Also in attendance were Bernard Crecca, Union County Electrical Contractors Association and Joseph McMullen, New Jersey Electrical Contractors Association.

The Board saluted the Flag.

March 12, 2014

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (40) Initial Licenses effective March 12, 2014 to March 31, 2015.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (33) Initial Business Permits effective March 12, 2014 to March 31, 2015.

Motion made by Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and unanimously passed, to approve (4) Initial Business Permits Previously Expired effective March 12, 2014 to March 31, 2015.

Motion made by Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and unanimously passed, to approve (7) Changes in Business Permits effective March 12, 2014 to March 31, 2015.

Checks in the amount of \$100.00 each received from Christian F. Rupp, IV, License #8149, t/a C R Electrical Contracting, as the thirteenth and fourteenth installment of a civil penalty in the amount of \$2,700.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started November 14, 2012 and the balance due is \$1,300.00.

The Board accepted the payment.

Check in the amount of \$1,000.00 received from Ralph Peragine, License #4993, as the first and final payment of a civil penalty in the amount of \$1,000.00 for violation of N.J.S.A. 45:1-21(e) and N.J.A.C. 13:31-3.4.

The Board accepted the payment.

Postal Money Order in the amount of \$500.00 received from Rodolphe Schomberg, License #11661, t/a R S Electrical Contracting, as the third installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:1-21(b). Payments started November 6, 2013 and the balance due is \$1,000.00.

The Board accepted the payment.

March 12, 2014

Money Order in the amount of \$1,000.00 received from Michael C. Stephens, President and CEO of CBM of America, Inc, Telecommunications Wiring Exemption #2032, as the first and final payment in the amount of \$1,000.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1. Acknowledgment and cease and desist agreement signed by Michael. C. Stephens, not Eddie E. Sultan who is listed in the Board's licensing system as owner.

The Board accepted the payment; however, Mr. Sultan must also sign the acknowledgment and agreement as he qualifies for the exemption.

Postal Money Order in the amount of \$100.00 received from Adam F. Granados, License #16162, t/a AFG Electric, LLC, as the first and final payment in the amount of \$100.00 for violation of N.J.A.C. 13:31-3.2(b).

The Board accepted the payment.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Sarah Barton, Warshauer Electric Supply, requesting approval of new courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that a letter be sent to Ms. Barton advising her request is denied as the instructor lacks the qualifications to teach the courses entitled "Residential Standby Generators" and "Commercial Standby Generators".

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Mark Quinn, requesting approval of a new course.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve one (1) new course and instructors.

March 12, 2014

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Greg Chontow, IAEI - Skyland Division, requesting to add Frank Baguiao to teach previously approved courses; reducing the hours of two previously approved courses; and requesting the approval of new courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve six (6) new courses and instructors. The Board also approved Mr. Chontow's request to reduce the course hours from six (6) to five (5) hours for the two previously approved courses entitled "NEC Article 680 Swimming Pools, Fountains and Similar Installations" and "Emergency, Legally Required, and Optional Standby Systems". The Board also approved Mr. Chontow's request to add Frank Baguiao as an instructor to teach previously approved courses.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Dwight C. Price, The Electrical Association of Philadelphia, requesting approval of new courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve three (3) new courses and instructors. Mr. Link will be advised that the courses are being approved as seven (7) hour courses and not eight (8) hour courses as the Board does not allow breaks, lunch, and registration to be part of the instructional hours. Mr. Link will also be advised that licensees attending the course entitled "High Voltage Systems: Equipment and Safety" on February 28, 2014 will not receive Continuing Education credit toward the renewal of their license.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Sean Smyth, requesting approval of new courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that a letter be sent to Mr. Smyth advising him that his request is being held in abeyance pending a more detailed outline of the course content. Specifically, the Board requests that Mr. Smyth describe how much instruction time will be spent on each code topic.

March 12, 2014

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Brian Mitchell, Construction Training Service, requesting approval of new courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve four (4) new courses and instructors.

Mr. Mitchell R. Malec noted for the record that he is an employee of the New Jersey Department of Community Affairs.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from John Delesandro, New Jersey Department of Community Affairs/Rutgers University, requesting approval of new courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve nine (9) new courses and instructors. Mr. Delesandro will be advised that the course entitled "Electrical Plan Review & Inspection of Residential & Multi-Family Structures in the Special Flood Hazard Areas" is disapproved.

Mr. Constantinos Papademas recused himself from the following discussion and motion.

The Committee reviewed an application for Continuing Education Course/Seminar Approval received from Constantinos Papademas, requesting approval of new courses.

The Committee unanimously recommended to approve forty-two (42) new courses and instructors.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Richard F. Van Wert, Electric Education Center, requesting approval of new courses.

March 12, 2014

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve twelve (12) new courses and instructors. The courses entitled "Transformers" and "Swimming Pool, Fountains, and Similar Electrical Installations" are approved pending receipt of an outline to demonstrate the increase in course hours.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Salvatore Ferrara, Electrical Training Center, Inc., requesting approval of a new instructor to teach a previously approved courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve Mr. Ferrara's request to add Robert E. Liptak to teach previously approved courses.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Lawrence S. Cross, III, requesting approval of new courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve fourteen (14) new courses and instructors.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from James Presto, Rumsey Electric, requesting approval of a new course.

Motion made by Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that a letter be sent to Mr. Presto advising him that his request is denied as the instructor is not qualified to teach the course presented.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Helen Heneveld, Bedrock Learning, Inc., requesting approval of new courses.

March 12, 2014

Motion made by Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that a letter be sent to Ms. Heneveld advising her request is being held in abeyance. The Board would like to know how the webinars are conducted and if they are instructor led. If so, the Board requests that a resume be provided for each instructor. Additionally, the Board requests a more detailed description of the course content.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from James M. Stover, Training Director, Joint Apprenticeship & Training Committee, requesting approval of two new instructors to teach previously approved courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve two (2) new courses and instructors.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Thomas McNulty, Penn-Del-Jersey Chapter, NECA, requesting approval of new courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve four (4) new courses and instructors.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Ralph Lombardi requesting approval of new courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve six (6) new courses and instructors.

Rachel Glasgow, Regulatory Analyst, appeared before the Board to review and discuss a draft of its rules and regulations which will Sunset on August 23, 2014.

March 12, 2014

Mrs. Glasgow stated employee has been defined in N.J.A.C. 13:31-1.2 which states:

Employee means a person hired to work on an ongoing and continuous basis, whose remuneration is reported on a Form W-2 to the Internal Revenue Service, and whose work is supervised pursuant to the provisions of N.J.A.C. 13:31-3.4.

The Board requested that the following be changed or added:

N.J.A.C. 13:31-1.6 (a)

9. Initial/replacement pressure seal \$25.00

N.J.A.C. 13:31-1.7(h)

6. Maintain and retain accurate records of attendance for a six year period and shall submit such documentation to the Board upon request.

N.J.A.C. 13:31-2.1 (b)

If an applicant cannot obtain an affidavit from his or her previous employer, the applicant may submit copies of the applicant's W-2 form to verify the practical hands-on experience requirements set forth in N.J.A.C. 13:31-2.1(a) (3).

N.J.A.C. 13:31-2.2 (a)

The examination shall consist of three written sections: electrical contractor, business and law, and alarm systems contractor.

N.J.A.C. 13:31-2.2 (d)

If an applicant fails to obtain a passing score on the Board licensing examination within five (5) years of the date of approval to take the first examination, the application for licensure shall be deemed abandoned and closed.

N.J.A.C. 13:31-3.3 (h)

A licensee seeking a new pressure seal following the return of a previously issued pressure seal to the Board shall remit the fee set forth in N.J.A.C. 13:31-1.6 for the issuance of the new pressure seal.

March 12, 2014

N.J.A.C. 13:31-3.4 (d)

1. If the employee performing the electrical work has less than three and one half years electrical experience working under the State Uniform Construction Code Act, N.J.S.A. 52:27D-119 et seq., and its implementing rules set forth in the Uniform Construction Code N.J.A.C. 5:23, the qualifying licensee, licensee or qualified journeyman electrician shall ensure constant on-site supervision of the employee; or
2. If the employee performing the electrical work has more than three and one half years electrical experience working under the State Uniform Construction Code Act, N.J.S.A. 52:27D-119 et seq., and its implementing rules set forth in the Uniform Construction Code, 5:23, the qualifying licensee, licensee or qualified journeyman electrician shall provide the employee with a verbal or written work order specifying the type of work to be performed, and at the conclusion of the job, the employee shall confirm that the work order has been completed.

N.J.A.C. 13:31-3.8 (b)

Installing, maintaining or servicing wiring for the supplying of power from the service point on a customer's premises to an appliance or other equipment used by the customer for the purpose of light, heat or power, shall be performed only by a licensee holding a business permit or an employee, except as provided in N.J.S.A. 45:5A-18 and (c).

N.J.A.C. 13:31-3.8 (d)

Installing, maintaining, servicing, and handling exposed photovoltaic panels, solar inverters, and all other electrical components shall be performed by a licensee holding a business permit or an employee.

Mr. Schooley thanked Mrs. Glasgow and the Sunset Committee for drafting the language for the Board Rules and Regulations for Sunset.

The Board reviewed Senate Bill No. 681 which provides for the issuance of a certificate of rehabilitation by the court or State Parole Board to persons who have a substance abuse disorder and have been convicted of certain crimes.

March 12, 2014

Mrs. Glasgow stated this bill will allow those individuals with substance abuse disorders, and have been determined to be in remission and stable recover, to apply to the court for a certificate of rehabilitation. If the individual receives this certificate, the Board cannot use that conviction against that individual.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, that the Board has a neutral position concerning Senate Bill No. 681.

The Board reviewed Assembly Bill No. 2332 which requires a public body to publish notice of public meetings on the official Internet website of the public body, in addition to publishing a notice in two local newspapers.

The Board is in compliance with Assembly Bill No. 2332.

The Board reviewed Assembly Bill No. 1545, recently signed by the governor, concerns the renewal/reinstatement of a license or certificate.

If a licensee does not renew the license or certificate prior to the date of expiration, the holder may renew it within thirty days of its expiration date by submitting a renewal application and paying a renewal fee and a late fee. During the 30 day period, the license shall be valid and the licensee shall not be deemed practicing without a license.

A licensee who failed to reinstate after five years must take the examination.

A licensee seeking reinstatement of a license, and holds a valid, current, corresponding professional or occupational license in good standing issued by another state, can submit proof of having satisfied that state's continuing education requirements for that license.

A licensee seeking reinstatement of a license must pay the renewal fee for the period for which reinstatement is sought and pay the renewal fee for the period immediately preceding the period for which reinstatement is sought.

March 12, 2014

E-mail dated January 27, 2014, received from Adrian Lowenstein, stating he has worked for electrical utilities such as PSE&G and Con Edison. Therefore, what qualifications would be required of such an applicant as indicated in N.J.A.C. 13:13:31-2.1(a 3) which states:

immediately preceding the submission of the application, an applicant has at least five years of practical hands-on experience working with tools in the installation, alteration, or repair of wiring for electric light, heat or power, which work shall have been done in compliance with the National Electrical Code.

Mr. Flaherty stated electrical line-men do not perform work under the National Electrical Code and do not get credit to sit for the test.

Mr. Flaherty also stated the Board's regulations are clear; an applicant needs five years of experience working with the National Electrical Code. Work performed within the National Safety Code would not apply. The National Safety Code is a performance standard that specifies what is to be performed. Mr. Flaherty also stated earning a Bachelor's Degree in electrical engineering, not mechanical engineering, reduces the amount of time required to qualify to take the test.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, that a letter be sent to Adrian Lowenstein advising him that work performed within the National Safety Code would not apply towards his experience in the electrical field. The regulations stipulate applicants are required to show five years of experience working with the National Electrical Code. Mr. Lowenstein will also be advised a Bachelor's Degree in electrical engineering would require two years of experience in the electrical field working with the National Electrical Code.

Signed agreement to include the statement "all electrical work performed by licensed electrical contractors" received from Jorge Jover Broche, G. T. Construction, Passaic, New Jersey.

March 12, 2014

The Board reviewed documentation received from Robert C. Izzo, Jr., License #15541, as reflected in the Consent Order filed January 5, 2011.

It is noted for the record that Robert C. Izzo, Jr., License #15541, has satisfied the requirement as set forth in the Consent Order filed January 5, 2011.

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Thirty-three (33) applications were approved.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
