

886th BUSINESS MEETING OF THE BOARD OF EXAMINERS OF ELECTRICAL CONTRACTORS (PUBLIC SESSION) APRIL 2, 2014

Marian Fiore, Senior Management Assistant, was present from 9:00 A.M. until the close of the meeting.

Joseph Donofrio, Deputy Attorney General, was present from 9:00 A.M. until the close of the meeting.

Also in attendance were Joseph Scialabbo, License #8759 and Bernard Crecca, Union County Electrical Contractors Association.

The Board saluted the Flag.

April 2, 2014

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (23) Initial Licenses effective April 2, 2014 to March 31, 2015.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (14) Initial Business Permits effective April 2, 2014 to March 31, 2015.

Motion made by Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and unanimously passed, to approve (2) Initial Business Permits Previously Expired effective April 2, 2014 to March 31, 2015.

Motion made by Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and unanimously passed, to approve (15) Changes in Business Permits effective April 2, 2014 to March 31, 2015.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Arthur W. Jacobs, Sr., and unanimously passed, to approve the Minutes of the 882nd Open Session Business Meeting held November 6, 2013 with the following correction:

Page 4, last paragraph:

After review and discussion, the Board requested that Darlene Kane, Budget Officer, be asked to discuss its' concerns regarding the Board's "tight" status.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Mitchell R. Malec, and unanimously passed, to approve the Minutes of the 883rd Open Session Business Meeting held December 4, 2013.

Check in the amount of \$100.00 received from Christian F. Rupp, License #8149, t/a C R Electrical Contracting, as the fifteenth installment of a civil penalty in the amount of \$2,700.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started November 14, 2012 and the balance due is \$1,200.00.

The Board accepted the payment.

April 2, 2014

Postal Money Order in the amount of \$500.00 received from Rodolphe Schomberg, License #11661, t/a R S Electrical Contracting, as the fourth installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:1-21(b). Payments started November 6, 2013 and the balance due is \$500.00.

The Board accepted the payment.

Postal Money Order in the amount of \$1,000.00 received from Christopher Paoello, License #11651, t/a Paoello Electric, as the first and final payment of a civil penalty in the amount of \$1,000.00 for violation of N.J.S.A. 45:5A-9 as reflected in the Final Order of Discipline filed January 8, 2014.

The Board accepted the payment.

Postal Money Order in the amount of \$500.00 received from Mark Konczyk, Jr., Unlicensed, as the first and final payment of a civil penalty in the amount of \$500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. as reflected in the Uniform Penalty Letter dated February 3, 2014.

The Board accepted the payment.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Dwight C. Price, The Electrical Association of Philadelphia, requesting approval of a new course.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve one (1) new course.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Anthony T. Urbanik requesting approval of new courses.

April 2, 2014

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve four (4) new courses. The Board also approved Mr. Urbanik's request to change the five (5) hour courses to five one (1) hour courses.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from John A. McCabe requesting approval of new courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve twenty-one (21) new courses.

Letter dated December 30, 2013, received from Julio Ramirez, License #14566, requesting a waiver of the 34 hours of Continuing Education for the renewal of his license for the 2015 cycle.

Office files reflect that Business Permit #14566 expired on March 31, 2012 and the pressure seal for Julio Ramirez Electrical Contractor was returned on May 13, 2012.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, that a letter be sent to Mr. Ramirez advising him that his request for a waiver is denied. Mr. Ramirez will be advised that he may choose to place his license in "Inactivate" status. The Board also requested that Mr. Ramirez be requested to provide copies of his Continuing Education Course certificates for the 2009 cycle.

Mr. Mitchell R. Malec noted for the record that he is the government representative for the Board and is employed by the Department of Community Affairs.

The Board received a copy of a letter addressed to Paul J. Rabenda, Construction Official, Township of Wall, signed by Robert S. Hilzer, Office of Regulatory Affairs, Department of Community Affairs, concerning work performed on single family homes which are not owner occupied.

April 2, 2014

Motion made by Mr. Constantinos Papademas and seconded by Mr. James H. Flaherty, and passed, that a letter be sent to the Department of Community Affairs advising the interpretation of the Board's Laws, Rules, and Regulations, and questions regarding licensing, should be addressed by the Board.

Mr. Malec abstained from the motion.

Mr. Mitchell R. Malec noted for the record that he is the government representative for the Board and is employed by the Department of Community Affairs.

The Board received a copy of an e-mail drafted by David J. Greenhill concerning the scope of practice for an electrical contractor and home improvement contractor and obtaining permits for generators and solar panels.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Arthur W. Jacobs, Sr., and passed, that a letter be sent to Mr. Greenhill advising the interpretation of the Board's Laws, Rules, and Regulations should be addressed by the Board. Mr. Greenhill will also be advised that his correspondence should be rescinded.

Mr. Mitchell R. Malec abstained from the motion.

Rachel Glasgow, Regulatory Analyst, appeared before the Board to review the proposed Sunset regulations.

The Board requested that the words "ongoing and continuous" be removed from N.J.A.C. 13:31-1.2(a) Definition of Regular Employee.

The Board requested that the words "ongoing and continuous" be removed from N.J.A.C. 13:31-3.5 (e).

The Board requested that the words "alarm systems contractor" be changed to "alarm systems" in N.J.A.C. 13:31-2.2 Examinations.

Motion made by Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and unanimously passed, that the proposed Sunset regulations be approved as amended.

April 2, 2014

The Board reviewed Assembly Bill A-2460 which provides that several professional and occupational licensing boards in the Division of Consumer Affairs shall not charge a license fee to a veteran or the spouse of a veteran when granting that veteran or spouse, on the basis of reciprocity, a license to practice in New Jersey.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that the Board supports Assembly Bill A-2460. However, the Board would like clarification as to whether or not this bill is limited to only the initial fee or does it include the ancillary fees such as license fees, business permit fees, pressure seal fees, etc. Additionally, even though the Board does not have a reciprocal agreement with any other state, the Board feels that veterans who reside in the State of New Jersey should also benefit.

Joseph Scialabbo, License #8759, stated he was hired by Evesham Board of Education in 2012 as the licensed electrical contractor. Mr. Scialabbo also stated he was employed for approximately one year when he began to complain about unlicensed electrical work being performed. Mr. Scialabbo further stated he was forced to work with unqualified personnel. Mr. Scialabbo asked whether or not, from a liability standpoint, would his license or business permit be in jeopardy.

DAG Donofrio stated he does not believe Mr. Scialabbo is liable as he was an employee of the school district. The complaint Mr. Scialabbo submitted to the Board alleged that the Evesham Board of Education was performing unlicensed electrical work.

Mr. Scialabbo stated that he did not seal any Subcode Technical Section applications for work performed for the Board of Education.

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Twenty-two (22) applications were approved.

April 2, 2014

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
