The Board saluted the Flag.

Motion made by Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and unanimously passed, to approve (6) Initial Licenses effective April 4, 2012 to March 31, 2015.

Motion made by Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and unanimously passed, to approve (11) Initial Business Permits effective April 4, 2012 to March 31, 2015.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (12) Initial Business Permits Previously Expired effective April 4, 2012 to March 31, 2015.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (34) Change in Business Permits effective April 4, 2012 to March 31, 2015.

The reviewed an application for Continuing Education Course/Seminar Approval for the 2015 triennial renewal period received from Nancy Lewis, E-Hazard.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that Ms. Lewis' request be held in abeyance pending receipt of resumes for those instructors not previously approved to teach certain courses so that the Board may ascertain whether or not they are qualified to do so.

The Board reviewed an application for Continuing Education Course/Seminar Approval for the 2015 triennial renewal period received from Victor V. Timpanaro, d/b/a Technical Seminars, LLC.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve all previously approved courses and instructors. Kenneth Rogers is not approved as an instructor as his resume does not reflect an electrical background.

The Board reviewed an application for Continuing Education Course/Seminar Approval for the 2015 triennial renewal period received from Lorraine Matturri, Bergen Community College.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve all previously approved courses and instructors.

The Board reviewed an application for Continuing Education Course/Seminar Approval for the 2015 triennial renewal period received from Michele Powell, New Jersey Electrical Contractor, Assoc.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve one (1) new course and Ms. Powell's request to add Mr. Rossi as an instructor to teach the nine hours of code changes and the one hour of laws, rules and regulations.

Letter dated March 21, 2012, received from Ronald J. Barber, License #3580, t/a Barber Electric, stating that he would like to retire on March 31, 2012 due to health reasons. Mr. Barber requests that the Board allow him a six-month extension pursuant to N.J.S.A. 45:5A-14 to complete jobs already in progress.

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. Constantinos Papademas, and unanimously passed, that a letter be sent to Mr. Barber advising him that the Board has granted Barber Electric a three-month continuance of business under permit #3580 to complete jobs already in progress. Mr. Barber is to provide the Board with a listing of the outstanding jobs and

the name of the individual who will be overseeing the electrical work being performed by Barber Electric. The Board requests that Mr. Barber provide it with a copy of the current bond, certificate of general liability, and the pressure seal issued to Barber Electric. Mr. Barber will further be advised that the Board recommends he place his license in "inactive" status.

Letter received March 27, 2012, from Dennis Campbell, Instructor #7694, requesting 15 hours of credit towards the renewal of his License #7694 pursuant to N.J.A.C. 13:31-1.7. Mr. Campbell has provided copies of attendance certification sheets reflecting that he has taught more than 15 hours of continuing education courses which includes the nine hours of code changes and the one hour of laws, rules and regulations.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that Mr. Campbell be granted 15 credits toward his 2012 triennial license renewal.

Letter dated March 7, 2012, received from Gregory R. Ferrentino, License #15553, t/a Gregory R. Ferrentino Electrical Contractor, requesting a waiver of the Continuing Education Courses for the 2012 to 2015 renewal period pursuant to N.J.A.C. 13:31-1.7.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, that a letter be sent to Mr. Ferrentino advising him that his request for a waiver is being held in abeyance pending an explanation of the facts and circumstances underlying his arrest and conviction; the date he was incarcerated; and the nature of his disability.

Letter dated February 15, 2012, received from Dieter Franiok, License #9060, Dieter Franiok Electrical Contractor, requesting an extension to complete his Continuing Education courses for the 2012 renewal period. Mr. Franiok has provided medical documentation.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, that a letter be sent to Mr. Franiok advising him that the Board has granted him a three month extension to take the required 34 hours of Continuing Education courses.

Letter dated March 19, 2012, received from Dieter Szardenings, License #6590, t/a Dieter Szardenings Electrical Contracting, requesting an extension to complete his Continuing Education courses for the 2012 renewal period. Mr. Szardenings has provided medical documentation.

Motion made by Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and unanimously passed, that a letter be sent to Mr. Szardenings advising him that the Board has granted him a three month extension to take the required 34 hours of Continuing Education courses.

Letter dated March 26, 2012, received from Jorge R. Diaz, License #13817, t/a Veritas Electric, Inc., requesting an extension to complete his Continuing Education Courses for the 2012 renewal period. Mr. Diaz has provided medical documentation.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that a letter be sent to Mr. Diaz advising him that the Board has granted him a three month extension to take the required 34 hours of Continuing Education courses.

The Board reviewed an article regarding the installation of CSST (corrugated stainless steel tubing) gas piping.

Mr. Malec stated that a question has been posed as to who can do the work associated with the electrical bonding of CSST systems.

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. Mitchell R. Malec, and unanimously passed, that although a New Jersey licensed electrical contractor is the most qualified person to perform the bonding, the Board's position that it is not required that a licensed electrical contractor install the bonding clamps and conductor provided that the connection to the grounding electrode system is outside the service enclosure; i.e. to the electrical system grounding electrodes with the appropriate ground clamp, to the foundation rebar when the electrical system employs a Ufer ground, to the electrical system grounding electrode conductor if it is of sufficient size, to other grounding electrodes (lightning) if integrated with the electrical system, or copper water pipe if it serves as primary grounding electrode. The Board notes that this position is applicable only for installations required to be inspected and are inspected per the State Uniform Construction Code.

The Board did not discuss the new continuing education procedures pursuant to N.J.A.C. 13:31-1.7(l).

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Thirty-six (36) applications were approved.

April 4, 2012

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. James H. Flaherty, and unanimously passed, to go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
