The Board saluted the Flag.

\*\*\*\*\*

April 6, 2011

Motion made by Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and unanimously passed, to approve thirty-six (36) Initial Licenses effective April 6, 2011 to March 31, 2012.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve forty-one (41) Initial Business Permits effective April 6, 2011 to March 31, 2012.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. James H. Flaherty, and unanimously passed, to approve four (4) Initial Business Permits Previously Expired effective April 6, 2011 to March 31, 2012.

Motion made by Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and unanimously passed, to approve twelve (12) Changes in Business Permits effective April 6, 2011 to March 31, 2012.

Motion made by Mr. Constantinos Papademas and seconded by Mr. James H. Flaherty, and unanimously passed, to ratify the Committee's recommendations for the Minutes of the 850<sup>th</sup> Meeting held December 1, 2010.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to ratify the Committee's recommendations for the Minutes of the 853<sup>rd</sup> Open Session Business Meeting held March 2, 2011, with the following corrections.

Page 5, paragraph 4

The Committee unanimously recommended to approve ten (10) new courses and instructors. The courses entitled "The Paths to Compliance with the 2009 International Energy Conservation Code for Residential Construction" and "The Paths to Compliance with ASHRAE 90.1 for Commercial Construction" are disapproved as they do not meet the criteria of continuing education.

Page 6, paragraph 3

Mrs. Sheehan stated that the statutory exemptions are quite clear; the individuals need to be either a journeyman, a state employee with the civil service title, or a state employee who has completed an apprenticeship program. Therefore, this language does not necessarily have to be included in N.J.A.C. 13:31-5.1 (a) whereas in N.J.S.A. 45:5A-18(k) the language was necessary.

April 6, 2011

Page 6, paragraph 4

Mr. Malec stated that he would not add language to N.J.A.C. 13:31-5.1 (a). If we want to add language, it would have to be crafted so as not to make it mandatory. If an individual is performing work pursuant to N.J.S.A. 45:5A-18(l), the individual would be required to register as a qualified journeyman only if that individual does not have a civil service title or apprenticeship certificate.

Page 6, paragraph 5

Mrs. Sheehan stated that she will draft regulatory language for the Board's review to clarify N.J.S.A. 45:5A-18(l).

Page 7, paragraph 7

An Appointment and Business Meeting is scheduled for Wednesday, April 6, 2011, at 9:00 A.M.

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Fifteen (15) applications were approved.

\*\*\*\*\*

Check in the amount of \$100.00 received from Treverald Allen, License #4240, as the first and final installment of a civil penalty in the amount of \$100.00 for violation of N.J.A.C. 13:31-3.1; N.J.A.C. 13:31-3.4; and N.J.A.C. 13:31-3.5(e). Mr. Allen included the signed acknowledgment.

The Board accepted the payment.

Motion made by Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and unanimously passed, that a letter be sent to Mr. Allen asking him if it is his contention to continue in the business of electrical contracting. If so, Mr. Allen is to explain who will perform the electrical work.

April 6, 2011

Check in the amount of \$25.00 received from Frank D'Arpa, License #8778 (Inactive), as the fifty-fourth installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started September 25, 2002 and the balance due is \$1,150.00.

The Board accepted the payment.

\*\*\*\*\*

Checks in the amount of \$100.00 each received from William Passione, License #11485, t/a B. Passione Electric, as the thirteenth and fourteenth installment of a civil penalty in the amount of \$3,500.00 for violation of N.J.S.A. 45:5A-9; N.J.S.A. 56:8-1 et seq; and N.J.A.C. 13:45C-1.2. Payments started February 4, 2010 and the balance due is \$2,095.00.

The Board accepted the payment.

Check in the amount of \$500.00 received from Troy McMahon, Unlicensed, as the second and final installment of a civil penalty in the amount of \$1,000.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started October 20, 2010.

The Board accepted the payment.

The sub-committee reviewed an application for Continuing Education Course/Seminar Approval received from Tom Rosa, Honeywell Fire Systems - Fire-Lite Alarms.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve eight (8) new courses and instructors. The Course entitled "Understanding Intelligent Fire Alarm Systems" is being approved as a three (3) hour course. Mr. Rosa requested that this course be approved as a 3.75 hour course; however, the Board only approves courses one hour in length.

The courses entitled "Fire-Lite Software Applications", "Fire-Lite Systems-Advanced", "Intelligent Addressable Fire Alarm Control Panels", "Fundamentals of Power Supplies", and "Troubleshooting Fire Alarm Systems", are being held in abeyance pending receipt of a more detailed description of the courses to be taught.

April 6, 2011

The sub-committee reviewed an application for Continuing Education Course/Seminar Approval received from Trisha Egbert, Infinite Solar, Inc. This matter was held in abeyance pending further discussion by the sub-committee.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that a letter be sent to Ms. Egbert advising her that the courses she submitted are not approved. Ms. Egbert will be advised that she may submit a more detailed breakdown and description of the courses to be taught.

The sub-committee reviewed an application for Continuing Education Course/Seminar Approval received from Scott Banker, System Sensor.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that a letter be sent to Mr. Banker advising him that the courses he submitted are not approved. Mr. Banker will be advised that he may submit a more detailed breakdown and description of the courses to be taught.

The sub-committee reviewed an application for Continuing Education Course/Seminar Approval received from L. Keith Lofland, International Association of Electrical Inspectors.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve two (2) new courses and instructors and previously approved courses and instructors.

\*\*\*\*\*

The sub-committee reviewed an application for Continuing Education Course/Seminar Approval received from Stephanie Carlberg, National Technology Transfer, Inc.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that a letter be sent to Ms. Carlberg advising her that the courses she submitted are not approved. The Board requests that Ms. Carlberg resubmit these courses and provide a more detailed breakdown and description/format of the courses to be taught. The Board also requests that Ms. Carlberg clarify their monitoring procedures. Ms. Carlberg will be advised if a licensee only attends 35 hours of a 40 hour course, that licensee should not receive credit of having attended a forty hour course.

April 6, 2011

The sub-committee reviewed an application for Continuing Education Course/Seminar Approval received from Michele Powell, New Jersey Electrical Contractors Association.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve two (2) new courses and instructors and previously approved courses and instructors. The Board also approved Ms. Powell's request to add new instructors to previously approved courses.

\*\*\*\*\*

The sub-committee reviewed an application for Continuing Education Course/Seminar Approval received from Thomas McNulty, Penn-Del-Jersey Chapter NECA.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve one (1) new course and instructor.

\*\*\*\*\*

The sub-committee reviewed an application for Continuing Education Course/Seminar Approval received from Neil D. Nagy.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve a previously approved course and instructor. Mr. Nagy will also be advised that the approval of the remainder of the courses is being held in abeyance pending a detailed description of the courses to be taught. The Board will allow five hours of credit unless a more detailed description is provided.

\*\*\*\*\*

Maryann Sheehan, Regulatory Analyst, appeared before the Board to discuss N.J.A.C. 13:31-5.1 Registration as qualified journeyman electrician.

Mrs. Sheehan stated that the Board wanted to clarify the language to reflect that anyone who does not hold a civil service title or has not completed an apprenticeship training program will be required to register as a qualified journeyman in order to perform electrical work under N.J.S.A. 45:5A-18(l).

Mrs. Sheehan also stated that the drafted language will require a person who is employed by the State or by a municipality, county, or school district shall register with the Board as a qualified journeyman unless that individual holds a civil service title with a job description that includes electrical work or has completed an apprenticeship program.

April 6, 2011

Mr. Malec stated that perhaps the regulation should be drafted into two sections; one section for regular employees of the State or municipality, county or school district who performs electrical work on the premises or property owned or occupied by the State, municipality, county or school district and one section for any employee of a State authority who performs electrical work on the premises or property owned or occupied by the State, municipality, county or school district unless this person has completed an apprenticeship program.

Mrs. Sheehan stated that she will review the definition of "authority" and report her findings to the Board.

\*\*\*\*\*

Maryann Sheehan, Regulatory Analyst, appeared before the Board to discuss N.J.A.C.13:31A-1.12 Continuing Education Requirements of the Fire Alarm, Burglar Alarm and Locksmith Advisory Committee.

Mrs. Sheehan stated that the Committee's licensees are having a difficult time understanding the intricacies of the continuing education rules.

Mrs. Sheehan also stated that the Committee is lowering the amount of the required continuing education credits from 36 hours to 24 hours in each triennial renewal period.

Mrs. Sheehan further stated that the Committee allows on-line courses; however, the licensee cannot take more than 8 credits in each triennial period.

Mrs. Sheehan also stated that continuing education course instructors do not need to resubmit a course or program that has been previously approved by the Committee as long as there are no changes in course content, hours of instruction or course lecturer.

Mr. Flaherty asked if an electrical contractor takes a course approved by the Committee, can that electrical contractor receive credit in order to renew his/her license.

Mrs. Sheehan stated that licensees must take continuing education courses approved by the Electrical Board in order to renew his/her electrical contractor's license.

Mr. Flaherty stated that he would like to continue this discussion at a future meeting as he feels that licensed electrical contractors should be able to attend courses approved by the Committee and have those courses count towards the renewal of their electrical contractor's license.

April 6, 2011

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve N.J.A.C. 13:31A-1.12 Continuing Education Requirements including the suggested changes.

\*\*\*\*\*

The Board reviewed N.J.A.C. 13:31A-1.16 Change in Business Qualifier for the Fire Alarm, Burglar Alarm and Locksmith Advisory Committee.

Mrs. Sheehan stated that this regulation allows the business to continue to operate for six months provided that the Committee is immediately notified that the licensee is deceased or has resigned.

Mr. Malec requested that the wording "permanent basis" be deleted from N.J.A.C. 13:31A-1.16(2 d).

Mr. Flaherty stated that the language should reflect that the six-month extension is from the date of death or resignation.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve N.J.A.C. 13:31A-1.16 as amended.

\*\*\*\*\*

Mr. Joseph Merlo, applicant, stated that he operates an HVAC company and would like to apply to take the electrical contractor's examination. Mr. Merlo also stated that he has approximately fifteen years of experience in the field; however, he has not worked in the electrical field for approximately ten years. Mr. Merlo further stated that he has been advised that because he has not worked in the electrical field for the last five years, he does not qualify to take the examination.

Mr. Merlo stated that he would like to be able to perform the electrical work in his business and would like to know how he can become eligible to take the electrical contractor's examination.

Mr. Flaherty stated that the statute indicates that applicants must have five years of experience in the field of electrical contracting five years immediately preceding the submission of the application.

Mr. Schooley advised Mr. Merlo that he can hire a licensed electrical contractor who is willing to endorse his business permit to his company. Mr. Merlo can then work with that licensee full time in the electrical field.

Mr. Merlo thanked the Board for the opportunity to discuss this matter with them.

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Fifteen (15) applications were approved.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Mitchell R. Malec, and unanimously passed, to go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
