

877th BUSINESS MEETING OF THE BOARD OF EXAMINERS
OF ELECTRICAL CONTRACTORS (PUBLIC SESSION) - - - MAY 1, 2013

David Freed, Acting Executive Director, was present from 9:00 A.M. until the close of the meeting.

Marian Fiore, Sr. Management Assistant, was present from 9:00 A.M. until the close of the meeting.

Kathleen Moran, Administrative Assistant 3, was present from 9:00 A.M. until the close of the meeting.

Joseph Donofrio, Deputy Attorney General, Division of Law, was present from 9:00 A.M. until the close of the meeting.

The Board saluted the Flag.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve the Minutes of the Minutes of the 876th Open Session Business Meeting held April 3, 2013, with the following correction:

Page 9

The following discussion was not included in the April 3, 2013 Minutes regarding the Notice of Pre-Proposal for N.J.A.C. 13:31-4.1 Limited Telecommunications Wiring Exemption.

The pre-proposal includes language which states that the Division (sic) Department of Community Affairs is considering a rule proposal to redefine "ordinary maintenance" which would affect the requirement for obtaining permits for telecommunications wiring.

The Board requested that this language be deleted as the Department of Community Affairs' rule proposal does not impact the Board's request in the pre-proposal for comments on whether anyone, in addition to the qualifying employee, should be able to obtain permits.

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. Mitchell R. Malec, and unanimously passed, to approve (16) Initial Licenses effective May 1, 2013 to March 31, 2015.

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (13) Initial Business Permits effective May 1, 2013 to March 31, 2015.

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (3) Initial Business Permits Previously Expired effective May 1, 2013 to March 31, 2015.

Motion made by Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and unanimously passed, to approve (13) Changes in Business Permits effective May 1, 2013 to March 31, 2015.

May 1, 2013

Check in the amount of \$25.00 received from Frank D'Arpa, License #8778, as the sixty-third installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started September 25, 2002 and the balance due is \$925.00.

The Board accepted the payment.

Check in the amount of \$1,000.00 received from Jimmy Youngblood, License #11053, t/a Young Blood Electrical Contractor, as the first and final payment of a civil penalty in the amount of \$1,000.00 for violation of N.J.A.C. 13:45C-1.2.

The Board accepted the payment.

Check in the amount of \$100.00 received from Christian Rupp, License #8149, t/a C R Electrical Contracting, as the sixth installment of a civil penalty in the amount of \$2,700.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started November 14, 2012 and the balance due is \$2,100.00.

The Board accepted the payment.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Allyse Denny, Harger Lightning & Grounding, requesting approval of a new course.

At its December 5, 2012 meeting, the Board held in abeyance Ms. Denny's request to teach continuing education pending receipt of a more detailed outline and course description. Ms. Denny was also advised that the Board does not allow a quiz/exam to be part of the instructional hours and should not be a requirement in order for the licensee to receive a certificate.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and

unanimously passed, to approve the course entitled "Lightning Protection Installation Training". Ms. Denny will be advised that the Board is only approving four (4) hours of the twelve (12) hour course.

Ms. Denny will also be advised that licensed electrical contractors must attend all 12 hours in order to receive a certificate for the renewal of their license.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Scott Pomarico requesting approval of new courses and previously approved courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve six (6) new courses and instructors and previously approved courses.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Marcel Renson requesting approval of new courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve three (3) new courses and instructor.

Anthony Ventolo, License #6427, has failed to respond to a Provisional Order of Discipline ordering that he pay a civil penalty in the amount of \$2,000.00 for violation of N.J.A.C. 13:45C-1.2 and License #6427 is provisionally suspended until such time as Mr. Ventolo responds to the complaint received. POD mailed to Mr. Ventolo certified and regular mail. Certified mail returned "Unclaimed", regular mail not returned.

Motion made by Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and unanimously passed, that Deputy Attorney General Joseph Donofrio finalize the Provisional Order of Discipline and issue a Final Order of Discipline ordering that Mr. Ventolo pay a civil penalty in the amount of \$2,000.00 for violation of N.J.A.C. 13:45C-1.2 and License #6427 is suspended until such time as Mr. Ventolo responds to the complaint received.

Additionally, the Enforcement Bureau will be requested to retrieve the pressure seal issued to June Electrical Contractors, Inc., Business Permit #6427.

May 1, 2013

Letter dated April 30, 2013, received from Daniel F. Newman, Construction Official, Township of Brick, stating that the town is proposing to enter into additional Shared Service Agreements in order to provide electrical installation, repair, or maintenance to Township owned buildings, by employees of the Township's Municipal Utilities Authority. Mr. Newman is requesting clarification of N.J.S.A. 45:5A-18(I). Specifically can a municipality and a utility authority enter into a shared agreement that allows a journeyman electrician employed by the authority to perform maintenance on a municipal building.

DAG Donofrio stated that he will draft a letter to Mr. Newman advising him that pursuant to N.J.S.A. 45:5A-18(I) an employee of the Department of Public Works can perform electrical work for that municipality on the property owned and operated by that municipality as long as the employee is registered with the Board as a Qualified Journeyman Electrician, or holds any civil service title with a job description which includes electrical work pursuant to the Civil Service Act, or is an employee of a State Authority who has completed an apprenticeship training program approved by the United States Department of Labor, Bureau of Apprenticeship Training, that deals specifically with electrical work, and is of a minimum duration of three years.

Rachel Glaskow, Regulatory Analyst, appeared before the Board concerning Assembly Bill No. A-1750 which revises the law concerning alarm business licensees.

Ms. Glaskow stated that this bill was originally introduced during the 2010 to 2011 session under Assembly Bill A-2394.

Ms. Glaskow also stated that the Bill was reintroduced and the bill passed through the Assembly on Monday. However, if there are additional comments, the Board can submit a supplemental bill comment.

Ms. Glaskow stated that the bill amends the existing definition of "alarm business" to mean the design, installation, sales, servicing or maintenance of burglar alarm, fire alarm, or electronic security systems, or home automation and integration of these systems, or the monitoring or responding to alarm signals when provided in conjunction

therewith.

Mr. Malec stated that the Board has a concern with the wording "sales" and "design". Does "sales" include big box stores and does "design" intrude upon engineers? Mr. Malec also stated that because home automated systems can include heating, lighting, and air conditioning, the bill should only reference security systems.

Mr. Flaherty stated the problem is that a smart switch has electrical components which will electronically connect all of these systems. Mr. Flaherty also stated that technology is allowing consumers to turn on their lights, turn on the air conditioning, turn of their security system just using just their telephone. Mr. Flaherty further stated that this work is beyond the scope of the qualifications of an alarm licensee and could jeopardize the safety of the consumers in New Jersey.

Mr. Freed stated that the Bill does not define the word "sales" and does not reflect who is to be included in the group of individuals or businesses requiring licensure.

Ms. Glaskow stated that she will prepare a draft of the Board's comments. Ms. Glaskow stated that she will draft a response to include the Board's concerns regarding Assembly Bill A-1750.

Joseph P. Schooley, Chairman, signed on this date, a Final Order of Discipline ordering that the civil penalty in the amount of \$537.50 for violation of N.J.A.C. 13:31-1.7(b) be waived as Mr. Nowicki provided proof of having completed 34 hours of continuing education courses. The reprimand is to be sustained as Mr. Nowicki used two business names in violation of N.J.S.A. 45:5A-9.

Joseph P. Schooley, Chairman, signed on this date, a Final Order of Discipline ordering that Mr. Ventolo pay a civil penalty in the amount of \$2,000.00 for violation of N.J.A.C. 13:45C-1.2 and License #6427 is suspended until such time as Mr. Ventolo responds to the complaint received.

Additionally, the Enforcement Bureau will be requested to retrieve the pressure seal issued to June Electrical Contractors, Inc., Business Permit #6427.

Joseph P. Schooley, Chairman, signed on this date a Final Order of Discipline ordering that the civil penalty assessed against Mr. Saganski be reduced to \$500.00 for violation of N.J.A.C. 13:45C-1.2 as Mr. Saganski did respond to the complaint received.

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Thirty-five (35) applications were approved.

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. Mitchell R. Malec, and unanimously passed, to go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
