

**786 APPOINTMENT AND BUSINESS MEETING
OF THE BOARD OF EXAMINERS OF ELECTRICAL CONTRACTORS
- - - JUNE 1, 2005**

The Board Minutes of June 1, 2005, have not been formally approved and are subject to change or modification by the Public Body at its next meeting of July 6, 2005. All requirements of the "Open Public Meetings Act" have been complied with according to N.J.S.A. 10:4-6.

The notice of the meeting has been mailed to the Newark Star Ledger, Camden Courier Post, and the Trenton Times, and also notice has been posted on the Bulletin Board at the office of the Secretary of State, Trenton, New Jersey.

The Board saluted the flag

Mr. Schooley welcomed Mr. Aicher to the Board.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve the Minutes of the Special Meeting held April 20, 2005.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve the Minutes of the 785 Meeting held May 4, 2005.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve (34) Initial Licenses effective June 1, 2005 to March 31, 2006.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve (37) Initial Business Permits effective June 1, 2005 to March 31, 2006.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mrs. Gail Best, and unanimously passed, to approve (8) Initial Business Permits Previously Expired effective June 1, 2005 to March 31, 2006.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve (9) Changes in Business Permits effective June 1, 2005 to March 31, 2006.

William Hartz, Experior Assessments, LLC, discussed with the Board the electronic examination.

Mr. Hartz thanked the Board for inviting him to appear before it to discuss the electronic examination. Mr. Hartz stated that unfortunately his computer is not compatible with the phone line; therefore, he is not able to provide a visual presentation.

Mr. Hartz stated that Thompson Pro-Metric has taken over Experior Assessments LLC. We are located in 134 countries with over 300 testing sites in the United States.

Mr. Hartz also stated that the candidate is provided with a list of places to take the examination; the candidate chooses the location and the date to take the examination. Mr. Hartz stated that the examination can be given any day the candidate chooses as the testing sites are open six days a week until 5:00 P.M. The candidate arrives at the testing center and a digital photograph is taken which is transferred to the computer screen and is located on the corner of the computer screen of that candidate. The candidate is given a half hour test demonstration which provides test taking tips, and how to use the mouse and/or key board. The half hour is not part of the test time and the candidate can choose not to use the practice time. Mr. Hartz stated that candidates are provided with ear plugs or head phones.

Mr. Hartz further stated that on the left hand side of the computer screen there is a count down clock. The biggest fault of candidates is that they spend too much time on one question. The count down clock is on the computer screen for each portion of the examination. The candidate is advised to make their best guess and then if they wish they can mark the question and go back to it later.

Mr. Hartz stated that the electrical contractor's examination is basically four part multiple choice and the Board can include essay type questions which are harder to grade.

Mr. Cantalupo asked whether or not the computer can show a piece of pipe which the candidate must show how to bend.

Mr. Hartz stated that he will have to look into that.

Mr. Hartz stated when the candidate completes the examination, the computer will ask the candidate if he is sure he is ready to end the examination. If the candidate has completed the examination, the computer questions the candidate whether or not he would like to make comments. After comments are made the score report is printed and is embossed by the test administrator. If a candidate fails the examination, the candidate is provided with a diagnostic report showing their strength and weakness. They are not allowed to review the examination.

Mr. Hartz also stated that for a first time candidate the examination is seven and one half hours long; this is a significant amount of time which does not include the half hour test demonstration.

Mr. Hartz further stated that all of the sites are ADA compatible; we provide readers and access units. If the candidate provides documentation that they have a reading disability, we will add 50% more time; a four hour examination will then be six hours.

Mr. Hartz stated that the tests are scrambled as are the questions so that the candidates do not get the same test each time.

Mr. Schooley also stated that first time candidate must take all three parts; therefore, the candidates should receive a lunch break.

Mr. Hartz further stated that they have testing sites in Fairlawn, Hamilton, Deptford, Toms River, Clark, and West Orange, New Jersey. All of these sites have a proctor ratio of 18 to 1. The administration goes through extensive training and they are taught how to handle disgruntled candidates.

Mr. Schooley advised Mr. Hartz that candidates rent the code books, they are not allowed to bring their own code books into the testing site.

Mr. Hartz stated that the candidate must have their admission letter with them and must show government issued identification i.e. driver's license, passport, state issued identification with signature.

The test administrator checks all material before they enter the examination room and collects all scrap paper which is shredded.

Mr. Hartz stated that the test site is monitored 24 hours a day by ADT. All examinations are video taped and kept for 30 days.

Mr. Hartz also stated that without really knowing what the Board wants, it is hard to determine the cost of the examination; however, we can be very close to the price charged at this time. There could be a minimal increase.

Mr. Schooley advised Mr. Hartz that candidates who fail the examination must wait six months before retaking that examination.

Mr. Hartz stated that since we are still in the transition stage the Board should keep the exam as is until October 2006. Mr. Hartz also stated that he would need to know the Board's decision about the computerized examination by August 2005.

Maryann Sheehan, Regulatory Analyst, Director's Office, discussed with Board the following issues:

Mrs. Sheehan reviewed with the Board the drafted regulation for Qualified Journeyman Electrician Registration.

Mr. Malec stated that the statute does not recognize an active licensee as being a qualified journeyman. Mr. Malec also stated that the statute should stipulate that an active license need not register, but will be recognized as a qualified journeyman electrician.

Mr. McCullough stated that if you are working for a company, and hold a license, you are not performing licensee work as per the statute, you are doing exempt work under N.J.S.A. 45:5A-18(k).

Mr. Schooley stated that if the corporation were to apply for an electrical subcode technical section application, the individual applying would have to be registered with the Board as a qualified journeyman electrician.

Mrs. Sheehan asked the Board if a licensee no longer has a valid license, whether it be inactive or suspended, and that individual has a qualified journeyman card which is renewed, is that individual still qualified as a journeyman.

Mr. McCullough said yes. Mr. Malec stated that language should be included indicating if an electrical contractor has an active electrical contractor's license, the licensee can satisfy the continuing education requirement for the qualified journeyman as the same ten hours (nine hours of code changes and one hour of business and law) is required for both.

Mr. McCullough requested that the wording "if applicable" be added to 13:31-5.5(a3).

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve the drafted regulation N.J.A.C. 13:31.5.1 "Qualified Journeyman Electricians" to include the changes as

discussed.

The Board reviewed the comments received concerning the proposed amendment N.J.A.C. 13:31-3.5 Joint Ventures; Subcontracting of Electrical Work;

Mrs. Sheehan stated that the first comment was received from Lisa Levine, Pringle Quinn Anzano, P.C., stating that NJECA appreciates the Board's effort to state unequivocally that an electrical contractor holding a business permit issued by the Board may only subcontract electrical work to an individual also holding a business permit issued by the Board. NJECA is hopeful that this regulatory change will discourage illegal practice and further ensure the safety of the consumers of New Jersey.

Mrs. Sheehan stated that the Board will thank Ms. Levine for her comment.

Mrs. Sheehan stated that the second comment was received from Paul Vitale who was concerned with the leasing of business permits. Mr. Vitale stated that the business permit identification card should include the licensee's picture.

Mrs. Sheehan stated that the Board will thank Mr. Vitale for his comment. However, the filing of permits is not under the jurisdiction of the Board.

Mrs. Sheehan stated that the third comment was received from Roger M. Schwarz on behalf of the New Jersey State Electrical Workers Association, who supports the proposed rule; however, the association recommends that the Board's proposed definition of employee be amended to eliminate what could be a possible loophole. The Association suggests that the Board clarify that the W-2 form is to be issued by the permit holder. The remuneration must be reported by the electrical contractor holding the business permit.

Mr. Malec asked if there is another way that a W-2 form could be issued, as in the staffing companies like Trade Source and Joule.

This matter is being held in abeyance.

The Board is also holding in abeyance their request that a rule be drafted that would stipulate that a licensee cannot request a Change in Business Name unless the licensee first certifies that there are no outstanding judgements against the license and/or the company.

Check in the amount of \$25.00 received from Frank D'Arpa, License #8778, as the twenty-eighth installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started September 25, 2002 and the balance due is \$1,800.00.

The Board accepted the payment.

Postal Money Order in the amount of \$300.00 received from John Helmstetter, License #7192, as the twelfth installment of a civil penalty in the amount of \$7,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started June 7, 2004 and the balance due is \$3,900.00.

The Board accepted the payment.

Postal Money Order in the amount of \$100.00 received from Niepce Martinez, Unlicensed, as the first installment of a civil penalty in the amount of \$500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started May 12, 2005 and the balance due is \$400.00.

The Board accepted the payment.

Cashier's Check in the amount of \$1,000.00 received from Nelson Morales, License #6974, t/a M V P Electric Contractor, as the first and final installment of a civil penalty in the amount of \$1,000.00 for violation of N.J.S.A.

45:1-21(b).

The Board accepted the payment.

Letter dated April 20, 2005, received from Stephan Socci requesting a third six-month continuance of business under permit #9175 according to N.J.S.A. 45:5A-14. The licensee, William Hueber, died on August 4, 2003.

Mr. Socci stated that he is scheduled to retake the examination. The current extension expired on April 27, 2005.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that a letter be sent to Mr. Socci advising him that the Board has granted the firm of Live Wires Electric, LLC, a final continuance of Business Permit #9175 according to N.J.S.A. 45:5A-14. The extension will expire on October 27, 2005. Mr. Socci will be advised that this is the final extension being granted to Live Wires Electric, LLC. Therefore, if necessary, he should make arrangements with a licensed electrical contractor with a business permit to complete any unfinished jobs after the extension has expired.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Gary T. Sargent requesting approval of new courses.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Mitchell R. Malec, and unanimously passed, that the following courses, and instructors, are approved as submitted.

"HVAC Controls - Working, Wiring, Trouble Shooting"

"Grounding and Bonding"

"Contact Law and Legal Options for Contractors"

"Motors and Motor Circuits"

The following course is being held in abeyance pending a detailed breakdown and course description. Some of the content material appears to be specific to a manufacturing system, which the Board has not typically approved.

"Electric Thermal Storage Heat"

Additionally a more extensive resume is required for Gene Gill and a resume is required for Dan Gaffney.

The sub-committee reviewed a letter dated May 16, 2005, received from Alan Schell, IBEW, requesting the approval of three new instructors to teach previously approved courses.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Mitchell R. Malec, and unanimously passed, to approve Mr. Schell's request to include one new instructor to teach previously approved courses.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Eric J. Sivertsen requesting approval of new courses and the approval of instructors to teach previously approved courses.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Mitchell R. Malec, and unanimously passed, that the following courses, and instructors, are approved as submitted.

"Financial Planning"

"Family Business Planning"

"Understanding Financial Statements"

"Compensation Plans"

"Arc Flash Awareness"

"A Strategy for Improving the Electrical Contracting Industry"

"Conflict Prevention and Resolution: From Job-Site Issue Resolution to Enhanced Claims Negotiations"

The Board also approved Mr. Sivertsen's request to remove an instructor and add a new instructor to previously approved courses.

The sub-committee reviewed a letter dated April 28, 2005, received from Michael J. Johnston, IA EI, requesting approval of James J. Rogers to teach the nine hours of code changes and the one hour of laws, rules, and regulations.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Mitchell R. Malec, and unanimously passed, to approve James J. Rogers to teach the nine hours of code changes and the one hour of Laws, Rules and Regulations.

Letter dated May 13, 2005, received from Steven M. Ripley, Executive Director, New Jersey Contractors Educational Institute, Inc., concerning the Board's decision to deny his request to teach computer based programs as they did not meet the criteria of continuing education.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Mitchell R. Malec, and unanimously passed, that a letter be sent to Mr. Ripley advising him that based on the precedent set for this licensing renewal cycle, the Board did not approve his courses as they are very specific computerized programs. Also the courses submitted do not fit the criteria of continuing education. Mr. Ripley will also be advised that the course entitled "One-Hour BOE Law" is denied. The Board considers this as one ten hour course. Pursuant to N.J.A.C. 13:31-1.7(c) a licensee shall complete a ten hour course relating to the most recent edition of the National Electrical Code, nine hours shall pertain to the code and one hour shall pertain to State statutes and rules.

Letter dated April 4, 2005, received from Glen Hartzler, President, New Jersey Electrical Inspectors Association, Inc., stating that the members of the NJEIA feel that thirty-four hours of continuing education is encumbering. Mr. Hartzler also stated that all of the members agree that continuing education is very important and that a reduction of twelve hours would be adequate and prudent to accomplish this goal.

The Board requested that a letter be sent to Mr. Hartzler advising him that pursuant to N.J.S.A. 45:5A-13.1 licensees are required to complete 34 hours of continuing education. Mr. Hartzler will also be advised that his request to reduce the continuing education numbers is not within the Board's jurisdiction.

Letter dated May 1, 2005, received from Christopher Venezia, License #10195, requesting that the continuing education courses he attended to maintain his HHS Inspector's license be accredited towards the Continuing Education Course Requirement.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Mitchell R. Malec, and unanimously passed, that a letter be sent to Mr. Venezia advising him that the courses he attended have not been approved by the Board. The Board would like to work with the DCA in the future; however, these courses do not meet the current requirements pursuant to N.J.A.C. 13:31-1.7.

The Board reviewed a memorandum dated May 23, 2005, received from Darlene Kane, Budget Officer, Division of Consumer Affairs, stating that for the third quarter of Fiscal Year 2005, the Electrical Board was directly billed for 77.2 hours of Deputy Attorney General/Paralegal services totaling \$8,682.56.

E-Mail dated May 9, 2005, received from J. M. Rowland requesting information concerning Chapter 21 of Title 2C of the New Jersey Statutes.

The Board requested that a letter be sent to Mr. Rowland advising him that the Board does not interpret criminal statutes; the Board only has the expertise to interpret its own enabling statutes. Mr. Rowland will be advised to contact his local prosecutor's office and the State Library.

Letter dated May 17, 2005, received from Kimberly S. Ricketts who has been appointed Acting Director of the Division of Consumer Affairs.

Letter dated May 19, 2005, received from Benedict Shedlock, Tech Elec Courses, Inc., requesting information concerning the July 11, 2005 examination.

The Board requested that a letter be sent to Mr. Shedlock advising him that the information referenced in the 2005 Candidate Information Bulletin is correct. The July 2005 examination will be based on the National Electrical Code, NFPA - 70, 2005 Edition; the NFPA 72 National Fire Alarm Code, 1999 Edition; and the New Jersey 2003 or 2004 Electrical Reference Manual.

The Board reviewed applications for the written examination to be administered by Experior Assessments, LLC. Seventeen (17) applications were approved.

Motion made by Mrs. Connie F. Calisti and seconded by Mr. Mitchell R. Malec, and unanimously passed, that the Board go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
