

**821st BUSINESS MEETING OF THE BOARD OF EXAMINERS OF
ELECTRICAL CONTRACTORS (PUBLIC SESSION) - - - JUNE 4, 2008**

The Board Minutes of June 4, 2008, have not been formally approved and are subject to change or modification by the Public Body at its next meeting of July 2, 2008, or soon thereafter as it may be considered. All requirements of the "Open Public Meetings Act" have been complied with according to N.J.S.A. 10:4-6.

Meeting of June 4, 2008, was called to order at 9:00 A.M.

The Board saluted the Flag.

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve the Open Session Minutes of the 820th Business Meeting held April 2, 2008.

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. James H. Flaherty, and unanimously passed, to approve (61) Initial Licenses effective June 4, 2008 to March 31, 2009.

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. James H. Flaherty, and unanimously passed, to approve (47) Initial Business Permits effective June 4, 2008 to March 31, 2009.

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. James H. Flaherty, and unanimously passed, to approve (2) Initial Business Permits Previously Expired effective June 4, 2008 to March 31, 2009.

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. James H. Flaherty, and unanimously passed, to approve (2) Changes in Business Permits effective June 4, 2008 to March 31, 2009.

Three Postal Money Orders in the amount of \$100.00 each were received from James H. Gandy, Unlicensed, as the eleventh, twelfth and thirteenth installment of a civil penalty in the amount of \$2,500.00 for violation of

N.J.A.C. 13:31-3.3 and N.J.S.A. 45:5A-9. Payments started May 25, 2007 and the balance due is \$1,200.00.

The Board accepted the payment.

Check in the amount of \$2,000.00 was received from Joseph Pittius, License #12926, as the first and final installment of a civil penalty in the amount of \$2,000.00 for violation of N.J.S.A. 45:5A-9.

The Board accepted the payment.

Postal Money Order in the amount of \$300.00 received from Jack A. Giaimo, License #7375, as the tenth installment of a civil penalty in the amount of \$3,000.00 for violation of N.J.S.A. 45:5A-9 and N.J.A.C. 13:31-3.3. Payments started April 16, 2007 and the balance due is \$600.00.

The Board accepted the payment.

Check in the amount of \$25.00 received from Frank D'Arpa, License #7887 (Inactive), as the thirty-fifth installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started September 25, 2002 and the balance due is \$1,625.00.

The Board accepted the payment.

Check in the amount of \$500.00 received from Joseph J. Puglisi, Unlicensed, as the first and final payment of a civil penalty in the amount of \$500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq.

The Board accepted the payment.

Two checks in the amounts of \$250.00 each were received from Christopher Page, License #13710, as the ninth and tenth (final) installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.A.C. 13:31-3.3 (c).

The Board accepted the payment.

Check in the amount of \$500.00 received from John Cerritelli, License #6791, as the first and final payment of a civil penalty in the amount of \$500.00 for violation of N.J.S.A. 45:5A-9.

The Board accepted the payment.

Check in the amount of \$1,164.70 received from Victor Sarno, Unlicensed, as the first and final payment of a civil penalty in the amount of \$1,164.70 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq.

The Board accepted the payment.

Cashier's Check in the amount of \$500.00 received from Carlos Santos, License #11359, as the first installment of a civil penalty in the amount of \$2,000.00 for violation of N.J.A.C. 13:31-3.3 and N.J.S.A. 45:5A-9. The balance due is \$1,500.00.

The Board accepted the payment.

Check in the amount of \$500.00 received from Kurt Swanstrom, License #14661, as the first and final payment in the amount of \$500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq.

The Board accepted the payment.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Joe Swanson, Swanson Consulting, Inc.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that one (1) new course, and instructor, is approved as submitted.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Sammie McGriff, Sr., Simplex Grinnel.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that one (1) new course, and instructor, is approved as submitted.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Steven McPartland.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that one (1) new course, and instructors, are approved as submitted.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from John Nakahara.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that seventeen (17) new courses, and instructors, are approved as submitted.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Gary Sargent.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that two (2) new courses, and instructors, are approved as submitted.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Robert H. Keis.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that two (2) new courses, and instructors, are approved as submitted.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from John A. Drebitko, New Jersey Electrical Group, Inc.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that six (6) new courses, and instructors, are approved as submitted. The Board also approves Mr. Drebitko's request to reduce previously approved courses from two hours to one hour. Mr. Drebitko will be advised that his request to utilize "DVD" courses is not approved as they do not meet the criteria of continuing education.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Garret W. Graaskamp, P.G., American Ground Water Trust.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that Mr. Graaskamp's request to teach Continuing Education Courses is denied as the Board is unsure which courses are relevant to electrical contracting. Also, the Board does not approve quarter hours of instruction.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Lawrence Kosden.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that Mr. Kosden's request to teach Continuing Education Courses is denied. Mr. Kosden will be requested to submit a complete Continuing Education Application.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from

Joseph E. Rossi.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that (1) new course, and instructor, is approved as submitted.

The sub-committee reviewed additional information received from Marcel Renson who is requesting approval of a course entitled "Smoke & Carbon Monoxide Detectors". The sub-committee previously disapproved this course as the instructor did not provide enough details to qualify his experience to teach this course.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that Mr. Renson's request for approval of the course entitled "Smoke & Carbon Monoxide Detectors" is denied as the instructor is not qualified to teach the installation of these detectors. Should Mr. Renson change his course content, the Board will again review his request.

The Board wishes to reiterate that it has determined that previously approved courses and new courses will be accepted for Board Approval for the 2006 to 2009 cycle, in preparation for the 2009 Renewal, through August 31, 2008. No Continuing Education Submissions will be accepted after this date. Changes of instructors only will be accepted by the Board through November 30, 2008.

At its meeting held April 2, 2008, the Board reviewed a letter dated March 12, 2008, received from Harry Rosenzweig, License #4082, t/a Harry's Electrical Service, requesting a waiver of the Continuing Education Courses for the 2009 to 2012 renewal period.

The Board requested that a letter be sent to Mr. Rosenzweig advising him that his request for a waiver is being held in abeyance pending receipt of medical documentation giving the dates he became ill and how long he will be under a doctor's care.

As per the Board's request, documentation was received from Mr. Rosenzweig.

Motion made by Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and unanimously passed, that a letter be sent to Mr. Rosenzweig advising him that based on the documentation submitted the Board approves his request for a waiver of the Continuing Education Course for the 2009 to 2012 triennial renewal period.

The Board reviewed a memorandum dated May 13, 2008, received from Darlene Kane, Budget Officer, Division of Consumer Affairs, stating that for the third quarter of Fiscal Year 2008, the Board/Committee was directly billed for 105.1 hours of Deputy Attorney General/Paralegal Services totaling \$15,411.31.

Deputy Attorney General Ginger R. Provost advised the Board that she does not recognize the names of two of the individuals reflected on the bill.

The Board requested that Mrs. Cook attempt to ascertain why these two names are reflected on this bill.

Signed cease and desist agreement was received from Joseph J. Puglisi, t/a AJAY Appliance, Toms River, NJ. Signed cease and desist agreement was received from William Montalvo, Montalvo Landscaping, Park Ridge, NJ and Joseph Canova, t/a Joe C. Painter, Pompton Lakes, NJ, agreeing to include the language in his advertisement that all electrical work is "performed by licensed electrical contractors".

The Board accepted the signed cease and desist agreements.

Maryann Sheehan, Regulatory Analyst, Division of Consumer Affairs, appeared before the Board at 9:30 A.M.

The Board reviewed a proposal to amend the fee schedule for the Fire Alarm, Burglar Alarm and Locksmith Advisory Committee as set forth in N.J.A.C. 13:31A-1.4 in order to include a late renewal fee and a reinstatement fee for licensed fire alarm and burglar alarm installers and licensed locksmiths.

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve the proposed amendment as set forth in N.J.A.C. 13:31A-1.4.

Mrs. Sheehan reviewed with the Board the comments concerning the proposed regulation N.J.A.C. 13:31-1.2.

Mrs. Sheehan stated that the comment period for the journeyman regulation ended in January 2008 and the Board received comments from Lisa Levine, Esq., Pringle Quinn Anzano, P.C.; Edward H. O'Hara and Jim Bibbo, President, Central Jersey Electrical League.

Mrs. Sheehan also stated that Ms. Levine's first comment stated that the Board does not have the authority to require that the ten hours of continuing education include one hour of related statutes and regulations.

Mr. Flaherty stated that journeyman should be required to attend one of hour of law since they may be required, as part of their job, to obtain Electrical Subcode Technical Section Applications for work to be performed.

Mr. Malec stated that the Board recognizes the nine hours of code changes and the one hour of law as being equivalent to ten hours.

Mrs. Sheehan stated that this would be a substantive change. However, since the journeyman would not have to attend continuing education for three years, the Board can propose a change after adoption.

Mrs. Sheehan also stated that she will attempt to keep the proposal as is; however, if it will delay the adoption, she will change the language to reflect that the journeyman must complete ten credit hours of continuing education in each registration renewal period.

Mrs. Sheehan stated that Ms. Levine's second comment stated that the registration fees being charged by the Board are too low.

Mrs. Sheehan stated that the Board will respond stating that the fees were drafted by the Administration.

Mrs. Sheehan further stated that Ms. Levine's third comment, which is also one of Mr. O'Hara's comment, deals with the language which reflects that the journeyman can demonstrate to the satisfaction of the Board that he has met the requirements of experience and classroom hours through alternative means. Mrs. Sheehan stated that Ms. Levine is requesting that this language be deleted from the proposal.

Mrs. Sheehan stated that the Board will thank Ms. Levine for her comment, however, the Statute gives the Board the authority to approve the work history of applicants through an alternative means.

Mrs. Sheehan also stated that Ms. Levine's fourth comment requests that the Board propose that businesses employing qualified journeyman electricians post the names of registrants at the workplace.

Mr. Flaherty stated that licensed electrical contractors are not required to post the names of their employees at the work site and the Board does not feel that this requirement should apply to journeymen electricians.

Mrs. Sheehan stated that the Board will thank Ms. Levine for her comment; however, the Board will not make this change. The Board will abide by the Statute which requires it to maintain a register to include all pertinent information.

Mrs. Sheehan stated that the Board has already addressed Mr. O'Hara's comment concerning the proposal that applicants can demonstrate their experience through alternative means.

Mrs. Sheehan also stated that Mr. O'Hara's second comment recommends that the journeyman regulation requiring 576 classroom hours be approved by both a Federal Agency and a Federally Certified State Agency.

Mrs. Sheehan stated that the Board will respond thanking him for his comment; however, the Board does not wish to make it an expressed regulation. The Board may accept 576 classroom hours approved by both a Federal

Agency and a Federally Certified State Agency as an "alternative means."

Mrs. Sheehan also stated that the last comment was received from Mr. Bibbo stating that the journeyman proposal over regulates the profession.

Mrs. Sheehan stated that the Board will respond stating that it is bound by its Statutes. Mrs. Sheehan also stated that Assembly Bill #4127 has not been enacted.

Mrs. Sheehan further stated that, as per the Board's request at one of its previous meetings, she will change the journeyman regulation to reflect that the work should have been done in compliance with the National Electrical Code

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, that the Board approves the adoption of N.J.A.C. 13:31-1.5 "Qualified Journeyman Electrician" with the changes as discussed.

Mr. Bibbo stated that Assembly Bill #4127 no longer exists; it has been changed to Assembly Bill #928.

DAG Provost stated that Assembly Bill #928 does not pertain to the journeyman regulation that was discussed.

Mr. Bibbo stated that the electrical contractors association feels that the electrical contractors are being over regulated. The Association has contacted their assembly people who are in agreement with the association's comments.

Mr. Schooley stated that most proposed regulations are not generated by this Board.

Maryann Sheehan discussed with the Board the following bills.

The Board reviewed Senate Bill No. 1805 which provides that whenever an appointed member of a State board, commission, or independent authority fails to attend three consecutive meetings thereof without good cause that member may be removed from office by a two thirds vote of the authorized membership of the board, commission or independent authority, excluding any vacancies. The Board does not have a position on Senate Bill No. 1805.

The Board reviewed Senate Bill No. 2735 which prohibits the State Bureau of Identification from disseminating criminal history record background information requested for employment or licensing purposes when that information is more than seven years old if the applicant was convicted of a third or fourth degree crime, or a disorderly or petty disorderly persons offense, but then did not commit another crime or offense for seven years. This bill would not apply to applicants who have committed sex offenses for which registration would be required under Megan's Law.

Mrs. Cook advised the Board that because it does not fingerprint its applicants, it is not necessary for the Board to take a position on Senate Bill No. 2735.

The Board reviewed Senate Bill No. 1815 which reduces the statute of limitations period for certain actions against professionals who are licensed persons as defined in N.J.S.A. 2A:53A-26. Specifically, the bill amends the current law to reduce the six year limitations period to two years for actions against certain licensed professionals.

Mrs. Cook advised the Board because Senate Bill No. 1815 does not pertain to licensed electrical contractors, it is not necessary for the Board to take a position on Senate Bill No. 1815.

The Board reviewed Assembly Bill No. A1032 which amends "The Electrical Contractors Licensing Act of 1962," P.L. 1962, c.1962 (C.45:5A-1 et seq.), to allow any person to maintain, install, repair or connect a built-in vacuum system which has the potential of not more than 24 volts.

Motion made by Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and unanimously passed, that the Board opposes Assembly Bill No. A1032. It is the opinion of the Board that in some instances low voltage wiring can be more dangerous than high voltage wiring, as for example, when wires are not fused properly. Therefore, before approving this exemption, the Board would first need to research the safety issues involved.

Mrs. Cook asked Mrs. Sheehan if she can ensure that the Board's position be presented by the Division of Consumer Affairs as this bill is being introduced the next day.

Mrs. Sheehan stated that she will advise the Division to inform the Office of the Attorney General of the Board's position.

Mrs. Sheehan left the meeting at 10:15 A.M.

Thomas M. Mains, License #6069, t/a Thomas Mains Electrical Contractor, 714 Ashdale Road, Morrisville, PA 19067-6802, appeared before the Board at 10:30 A.M.

Kevin D. Larison, Applicant, 587 Rosemar Drive, Morrisville, PA 19067, appeared before the Board at 10:30 A.M.

The Board requested that the above named individuals appear before it to discuss Mr. Larison's qualifications and work history with Thomas Mains Electrical Contractor, Business Permit #6069

Mr. Richard T. Aicher, Jr. stated for the record that he is recusing himself from this discussion as he has known Mr. Mains for many years.

Mr. Schooley asked Mr. Larison how he is able to work for an employer for six and one half years without being compensated.

Mr. Larison stated that he has a learning disability so he made an agreement with Mr. Mains to work for him so that he could gain his experience. Mr. Larison also stated that on an average he works with Mr. Larison thirty-five to forty hours per week. Mr. Larison further stated that he does not always work five days a week. Mr. Larison stated that some weeks he works seven days a week and some weeks he did not perform any work.

Mr. Mains stated that he has known Mr. Larison's mother and has known Kevin since he was eleven or twelve years of age. Mr. Mains also stated that he has a mentally retarded son and is a single father. Mr. Mains further stated that he works for a real estate company performing the electrical work on homes that are being rehabilitated.

Mr. Mains stated that Mr. Larison came to him because he was having trouble gaining employment and he asked him to teach him the electrical business. Mr. Mains also stated that the real estate company forwards to him a list of the violations cited, and because the homes are empty, he is able to perform the necessary work any time during the day or early evening. Mr. Mains further stated that he advised Mr. Larison that he would teach him, but he could not afford to pay him. Mr. Mains stated that Mr. Larison was acceptable to this arrangement because he was living with his in-laws. Mr. Mains stated that Kevin work approximately thirty to thirty-five hours per week.

Mr. Mains also stated that he gained custody of his children and he collected social security benefits until he could earn a living. Mr. Mains stated that he does not have any other employees.

Mr. Flaherty asked Mr. Mains how Mr. Larison was protected if he was not covered under worker's compensation insurance.

Mr. Mains stated that he has worker's compensation as a sole proprietor; however, Mr. Larison was not covered under his insurance.

Mr. Flaherty advised Mr. Mains that he was violating the Board's Laws.

Mr. Mains stated that he did not realize that he was breaking the law.

Mr. Mains also stated that he received payment for the work performed but did not charge for Mr. Larison's labor.

Mr. Flaherty asked Mr. Mains if he feels that Mr. Larison is capable of being an electrical contractor. Mr. Mains stated that Mr. Larison is capable of performing residential work; however, he does not think Mr. Larison is capable of performing commercial work.

Mr. Larison stated that he lives with his in-laws and they take care of him financially. Mr. Larison also stated that he will continue to work with Mr. Mains until such time as he passes the electrical contractor's examination.

Mr. Mains stated that he would like to retire soon and have Mr. Larison take over the business. Mr. Mains also stated that Mr. Larison also has a son with a learning disability and performing the work for the real estate company would afford him the freedom to work the same hours as he has done.

Mr. Mains further stated that he apologizes to the Board as he did not realize he was breaking any laws. Mr. Mains stated that he will forward to the Board a certification from his accountant that Mr. Larison is now an employee of his company.

Mr. Schooley advised Mr. Larison that the Board will consider his application for examination.

Mr. Mains and Mr. Larison left the meeting at 10:50 A.M.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, that the Board go into Executive Closed Session to consider this matter.

The Board returned to Public Session to consider Mr. Larison's application for examination.

Mr. Flaherty stated that he would not hold up Mr. Larison's application.

Mr. Malec stated that the work experience certification is signed and sealed by a licensed electrical contractor who has now verbally advised the Board that Mr. Larison is qualified. Mr. Mains admits that he violated the law, but it does not apply to the applicant. Mr. Malec also stated that he sees no reason why the Board would not allow Mr. Larison to take the examination.

Mr. Schooley stated that it is the Board's policy that someone who applies to take the examination, and their experience is gained outside the State of New Jersey, the Board requests that W-2 forms be provided by the applicant.

Mr. Papademas stated that Mr. Mains signed a letter indicating that Mr. Larison worked for him for 40 hours a week; however, he testified that Mr. Larison works 30 to 35 hours per week.

Mr. Schooley asked the Board to consider whether or not Mr. Larison is qualified to take the electrical contractor's examination based on his application.

Mr. Flaherty stated that in his opinion Mr. Larison should be allowed to take the examination even though his experience may be limited to one phase of construction.

Mr. Malec agreed.

Motion made by Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and passed, that no action be taken against Mr. Larison and the application process continue.

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Three

(3) applications were approved.

In the matter of Edward Johnson, License #7469 (Expired), the following was the Board's motion.

Motion made by Mr. James H. Flaherty and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, that Deputy Attorney General Ginger R. Provost finalize the Provisional Order of Discipline and issue a Final Order of Discipline ordering that Mr. Johnson pay the civil penalty assessed against him in the amount of \$500.00 for violation of N.J.S.A. 45:5A-9. An enhanced civil penalty in the amount of \$5,000.00 be imposed upon Mr. Johnson for a second violation of N.J.S.A. 45:5A-9 and N.J.S.A. 45:1-21(e); Mr. Johnson shall return the pressure seals issued to South Shore Electric, Inc. and Johnson Electric, Inc. and no application for reinstatement will be considered until such time as the prior sanctions as contained in the Final Order of Discipline dated March 12, 2002, as well as the sanctions imposed in the Provisional Order of Discipline filed November 27, 2007, are satisfied.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, that the Board go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.

Meeting adjourned at 2:30 P.M.
