

**810 BUSINESS MEETING OF THE BOARD OF EXAMINERS OF
ELECTRICAL CONTRACTORS (PUBLIC SESSION) - - - JUNE 6, 2007**

The Board Minutes of June 6, 2007, have not been formally approved and are subject to change or modification by the Public Body at its next meeting of July 11, 2007. All requirements of the "Open Public Meetings Act" have been complied with according to N.J.S.A. 10:4-6.

The notice of the meeting has been mailed to the Newark Star Ledger, Camden Courier Post, and the Trenton Times, and also notice has been posted on the Bulletin Board at the office of the Secretary of State, Trenton, New Jersey.

Meeting of June 6, 2007, was called to order at 9:00 A.M.

Also in attendance was James Bibbo, Central Jersey Electrical League and Shawn Gianella, New Jersey Electrical Contractors Association.

The Board saluted the Flag.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. James H. Flaherty, and unanimously passed, to approve the Minutes of the 809 Meeting held May 2, 2007.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. James H. Flaherty, and unanimously passed, to approve (43) Initial Licenses effective June 6, 2007 to March 31, 2009.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. James H. Flaherty, and unanimously passed, to approve (41) Initial Business Permits effective June 6, 2007 to March 31, 2009.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. James H. Flaherty, and unanimously passed, to approve (9) Initial Business Permits Previously Expired effective June 6, 2007 to March 31, 2009.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. James H. Flaherty, and unanimously passed, to approve (13) Changes in Business Permits effective June 6, 2007 to March 31, 2009.

Maryann Sheehan, Regulatory Analyst, Director's Office, appeared before the Board at 9:15 A.M. to discuss

N.J.A.C. 13:31A-1.10 which proposes to make changes to its reciprocity regulation for the Fire Alarm, Burglar Alarm, Locksmith Advisory Committee.

Mrs. Sheehan stated that the Committee is proposing to delete this rule as they want the applicant to take the examination. The Committee proposes that an applicant who has gathered their experience from another state successfully pass the examination. If the experience and knowledge in that other state are equal to or greater than the experience and knowledge requirements set forth in the Committee's rules and regulations, the applicant would only have to take the examination. However, if the experience and knowledge requirements in that other state are not equal to or greater than the experience and knowledge requirements set forth in the Committee's rules and regulations, the applicant would be required to have practical hands-on experience; (complete an apprenticeship program for licensure as a locksmith); and take the examination.

Mrs. Sheehan also stated that a couple of applicants thought that since they had a license from another State they would automatically be eligible to take the examination. Mrs. Sheehan further stated that based on the the current regulation, the language appears to allow an applicant, who has a license in another state, to be exempt from the examination requirement.

Mr. Malec stated that since no other state meets our requirements, there is no reason to address this issue.

Mrs. Sheehan stated that she is not completely convinced that this is so. This was the representation made at a committee meeting.

Mr. Schooley suggested that Mrs. Sheehan advise the Committee that the Board is requesting clarification as it does not agree with their proposal.

Mrs. Sheehan also discussed with the Board Assembly Bill No. 4127 which provides that an applicant to the Board of Examiners of Electrical Contractors for a business permit must meet certain minimum standards before being issued a permit. The bill provides that an applicant for a business permit satisfactorily demonstrate to the Board that he: (1) is currently licensed as an electrical contractor; (2) has been employed as a qualified journeyman electrician registered by the Board or a licensed electrical contractor for a total of at least four years; (3) has completed a management class of at least 60 hours at a county college or county vocational school accredited pursuant to Title 18A of the New Jersey Statutes, or other accredited institution of higher education approved by the board or holds a bachelor's degree, with a business major, from a regionally accredited college or university; and (4) is the holder of not less than 25 percent of the issued and outstanding shares of stock in a corporation, or not less than 25 percent of the capital of a partnership, or not less than 25 percent of the ownership of any other firm or legal entity established to engage in the business of electrical contracting in this State.

The bill further provides that a person who holds a business permit for electrical work shall maintain a bank letter of credit in the minimum amount of \$1,000,000 for property damage and bodily injury to or death of one or more persons or general liability insurance in the minimum amount of \$1,000,000 for the combined property damage and bodily injury to or death of one or more persons in any one accident or occurrence. This is an increase from the current requirement of \$300,000 in each case.

Mrs. Sheehan stated that according to this bill, in order to enter into business, an electrical contractor must be an owner or a partner of the company; an electrical contractor can no longer just be an employee.

Mr. Flaherty stated that he has major concerns with this requirement.

Mrs. Sheehan also stated that the bill requires that an applicant for a business permit be a licensed electrical contractor; be employed as a qualified journeyman electrician for a total of not less than four years; complete a management class of not less than 60 hours or hold a bachelor's degree; and is the holder of not less than 25% of the company.

Mr. Schooley asked would an electrical contractor have to be employed for four years before he obtains a

business permit?

Mrs. Sheehan stated according to this bill, in order to get a business permit, an electrical contractor must be licensed and have been employed as an electrical contractor for four years, have schooling, and own a share of the company.

Mr. Schooley stated that is ridiculous.

Mrs. Sheehan also stated that this bill would remove the Board's language which allows an applicant to establish to the satisfaction of the Board that the applicant has the necessary educational background and experience to qualify to take the examination. This bill would require that the applicant graduate from an apprenticeship program. Mrs. Sheehan further stated that this bill further requires that an applicant who fails the examination, retake all portions of the examination, even the portions that the applicant had previously passed.

Mr. Schooley stated that he does not know of any other licensing agency that requires applicants to retake the passing portion of their examination. This also does not make any sense.

Mrs. Sheehan asked why the Board objects to the requirement that the applicant have five years of apprenticeship training.

Mr. Schooley stated that an individual who has been in the field for 20 years would possibly be qualified to take the examination. However, this bill would limit the individual with 20 years of experience who may not be able to attend an apprenticeship training program.

Mr. Flaherty stated that the apprenticeship program is a good program; however, it should not be the only avenue by which an applicant can be considered eligible to take the electrical contractor's examination.

Mr. Flaherty stated that it is his opinion that a lobbyist has sponsored this bill and is trying to limit the industry.

Mr. Flaherty also stated that the licensee is still the responsible individual.

Mrs. Sheehan stated that this bill would make the person with the assets the responsible individual. Mr. Schooley stated that the amount of insurance required under this bill is also ridiculous; as the \$300,000.00 now required is more than sufficient.

Mr. Flaherty stated that licensees who bid on the larger contracts are required to have a million dollar insurance policy. Therefore, the smaller contractors who are not bidding on the larger jobs would not need this amount of insurance. This requirement would hurt the smaller contractor and put the larger contractor into business.

Mr. Flaherty also stated that this bill does nothing to protect the consumer.

Motion made by Mr. James H. Flaherty and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that the Board strongly opposes Assembly Bill No. 4127 for the reasons as stated above.

Check in the amount of \$100.00 and \$600.00 received from Michael Delli Santi, Unlicensed, as the eighteenth and nineteenth (final payment) of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started November 29, 2005.

The Board accepted the payment.

Check in the amount of \$750.00 received from Thomas Blandino, License #12399 (Expired) as the first and final payment of a civil penalty in the amount of \$750.00 for violation of N.J.A.C. 13:45C-1.2 & 1.3.

The Board accepted the payment.

Postal Money Order in the amount of \$100.00 received from Jack Giaimo, License #7375, as the second

installment of a civil penalty in the amount of \$3,000.00 for violation of N.J.S.A. 45:5A-9 and N.J.A.C. 13:31-3.3. Payments started April 16, 2007 and the balance due is \$2,800.00.

The Board accepted the payment.

Check in the amount of \$2,250.00 received from Ricci, Fava and Saracino, LLC on behalf of Michael Sorace, Unlicensed, as the second and final installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9. Payments started June 26, 2006.

The Board accepted the payment.

Postal Money Order in the amount of \$50.00 received from Robert Garron, Unlicensed, as the second and final installment of a civil penalty in the amount of \$250.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq.

The Board accepted the payment.

Check in the amount of \$1,000.00 received from Ramesh Benimadho, License #14769, as the first and final installment of a civil penalty in the amount of \$1,000.00 for violation of N.J.A.C. 13:31-3.2(b) and N.J.A.C. 13:45A-16.2(a 12).

The Board accepted the payment.

Cashier's Check in the amount of \$1,000.00 received from Louis P. Giacomozzi, License #6257, as the first and final payment of a civil penalty in the amount of \$1,000.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq.

The Board accepted the payment.

Check in the amount of \$100.00 received from James H. Gandy, Unlicensed, as the first installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.A.C.13:31-3.3 and N.J.S.A. 45:5A-9. The balance due is \$2,400.00.

The Board accepted the payment.

E-Mail dated April 24, 2007, received from Steven Kutner, License #5415 (Expired), requesting reinstatement of his License #5415 which he failed to renew for the 2000 to 2003; 2003 to 2006; and 2006 to 2009 triennial renewal periods.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, that a letter be sent to Mr. Kutner advising him that in order to regain his License #5415 he must take and pass the written examination in order to regain his license pursuant to the Uniform Enforcement Act which requires that five years after a license has expired a licensee is not permitted to renew his/her license without first taking the qualifying examination.

The sub-committee reviewed additional information received from Kennie Fried, Warshauer Electric Supply Co. The Board held in abeyance the approval of the courses entitled "Residential Innovations" and "NJ Smart Start Buildings" pending receipt of more detailed course outlines.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that the courses entitled "Residential Innovations" and "NJ Smart Start Buildings" are approved.

The sub-committee reviewed additional information received from Thomas McNulty, Penn-Del-Jersey Chapter, NECA. The Board held in abeyance the approval of the course entitled "Harnessing Technology to Increase Profitability" pending receipt of a more detailed course outline.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that the course entitled "Harnessing Technology to Increase Profitability" is approved.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Chester A. Brzostek.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that a letter be sent to Mr. Brzostek asking him to clarify whether or not the course entitled "2005 National Electrical Code Review and Law" is the course which teaches the nine hours of code changes and the one hour of laws, rules and regulations. Additionally, the outlines submitted for the courses entitled "Electrical Grounding and Bonding" and "Industrial Motor Controls I" appear to reflect that students will be graded on certain projects and expected to take a test. Mr. Brzostek will be advised that the examination cannot be part of the instructional hours nor does the licensee have to pass an examination in order to receive a certificate of completion. Therefore, Mr. Brzostek will be requested to provide a breakdown of the hours to be taught.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Robert Frangipane.

Note received from Mr. Frangipane and an E-Mail received from Thomas Valeo, Instructor #179, requesting that the Board allow instructors to only make copies of the changes and/or new laws in the Board's Statutes, Rules and Regulations Law Book, instead of making a copy of the complete law book.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve Mr. Frangipane's request to teach previously approved courses and his request to add instructors to previously approved courses.

Additionally, Mr. Frangipane and Mr. Valeo will be advised that it is standard procedure that all instructors are to supply copies of the Board's Statutes, Rules and Regulations at their expense.

Letter dated May 16, 2007, received from Vernon Cooper, License #4193, requesting 15 continuing education credits towards his license renewal pursuant to N.J.A.C. 13:31-1.7.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that a letter be sent to Mr. Cooper advising him that his request does not appear to meet the criteria of N.J.A.C. 13:31-1.7. The Board would like to know from Mr. Cooper whether or not he developed this course; if so, he is to provide the background for the development of same.

Letter dated March 15, 2007, received from Joseph Hovanec, Chairman, New Jersey Electrical Contractors Political Action Committee, requesting that the Board affirm that the installation of Solar Voltaic Systems, consisting of a single or multiple solar voltaic panel(s), with a potential of ten volts or more, be installed by a licensed electrical contractor who holds a valid business permit, with the exception of any applicable exemptions.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, that Mr. Hovanec be provided with a copy of the Board's Minutes of the April 4, 2007 Meeting wherein the Board determined that the installation of Solar Photovoltaic Array Modular Panels are clearly electrical equipment that emits a voltage of more than ten volts; therefore, the installation of these panels would not be considered exempt work and must be installed by a licensed electrical contractor who holds a business permit.

The Board review a memorandum dated May 24, 2007, from Darlene Kane, Budget Officer, Division of Consumer Affairs, stating that for the third quarter of Fiscal Year 2007, the Board/Committee was directly billed for 108.1 hours of Deputy Attorney General/Paralegal Services totaling \$14,514.90.

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Eighteen (18) applications were approved.

Mr. Gianella stated that he believes Assembly Bill No 4127 is being sponsored because a water utility company produced a flyer informing their customers that they should not have to pay an electrical contractor when they can get a much better deal through the utility company. Mr. Gianella also stated that if this is the same bill, the attempt was to avoid having a utility company take on a licensed electrical contractor and say do not hire an electrical contractor when we can give you a better price.

Mr. Malec stated that this is no different from the advertising done by Sears or even insurance agencies.

Mr. Schooley stated that the same thing occurred when the industry came to the Board stating that electrical contractors needed 34 hours of continuing education. After all was said and done, they then complained about the number of hours required.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Constantinos Papademas, and unanimously passed, that the Board go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.

Meeting adjourned at 2:00 P.M.
