

857th BUSINESS MEETING OF THE BOARD OF EXAMINERS
OF ELECTRICAL CONTRACTORS (PUBLIC SESSION) - - - JULY 6, 2011

Board meeting of July 6, 2011, was called to order at 9:00 A.M.

Joseph Donofrio, Deputy Attorney General, Division of Law, and intern Carol Landolfi, were present from 9:00 A.M. until the close of the meeting.

The Board saluted the Flag.

July 6, 2011

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to approve seventeen (17) Initial Licenses effective July 6, 2011 to March 31, 2012.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to approve thirteen (13) Initial Business Permits effective July 6, 2011 to March 31, 2012.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to approve two (2) Initial Business Permits Previously Expired effective July 6, 2011 to March 31, 2012.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to approve six (6) Changes in Business Permits effective July 6, 2011 to March 31, 2012.

The Board elected a Chairman for the year July 6, 2011 to June 30, 2012, pursuant to N.J.S.A. 45:5A-5.

Mr. Richard T. Aicher, Jr. nominated Mr. Joseph P. Schooley, and the nomination was seconded by Mr. James H. Flaherty.

Let the record reflect that Mr. Schooley has been elected Chairman for the Board from this date until the July 2012 meeting.

Check in the amount of \$100.00 received from William Passione, License #11485, t/a B. Passione Electric, as the sixteenth installment of a civil penalty in the amount of \$3,500.00 for violation of N.J.S.A. 45:5A-9, N.J.S.A. 56:8-1 et seq., and N.J.A.C. 13:45C-1.2. Payments started February 4, 2010 and the balance due is \$1,895.00.

The Board accepted the payment.

Check in the amount of \$25.00 received from Frank D'Arpa, License #8778 (Inactive), as the fifty-fifth installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started September 25, 2002 and the balance due is \$1,125.00.

The Board accepted the payment.

July 6, 2011

Check in the amount of \$1,000.00 received from Nathan Nelson, Unlicensed, as the first and final payment of a civil penalty in the amount of \$1,000.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq.

The Board accepted the payment.

Check in the amount of \$250.00 received from Vadim Verhowsky, License #14257, t/a ACDC Electrical Contractors, LLC, as the first and final payment of a civil penalty in the amount of \$250.00 for violation of N.J.A.C. 13:31-1.5(b).

The Board accepted the payment.

The sub-committee reviewed an application for Continuing Education Course/Seminar Approval received from Dessie Kirilova, Solar Education Center.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve three (3) new courses and instructors. Ms. Kirilova will be advised that the Board is only approving twenty-four (24) hours of the twenty-eight (28) hour course entitled "5 Day Entry Level Solar PV Design and Installation". In regards to the courses entitled "Introduction to Small Wind Systems" and "Intermediate PV Prelude to Wiles", the Board is only approving five (5) hours of the eight (8) hour course. Ms. Kirilova will be further advised that licensed electrical contractors must attend all hours in order to receive a certificate for the renewal of their license. It is the Board's recommendation that this language be included in their advertisements.

The sub-committee reviewed an application for Continuing Education Course/Seminar Approval received from Joseph Swanson, Swanson Consulting, Inc.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve five (5) new courses and instructor. The Board also approved Mr. Swanson's request to increase the hours of the previously approved course entitled "Electrical Safety" from three to four hours.

The sub-committee reviewed an application for Continuing Education Course/Seminar Approval received from Richard Bernhardt, John-Winston Engineers & Consultants, Inc. Mr. Bernhardt has requested that the previous course outline be replaced with this newest outline. (Previous outline was approved by the Board on June 1, 2011 as four - five hour technical courses).

July 6, 2011

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve four (4) new courses and instructor. The courses are approved as five hours in length as the Board does not consider the examination as part of the instructional hours.

The sub-committee reviewed an application for Continuing Education Course/Seminar Approval received from Alan Chech.

Motion made by Mr. Mitchell R. Malec and seconded Mr. Constantinos Papademas, and unanimously passed, to approve three (3) new courses and instructors.

Mr. Papademas stated that he has done some additional research concerning webinar continuing education courses and will soon contact Mr. Delasandro about taking the webinar course.

Mr. Papademas also stated that he has spoken to inspectors who have taken webinar courses and he has been advised that there is a significant amount of time used for introductions.

Mr. Malec stated that there are valuable assets in taking the online courses as applicants would save money in traveling expenses.

Mr. Malec also stated that perhaps the Board could limit the number of hours that licensees can attend webinar courses to five hours per renewal cycle.

Mr. Flaherty asked what would happen if, during a webinar course, the computer's automatic updates removed the licensee from the webinar course.

Mr. Malec stated that the licensee would not receive credit. The same would happen to a licensee who had car trouble and could not attend the seminar.

Mr. Flaherty stated that the Board should move in the direction of approving webinar courses.

DAG Donofrio stated that language would have to be drafted if the Board is going to limit the number of hours licensees attending webinar courses can receive credit.

Signed cease and desist agreement received from Nathan Nelson, t/a Alltest Instruments, Inc., Howell, New Jersey.

The Board accepted the signed cease and desist agreement.

July 6, 2011

The Board reviewed applications for the written examination to be administered by Prometric. Thirty-eight (38) applications were approved.

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. Mitchell R. Malec, and unanimously passed, to go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
