

868th BUSINESS MEETING OF THE BOARD OF EXAMINERS
OF ELECTRICAL CONTRACTORS (PUBLIC SESSION) - - - JULY 11, 2012

Kathleen Moran, Administrative Assistant 3, was present from 9:00 A.M. until the close of the meeting.

Joseph Donofrio, Deputy Attorney General, Division of Law, and Aron Mandel, an intern with the Division of Law, was present from 9:00 A.M. until the close of the meeting.

Also in attendance was Bob Spellman, Electrical Contractors Association of New Jersey.

The Board saluted the Flag.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Arthur W. Jacobs, Sr., and unanimously passed, to approve (20) Initial Licenses effective July 11, 2012 to March 31, 2015.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Arthur W. Jacobs, Sr., and unanimously passed, to approve (17) Initial Business Permits effective July 11, 2012 to March 31, 2015.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Mitchell R. Malec , and unanimously passed, to approve (6) Initial Business Permits Previously Expired effective July 11, 2012 to March 31, 2015.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, to approve (5) Changes in Business Permits effective July 11, 2012 to March 31, 2015.

Motion made by Mr Joseph F. Cantalupo and seconded by Mr. James H. Flaherty, and unanimously passed, to approve the Minutes of the 865th Open Session Business Meeting held April 4, 2012.

Motion made by Mr. James H. Flaherty and seconded by Mr. Arthur W. Jacobs, Sr., and unanimously passed, to approve the Minutes of the 866th Open Session Business Meeting held May 2, 2012.

Pursuant to N.J.S.A. 45:5A-5 the Board shall elect a chairman to preside over the meetings during the period of July 11, 2012 to June 30, 2013.

Mr. Richard T. Aicher, Jr. nominated Mr. Joseph P. Schooley, and the nomination was seconded by Mr. Arthur W. Jacobs, Sr.

Let the record reflect that Mr. Schooley has been elected Chairman for the Board from this date until the July 2013 meeting pursuant to N.J.S.A. 45:5A-5.

Mr. Schooley asked Mr. Mitchell R. Malec and Mr. Constantinos Papademas to continue to serve on the Committee for Continuing Education.

Mr. Schooley asked Mr. Joseph F. Cantalupo to continue to serve as the liaison to the Burglar Alarm, Fire Alarm, and Locksmith Advisory Committee.

Check in the amount of \$2,500.00 received from Santiago Garrido, License #5845, t/a Garrido Electrical Contractor, as the first and final payment of a civil penalty in the amount of \$2,500.00 for violation of N.J.A.C. 13:45C-1.2.

The Board accepted the payment.

Letter dated May 16, 2012, received from Brian Kajzer requesting reinstatement of his License #8678

which expired March 31, 2006. Mr. Kajzer has provided medical documentation.

Motion made by Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and unanimously passed, that a letter be sent to Mr. Kajzer advising him that his request is being held in abeyance pending receipt of updated medical documentation. The date on the last doctor's note provided by Mr. Kajzer was May 5, 2009. Additionally, the Board would like to know whether or not Mr. Kajzer intends to go back into business as an electrical contractor. If Mr. Kajzer advises that he does not intend to go back into business, Mr. Kajzer will be asked if he wishes to have his license placed in "inactive" status.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Jan Whitley, Janco Electric, LLC, requesting approval of previously approved courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve previously approved courses and instructors.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Tom Rosa, Honeywell Fire Systems - Fire Lite Alarms, requesting approval of previously approved courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve previously approved courses and instructors.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Lois D'Apuzzo, The Institute for Continuing Education.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve two (2) new courses and instructors.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Joseph E. Rossi.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve four (4) new courses and instructors and previously approved courses and instructors.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Stanley Kwake, NAT PRO Electrical Seminars, requesting approval of previously approved courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve previously approved courses and instructors.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Claudine Oleskin, Cook College Office of Continuing Professional Education, requesting approval of previously approved courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve previously approved courses and instructors.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Eric DeGesero, NJ Independent Electrical Contractors (NJIEC).

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve forty-four (44) new courses and instructors. The courses entitled "The BIZ Success Blueprint for Contractors (Part 1)" and "The BIZ Success Blueprint for Contractors (Part II)" are being held in abeyance pending receipt of a more detailed course description. The course description provided for the two courses is the same. Additionally, the Board requests clarification as to the name of the instructor teaching the course entitled "Demystifying The "Smart Grid" - Opportunities in Building The Next Generation of Energy Infrastructure" as the name listed in the course description is not the name listed as the instructor.

Mr. DeGesero will also be advised that the Board does not approve half hour courses. Therefore, the courses listed for 1.5 hours have been approved as one hour courses unless Mr. DeGesero can substantiate a two hour course.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Clifford Reisser, IBEW Local 269, JATC.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve all previously approved courses and instructors

July 11, 2012

Mr. Constantinos Papademas recused himself from the following discussion and motion as he is listed as an instructor.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Kennie M. Fried, Warshauer Electric Supply.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve all previously approved courses and instructors and one (1) new course and instructor.

E-Mail dated March 30, 2012, received from Richard Goldbeck, License #6354, requesting an extension to complete his Continuing Education Courses for the 2012 renewal period. Mr. Goldbeck stated that he is currently on assignment in Afghanistan authorized by the Department of Defense.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Mitchell R. Malec, and unanimously passed, that a letter be sent to Mr. Goldbeck advising him that the Board has granted a six-month extension to complete the 34 hours of Continuing Education Courses for the 2012 triennial renewal period. The six-month extension will commence upon his return from his assignment in Afghanistan. Mr. Goldbeck will be advised that he cannot renew his business permit until such time as he returns from his assignment.

Letter dated April 22, 2012, received from Mr. Szardenings, License #6590, along with copies of Continuing Education Course certificates totaling 35 hours.

Mr. Szardenings was granted an extension to take the required 34 hours of Continuing Education. The extension expired on June 30, 2012.

The Board accepted the continuing education certificates.

Letter dated May 31, 2012, received from Robert K. Schafer requesting a six-month continuance of business under Permit #2101 according to N.J.S.A. 45:5A-14. The licensee, Roland K. Schafer, died on September 28, 2011.

Mr. Schafer stated that he has been with the business since 1987.

Office files reflect that Robert is scheduled to take the October 2012 examination.

July 11, 2012

Based on the Board's previous discussion, a letter dated June 21, 2012, was sent to Mr. Schafer advising him that pursuant to N.J.S.A. 45:5A-14 the firm of Affordable Electrical Maintenance Service, LLC has been granted a second and final six-month continuance of business under permit #2101. Mr. Schafer was also advised should he not pass the October 2012 examination, then his company must hire a licensed electrical contractor to endorse his/her business permit to Affordable Electrical Maintenance Service, LLC to continue the business.

Board to make a motion reaffirming its previous discussion granting Mr. Schafer's request.

Motion made by Mr. James H. Flaherty and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, to ratify the Board's discussion and grant Affordable Electrical Maintenance Service, LLC a second and final six-month continuance of business under permit #2101.

Signed cease and desist agreement received from Peter Suleski, t/a Peter to the Rescue, Dover, New Jersey.

Letter dated June 9, 2012, received from Richard Rotonde, t/a (201) Generator, stating he will include language to reflect "all electrical work performed by KB Electric, Inc., Business Permit #11421". Should K B Electric, Inc. no longer be subcontracted to perform the electrical work for his company, future advertisements will reflect "all electrical work performed by licensed electrical contractors"

E-Mail received from Andrea Mann, t/a Mann Wireless, seeking the Board's assistance in clarifying their licensing needs for the State of New Jersey.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Mitchell R. Malec, and unanimously passed, that a letter be sent to Ms. Mann advising her that based on the description of the work her company performs, it does not appear that Mann Wireless is required to secure a license and business permit. However, it does appear that Mann Wireless is required to obtain a Telecommunications Wiring Exemption Certificate.

The Board reviewed a response received from Santiago Garrido, License #5845, t/a Garrido Electrical Contractor, to the Provisional Order of Discipline filed May 2, 2012, ordering that Mr. Garrido is provisionally reprimanded; License and Business Permit #5845 is provisionally suspended; and assessed a civil penalty in the amount of \$2,500.00 for violation of N.J.A.C. 13:45C-1.2. Included with the response was a civil penalty payment in the amount of \$2,500.00

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Richard T. Aicher, Jr., and unanimously

passed, to go into Executive Closed Session to discuss this matter.

After a discussion in Closed Session, the following motion was made.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Constantinos Papademas, and unanimously passed, that Deputy Attorney General Joseph Donofrio finalize the Provisional Order of Discipline and issue a Final Order of Discipline which reflects that Mr. Garrido has paid the civil penalty in the amount of \$2,500.00 for violation of N.J.A.C. 13:45C-1.2.

The Board discussed whether or not to draft language requiring that Telecommunication Wiring Exemptions be renewable.

Mr. Flaherty stated that the Board would then know whether or not the person qualifying the exemption has left the company.

Mr. Schooley stated that some of the Board's concerns are whether or not the company is still in business; is the qualifier still employed by the company; should continuing education be required; and should proof of insurance be provided to the Board.

The Board requested that this matter be held in abeyance and discussed at a future meeting with the division's regulatory analyst.

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Twenty-nine (29) applications were reviewed.

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. Mitchell R. Malec, and unanimously passed, to go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred.

July 11, 2012

The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
