

879th BUSINESS MEETING OF THE BOARD OF EXAMINERS
OF ELECTRICAL CONTRACTORS (PUBLIC SESSION) - - - JULY 31, 2013

Committee meeting of July 31, 2013, was called to order at 9:00 A.M.

July 31, 2013

Note: A quorum was not present. All actions are to be ratified at the Board's next meeting to be held on September 4, 2013, or soon thereafter.

The Committee unanimously recommended to approve (24) Initial Licenses effective July 10, 2013 to March 31, 2015.

The Committee unanimously recommended to approve (23) Initial Business Permits effective July 10, 2013 to March 31, 2015.

The Committee unanimously recommended to approve (5) Initial Business Permits Previously Expired effective July 10, 2013 to March 31, 2015.

The Committee unanimously recommended to approve (8) Changes in Business Permits effective July 10, 2013 to March 31, 2015.

Mr. Spellman stated he read a newspaper article concerning a general contractor who was awarded an electrical contracting job in Ramsey, New Jersey. Mr. Spellman asked how he should proceed to ensure that the electrical work is not done by unlicensed individuals.

Mr. Schooley advised Mr. Spellman that he should first contact the municipality where the work is to be performed to make them aware of the situation. Mr. Schooley also stated that Mr. Spellman can forward to the Board a copy of the newspaper article for its' investigation.

Mr. Nagy stated that he is encountering many contractors who do not know what codes are being enforced because of the flood damage from the storm. Mr. Nagy also stated that he has submitted courses for the Board's approval so that he may teach licensees the various codes that are being enforced.

Mr. Schooley stated that because the Board does not have a quorum, it is unable to approve any continuing education course requests.

July 31, 2013

The Committee reviewed applications for the written examination to be administered by Thomson Prometric. Thirty-six (36) applications were approved.

Letter dated June 10, 2013, received from Nancy L. Darling requesting a six-month continuance of business under permit #4719 according to N.J.S.A. 45:5A-14. The licensee, Robert W. Sauer, died on May 22, 2013.

John Burkhardt, an employee of H.C. Sauer, Inc., has been approved to take the electrical contractors examination.

The Committee unanimously recommended that pursuant to N.J.S.A. 45:5A-14 the firm of H C Sauer, Inc. has been granted a six-month continuance of business under permit #4719. The Board approves John Burkhardt to qualify the business for the six-month period.
