

880th BUSINESS MEETING OF THE BOARD OF EXAMINERS
OF ELECTRICAL CONTRACTORS (PUBLIC SESSION)
SEPTEMBER 4, 2013

Board meeting of September 4, 2013, was called to order at 9:00 A.M.

Mr. Schooley stated that Richard T. Aicher, Jr. has resigned from his position on the Board. Mr. Schooley also stated that Mr. Aicher will be greatly missed. Mr. Schooley further stated that he would like to acknowledge Mr. Aicher's tenure by presenting him with a plaque.

David Freed, Acting Executive Director, was present from 9:00 A.M. until the close of the meeting.

Kathleen Moran, Administrative Assistant 3, was present from 9:00 A.M. until the close of the meeting.

Joseph Donofrio, Deputy Attorney General, Division of Law, was present from 9:00 A.M. until the close of the meeting.

Also in attendance was Robert Spellmon, Ernie Fletcher, and Joseph McMullen, Members of the Electrical Contractors Association of New Jersey; and Chris Madden, A.A. Richards.

September 4, 2013

The Board saluted the Flag.

Mr. Schooley requested a moment of silence for the victims of the September 11, 2001 terrorist attacks and for Carmen Fiore, Marian Fiore's father, who passed away on August 28, 2013.

Pursuant to N.J.S.A. 45:5A-5 the Board shall elect a chairman to preside over the meetings and an Executive Director to serve the Board during the period of September 4, 2013 to June 30, 2014.

Mr. James H. Flaherty nominated Mr. Joseph P. Schooley, and the nomination was seconded by Mr. Mitchell R. Malec.

Let the record reflect that Mr. Schooley has been elected Chairman for the Board from this date until the July 2014 meeting pursuant to N.J.S.A. 45:5A-5.

Mr. Joseph F. Cantalupo nominated David Freed, and the nomination was seconded by James H. Flaherty.

Let the record reflect that Mr. Freed has been elected Acting Executive Director for the Board from this date until the July 2014 meeting pursuant to N.J.S.A. 45:5A-5.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. James H. Flaherty, and unanimously passed, to approve the Minutes of the 878th Open Session Business Meeting held June 5, 2013, with the following corrections:

Page 2, paragraph 3

The Board noted the incorrect spelling of Ms. Glasgow's name.

Page 6, paragraph 3

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to accept the response as drafted and approve the adoption of the language in N.J.A.C. 13:31-1.7 (e) 1.i.

September 4, 2013

Motion made by Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and unanimously passed, to approve (31) Initial Licenses effective September 4, 2013 to March 31, 2015.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. James H. Flaherty, and unanimously passed, to approve (28) Initial Business Permits effective September 4, 2013 to March 31, 2015.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. James H. Flaherty, and unanimously passed, to approve (5) Initial Business Permits Previously Expired effective September 4, 2013 to March 31, 2015.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, to approve (12) Changes in Business Permits effective September 4, 2013 to March 31, 2015.

Letter dated August 16, 2013, received from Lisa A. Green requesting a six-month continuance of business under permit #14435 according to N.J.S.A. 45:5A-14. The licensee, James Green, died on July 19, 2013.

Ms. Green stated that John Cantilina, License #8635, will oversee the jobs already in progress.

Motion made Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and unanimously passed, that pursuant to N.J.S.A. 45:5A-14 the firm of Logram Eastern Electrical Corp. has been granted a six-month continuance of business under permit #14435. The Board approves John Cantilina, License #8635, to qualify the business for the six-month period.

The following Penalty Payments and Continuing Education Course/Seminar requests include the July 31, 2013 Committee Meeting and this meeting.

Two Personal Money Orders in the amount of \$200.00 each were received from Robert T. Brown, License #10584, as the ninth and tenth installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-13.1 et seq., N.J.S.A. 45:1-21(h), N.J.A.C. 13:31-1.7(b), and N.J.A.C. 13:31-1.7 (c). Payments started November 14, 2012 and the balance due is \$500.00.

September 4, 2013

The Board accepted the payments.

Two Money Orders in the amount of \$560.00 and \$440.00 received from Martin Coates, Unlicensed, as the first and final payment of a civil penalty in the amount of \$1,000.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Mr. Coates also signed an agreement to cease and desist from engaging in the business of electrical contracting in the State of New Jersey.

The Board accepted the payments.

Check in the amount of \$25.00 received from Frank D'Arpa, License #8778 (Inactive), as the sixth-fifth installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started September 25, 2002 and the balance due is \$900.00. The Board accepted the payment.

Checks in the amount of \$100.00 each were received from Christian Rupp, License #8149, as the seventh and eighth installment of a civil penalty in the amount of \$2,700.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started November 14, 2012 and the balance due is \$1,900.00.

The Board accepted the payments.

Personal Money Order in the amount of \$250.00 received from Patrick G. Soltis, License #6759, t/a Patrick G. Soltis Electrical Contractor, as the first and final payment in the amount of \$250.00 for violation of N.J.S.A. 45:5A-9.

The Board accepted the payment.

Check in the amount of \$500.00 received from Robert Saganski, License #4254, t/a Evergreen Electrical RP, LLC, as the first and final payment in the amount of \$500.00 for violation of N.J.A.C. 13:31-1.8(a).

September 4, 2013

The Board accepted the payment.

Check in the amount of \$2,500.00 received from Lester Kiss, License #7202, t/a Lester Kiss Electrical Contractor, as the first and final payment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq.

The Board accepted the payment.

Check in the amount of \$25.00 received from Frank D'Arpa, License #8778 (Inactive), as the sixty-fifth installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started September 25, 2002 and the balance due is \$875.00.

The Board accepted the payment.

Check in the amount of \$100.00 received from Christian Rupp, License #8149, t/a C R Electrical Contracting, as the ninth installment of a civil penalty in the amount of \$2,700.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started November 14, 2012 and the balance due is \$1,800.00.

The Board accepted the payment.

Postal Money Order in the amount of \$200.00 received from Robert T. Brown, License #10584, t/a R T Brown Electrical Contracting, Inc., as the eleventh installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-13.1 et seq., N.J.S.A. 45:1-21(h), N.J.A.C. 13:31-1.7(b), and N.J.A.C. 13:31-1.7 (c). Payments started November 14, 2012 and the balance due is \$300.00.

The Board accepted the payment.

September 4, 2013

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Eric Sivertsen, Northern New Jersey Chapter, Inc., NECA, requesting approval of new courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. James H. Flaherty, and unanimously passed, to approve seventeen (17) new courses and instructors.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Wendy Ruggles, Electrical Diagnostic Surveys, requesting approval of a new course.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. James H. Flaherty, and unanimously passed, to approve one (1) new course and instructors. Ms. Ruggles will be advised that this courses is being approved as a six (6) hour course and not a seven (7) hour course as the Board does not allow a quiz/exam to be part of the instructional hours and should not be a requirement in order for the licensee to receive a certificate.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Neil D. Nagy requesting approval of new courses and previously approved courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. James H. Flaherty, and unanimously passed, to approve two (2) new courses and instructors and previously approved courses. Mr. Nagy will be advised that the course entitled "NEMA Standards for Flood Damaged Equipment and Wiring" is approved as a three (3) hour course and not a six (6) hour course as the building portion of the course is not electrically related. Licensees must attend the four hours of instruction that Mr. Nagy is providing in order to receive three hours of credit.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Karen Tedford-Tierney, FLIR - Infrared Training Center, requesting approval of new courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. James H. Flaherty, and unanimously passed, to approve two (2) new courses and instructor. Ms. Tedford-Tierney will be advised that the course entitled "Infrared Electrical Inspection Training"

is being approved as a twelve (12) hour course and not a sixteen (16) hour course as the Board does not allow a quiz/exam to be part of the instructional hours and should not be a requirement in order for the licensee to receive a certificate.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Sarah Barton, Warshauer Electric Supply, requesting approval of new courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. James H. Flaherty, and unanimously passed, to approve four (4) new courses and instructors.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Ria Bloss, Bergen Community College, requesting approval of a new course.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. James H. Flaherty, and unanimously passed, that a letter be sent to Ms. Bloss advising her request to teach the course entitled "Introduction to the National Electrical Code" is not approved. The Board requests that Ms. Bloss provide it with a more detailed breakdown and description of this course.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Alice Haines, IEC Chesapeake, requesting approval of new courses and previously approved courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. James H. Flaherty, and unanimously passed, to approve two (2) new courses and instructors and previously approved courses.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Thomas McNulty, Penn-Del-Jersey Chapter, NECA, requesting approval of new courses.

September 4, 2013

Motion made by Mr. Mitchell R. Malec and seconded by Mr. James H. Flaherty, and unanimously passed, to approve fifteen (15) new courses and instructors.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Sarah Barton, Warshauer Electric Supply, requesting approval of new courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. James H. Flaherty, and unanimously passed, to approve four (4) new courses and instructors.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Eric DeGesero, New Jersey Independent Electrical Contractors, requesting approval of new courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. James H. Flaherty, and unanimously passed, to approve thirty-three (33) new courses and instructors.

Rodolphe Schomberg, the appearance of Rachel Glasgow, and the discussion regarding Telecommunications were on the July 31, 2013 Agenda and held in abeyance due to lack of a Quorum.

The Board reviewed the response received from Rodolphe Schomberg, License #11661, to the Provisional Order of Discipline ordering that Mr. Schomberg pay a civil penalty in the amount of \$5,000.00 for violation of N.J.S.A. 45:1-21 for providing false information in his letter, estimate, and invoice (\$2,500.00 will be active and \$2,500.00 will be suspended unless future complaints are received).

The Board also reviewed a letter received from the Electrical Subcode Official concerning the work performed.

Motion made by Mr. James H. Flaherty and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, to finalize the Provisional Order of Discipline and issue a Final Order of Discipline ordering that Mr. Schomberg pay a civil penalty in the amount of \$5,000.00 for violation of N.J.S.A. 45:1-21 for providing false information in his letter,

estimate, and invoice (\$2,500.00 will be active and \$2,500.00 will be suspended unless future complaints are received). The Board will allow Mr. Schomberg to pay his penalty in monthly \$500.00 installments.

Rachel Glasgow, Regulatory Analyst, appeared before the Board to discuss the following:

- a) Rule proposal concerning qualifications of applicants;
- b) Rule proposal to give blanket approval to organizations/associations to teach continuing education to licensees as long as the organization/association meets the Board's general guidelines;
- c) Notice of Pre-Proposal for N.J.A.C. 13:31-4.1 Limited Telecommunications Wiring Exemption;
- d) N.J.A.C. 13:31-1.8 "Address of record" states that the address of record shall not be a post office box; however, the application for examination states that a post office box may be used as an address of record, but only if the applicant provides another address which includes a street, city, state and Zip code.

Ms. Glasgow stated that the Notice of Pre-Proposal for N.J.A.C. 13:31-4.1 Limited Telecommunications Wiring Exemption was signed off by the Office of the Attorney General and she is awaiting a publication date in the New Jersey Register.

Ms. Glasgow also stated that in regards to the Telecommunications Wiring Exemption Proposal, the Board approved the proposed language at its April 2013 meeting. However, after a discussion with David Freed, we thought we should clarify some of the language.

Ms. Glasgow stated that she added the word "solely" to the language in N.J.A.C. 13:31-4.1(a) which would state:

Pursuant to N.J.S.A. 45:5A-18, the Board may grant an exemption from the license and business permit requirements of N.J.S.A. 45:5A-9(a) to a business engaged "solely" in telecommunications wiring.

Mr. Malec stated that the word solely should not be added to the language as the business could be performing other work that is considered exempt.

September 4, 2013

Mr. Flaherty stated that the words "qualifying employee" should be changed to "regular employee".

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Mitchell R. Malec, and unanimously passed, to accept the drafted proposed language, as amended, for N.J.A.C. 13:31-4.1 Limited Telecommunications Wiring Exemption.

Ms. Glaskow stated in regards to N.J.A.C. 13:31-2.1 Qualifications of Applicants, she has drafted language to make it clear that the qualifications cannot include low voltage work with a potential of less than ten volts and the applicant must have at least 1800 hours of practical hands-on experience. An applicant who completes more than 1800 hours during a one year period may not carry the excess hours over to the next year. Additionally, if an applicant cannot obtain a Work Experience Certification from his or her employer, the applicant may submit a W-2 income tax form.

After a brief discussion, the Board requested that the approval of the proposed language be tabled pending further discussion.

Mr. Schooley requested that Mr. Malec and Mr. Flaherty draft language regarding the qualifications of applicants.

Ms. Glaskow stated that she is drafting language in regards to N.J.A.C. 13:31-1.7 Continuing Education Requirements. Ms. Glaskow asked whether or not the Board wants to approve only courses offered by the Department of Community Affairs or are there other providers that would be accepted by the Board.

After a brief discussion, the Board requested that the approval of the proposed language be tabled pending further discussion.

Ms. Glaskow stated David Freed found inconsistencies between the language reflected in N.J.A.C. 13:31-1.8 "Address of Record" which states that the address of record shall not be a post office box; however, the application for examination states that a post office box may be used as an address of record, but only if the applicant provides another address which includes a street, city, state and zip code.

September 4, 2013

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that the language be changed to reflect that a post office box address can be used by licensees as long as a street address is also provided by the licensee.

Signed cease and desist agreement received from Herbert McGrath, Seaside Park, New Jersey.

The Board accepted the signed cease and desist agreement.

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Fifteen (15) applications were approved.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. James H. Flaherty, and unanimously passed, to go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred.

The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.

Meeting adjourned at 3:00 P.M.
