The Board reviewed an application for Continuing Education Course/Seminar Approval received from Eric DeGesero, NJ Independent Electrical Contractors (NJIEC).

The Board held in abeyance the approval of the courses entitled "The BIZ Success Blueprint for Contractors (Part 1)" and "The BIZ Success Blueprint for Contractors (Part II)" pending receipt of a more detailed course description as the course description provided for the two courses was the same. The Board also requested clarification as to the name of the instructor teaching the course entitled "Demystifying The "Smart Grid" - Opportunities in Building The Next Generation of Energy

Infrastructure” as the name listed in the course description is not the name listed as the instructor. Additionally, Mr. DeGesero was advised that the Board does not approve half hour courses. Therefore, the courses listed for 1.5 hours were approved as one hour courses unless Mr. DeGesero can substantiate a two hour course.

Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that the courses entitled “The BIZ Success Blueprint for Contractors (Part 1)”; “The BIZ Success Blueprint for Contractors (Part II)”; and “Demystifying The “Smart Grid” - Opportunities in Building The Next Generation of Energy Infrastructure” are approved along with its instructors.

Ronchi, License #12230, t/a Jason Electric, Inc., to the Provisional Order of Discipline filed June 6, 2012, ordering that Mr. Ronchi pay a civil penalty in the amount of \$1,000.00 for violation of N.J.A.C. 13:45C-1.2; License and Business Permit #12230 is provisionally suspended until such time as he respond to the Board; and a public reprimand is provisionally imposed.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to go into Executive Closed Session to discuss this matter.

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that Joseph Donofrio, Deputy Attorney General, finalize the Provisional Order of Discipline and issue a Final Order of Discipline ordering that Mr. Ronchi pay a civil penalty in the amount of \$1,000.00 for violation of N.J.A.C. 13:45C-1.2 and impose a public reprimand. Mr. Ronchi’s license and business permit will not be suspended as he responded to the complaint.

September 5, 2012

The Board reviewed a response received from Robert T. Brown, License #10584, t/a R T Brown Electrical Contracting, Inc., to the Provisional Order of Discipline filed July 11, 2012, ordering that Mr. Brown pay a civil penalty in the amount of \$2,500.00 for violation of N.J.A.C. 13:31-1.7 (b & c) for failing to complete the ten hour course of study. Mr. Brown was granted three months in order to attend the nine hours of code changes and the one hour of Laws, Rules, and Regulations.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Mitchell R. Malec, and unanimously passed, to go into Executive Closed Session to discuss this matter.

After a discussion in Closed Session, the following motion was made.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, that Joseph Donofrio, Deputy Attorney General, finalize the Provisional Order of Discipline and issue a Final Order of Discipline ordering that Mr. Brown pay a civil penalty in the amount of \$2,500.00 for violation of N.J.A.C. 13:31-1.7 (b & c) and impose a public reprimand for failing to complete the ten hour course of study. Mr. Brown completed the required nine hours of code changes and the one hour of Laws, Rules, and Regulations by August 31, 2012. Mr. Brown may pay his civil penalty in \$200.00 monthly installments.

\*\*\*\*\*

The Board reviewed N.J.A.C. 13:45C-2.1 which was adopted on March 21, 2012, and published in the New Jersey Register on April 16, 2012, authorizing boards, committees, and units within the Division, pursuant to the standards and according to the requirements enunciated in the rules, to waive a specific regulatory requirement in circumstances specified in the subchapter where the grant of a waiver will not compromise the spirit and intent of the agency's statutory goals of providing consumer protection or pose a risk to the health, safety, or welfare of such boards, committees, and units to waive statutory requirements. A waiver under this subchapter shall not excuse a failure to obtain a license, permit, or other authorization required by ordinance, statute, or rule to be obtained from a unit within the Division or from another governmental agency.

Pursuant to N.J.A.C. 13:45C-2.3 a licensee or an applicant may apply to an agency for a waiver or relaxation of a specific regulatory requirement when strict compliance with that requirement would lead to an unfair, burdensome or incongruous result; would conflict with the rules of another agency; or would result in undue hardship, economic or otherwise, provided that the waiver or relaxation of the regulatory requirements would not unduly burden any affected parties, and that the waiver is consistent with the underlying purposes of the agency's laws and rules.

\*\*\*\*\*

Mr. McMullen stated that some towns require an electrical contractor to obtain a permit to install CSST (corrugated stainless steel tubing) gas piping and some towns do not.

September 5, 2012

Mr. Flaherty stated that the Board does not have jurisdiction over permitting issues; it can only advise its licensees to comply with the National Electrical code.

Mr. Schooley requested that this matter be placed on a future Agenda for discussion by the Board.

Darryl Gayton, License #11140, failed to respond to the Administrative Action Provisional Order of Discipline filed June 1, 2011, ordering that Mr. Gayton's License and Business Permit #11140 are provisionally suspended until such time as he responds to the complaint and is assessed a civil penalty in the amount of \$1,000.00 for violation of N.J.A.C. 13:45C-1.2.

Mr. Gayton has also failed to respond to a letter dated June 12, 2012, sent to him certified and regular mail requesting that he respond to the POD filed June 1, 2011. Certified mail returned "Unclaimed", regular mail not returned.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. James H. Flaherty, and unanimously passed, that Deputy Attorney General Joseph Donofrio finalize the Provisional Order of Discipline and issue a Final Order of Discipline ordering that Mr. Gayton's License and Business Permit #11140 are provisionally suspended until such time as he responds to the complaint and is assessed a civil penalty in the amount of \$1,000.00 for violation of N.J.A.C. 13:45C-1.2.

The Board reviewed documentation received from Gregory Martelli, License #15048, t/a GJM Electric, LLC, in response to the Provisional Order of Discipline ordering that Mr. Martelli be assessed a civil penalty in the amount of \$1,000.00 for violation of N.J.A.C. 13:45C-1.2 and provisionally suspend License #15048 until such time as Mr. Martelli cooperates with the Board.

Motion made by Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and unanimously passed, that Deputy Attorney General Joseph Donofrio finalize the Provisional Order of Discipline and issue a Final Order of Discipline ordering that Mr. Martelli be assessed a civil penalty in the amount of \$1,000.00 for violation of N.J.A.C. 13:45C-1.2.

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Sixteen (16) applications were approved.

Motion made by Mr. Joseph F.
