The Board saluted the Flag.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. James H. Flaherty, and unanimously passed, to approve the Minutes of the 765 Meeting held September 3, 2003, with a correction in Closed Session.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, to approve (18) Initial Licenses effective October 1, 2003 to March 31, 2003.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, to approve (18) of the (19) Initial Business Permits effective October 1, 2003 to March 31, 2006. (#2 is being held in abeyance pending further review)

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve (5) Initial Business Permits Previously Expired effective October 1, 2003 to March 31, 2006.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, to approve (3) Changes in Business Permits effective October 1, 2003 to March 31, 2006.

Check in the amount of \$25.00 received from Frank D@Arpa, License #8778, as the tenth installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started September 25, 2002 and the balance due is \$2,250.00.

The Board reviewed the Application for Reinstatement received from Richard Miller as he failed to renew his license #7385 for the 1991 to 1994; 1994 to 1997; 1997 to 2000; 2000 to 2003; and 2003 to 2006 triennial renewal periods.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that a letter be sent to Mr. Miller advising him that he must take and pass the written examination in order to regain his license. The Uniform Enforcement Act requires that five years after a license has expired, a licensee is not permitted to renew his/her license without first taking the qualifying examination. Mr. Miller will be directed to return his pressure seal issued to Fred Miller & Sons Electrical Contractors, Inc.

The Board reviewed the Application for Reinstatement received from Donald F. Todd, Sr. requesting reinstatement of his license #11051 which he failed to renew for the 1997 to 2000; 2000 to 2003 and 2003 to 2006 triennial renewal periods.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that a letter be sent to Mr. Todd advising him that he must take and pass the written examination in order to regain his license. The Uniform Enforcement Act requires that five years after a license has expired, a licensee is not permitted to renew his/her license without first taking the qualifying examination. Mr. Todd will be directed

to return his pressure seal issued to D F Todd Electrical Contractor, Inc.

Letter dated June 3, 2003, received on September 22, 2003, from Charles P. Bonicker, Jr., requesting a six-month continuance of business under permit #3984. The licensee, Earl Currey, died on April 18, 2003.

Mr. Bonicker, who is a partner of the company, stated that he has worked for Mr. Currey since 1994 and has sent in his application to take the electrical contractor's examination.
