

**825th BUSINESS MEETING OF THE BOARD OF EXAMINERS OF ELECTRICAL
CONTRACTORS
(PUBLIC SESSION) - - - OCTOBER 1, 2008**

The Board Minutes of October 1, 2008, have not been formally approved and are subject to change or modification by the Public Body at its next meeting of November 5, 2008, or soon thereafter as it may be considered. All requirements of the "Open Public Meetings Act" have been complied with according to N.J.S.A. 10:4-6.

The notice of the meeting has been mailed to the Newark Star Ledger, Camden Courier Post, and the Trenton Times, and also notice has been posted on the Bulletin Board at the office of the Secretary of State, Trenton, New Jersey.

Meeting of October 1, 2008, was called to order at 9:00 A.M.

Kathleen Moran, Administrative Assistant, III, was present from 9:00 A.M. until the close of the meeting.

Ginger R. Provost, Deputy Attorney General, Division of Law, was present from 9:00 A.M. until the close of the meeting.

Also in attendance was James Bibbo, Central Jersey Electrical League.

The Board saluted the Flag.

Motion made by Mr. James H. Flaherty and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, to approve the Open Session Minutes of the 823rd Meeting held August 6, 2008 with the following corrections.

Page 5, paragraph 10

13:31A-1.6 - the wording "the current renewal period, within three years prior to the date of application" is being added. Mrs. Sheehan stated that licensees who are going from "inactive" to "active" status will be required to attend the continuing education courses for the renewal for which they are becoming active.

Page 6, paragraph 9

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Thirty (30) applications were approved.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. James H. Flaherty, and unanimously passed, to approve (18) Initial Business Permits effective October 1, 2008 to March 31, 2009.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. James H. Flaherty, and unanimously passed, to approve (17) Initial Business Permits effective October 1, 2008 to March 31, 2009.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. James H. Flaherty, and unanimously passed, to approve (5) Initial Business Permits Previously Expired effective October 1, 2008 to March 31, 2009.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. James H. Flaherty, and unanimously passed, to approve (8) Changes in Business Permits effective October 1, 2008 to March 31, 2009.

DAG Provost advised the Board that she has been informed that there is a state wide program for debt collection. Therefore, before Provisional Orders of Discipline are drafted, she must first ascertain whether or not the outstanding penalties of electrical contractors have been sent for collection.

Check in the amount of \$25.00 received from Frank D'Arpa, License #8778 as the thirty-eighth installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started September 25, 2002 and the balance due is \$1,550.00.

The Board accepted the payment.

Check in the amount of \$5,000.00 received from Peter Gioello, License #9669, as the first and final payment in the amount of \$5,000.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq.

The Board accepted the payment.

The sub-committee reviewed additional information received from Lawrence H. Kosden concerning his application for Continuing Education Course Seminar approval. The Committee had previously requested that Mr. Kosden provide a detailed course description for each subject matter.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that five (5) new courses, and instructors, are approved as submitted.

The sub-committee reviewed an application for Continuing Education Course Seminar approval received from Joe Swanson, Swanson Consulting.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that four (4) new courses, and instructor, are approved as submitted.

The sub-committee reviewed an application for Continuing Education Course Seminar approval received from Thomas McNulty, Penn-Del-Jersey Chapter, NECA.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that one (1) new course, and instructor, is approved as submitted.

The sub-committee reviewed an application for Continuing Education Course Seminar approval received from Tom Pernal.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that four (4) new courses, and instructor, are approved as submitted.

The sub-committee reviewed an application for Continuing Education Course Seminar approval received from Richard F. Van Wert, Electric Education Center.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that four (4) new courses, and instructor, are approved as submitted. The course entitled "Exam

Prep for License Exam" is denied as it does not meet the guidelines of Continuing Education.

The sub-committee reviewed an application for Continuing Education Course Seminar approval received from Christina Bailey, American Trainco, Inc.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that one (1) new course, and instructors, are approved as submitted.

Letter dated August 11, 2008, received from William Capodanno, License #2199, t/a Capodanno Electric, requesting a waiver of the Continuing Education Courses for the 2009 to 2012 renewal period pursuant to N.J.A.C. 13:31-1.7.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, that a letter be sent to Mr. Capodanno advising him that his request is being held in abeyance. The Board would like to know from Mr. Capodanno whether or not he has an active business; if so, does he supervise the work being performed. If Mr. Capodanno does not supervise the work being performed, he is to provide the Board with the name of the qualified journeyman supervising the work being performed. The Board would also like to know how many employees Mr. Capodanno has.

Letter dated September 11, 2008, received from Marty Ryan, Associate Vice Chancellor for Facilities, Rutgers University, on behalf of Ronald Patrick, License #13182 and Eugene Medaglia, License #8782. Mr. Ryan stated that Messrs. Patrick and Medaglia are attempting to reinstate their license for the triennial renewal period of April 1, 2006 to March 31, 2009; however, they have been unable to find the continuing education courses required for that renewal period.

Motion made by Mr. James H. Flaherty and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that Ronald Patrick, License #13182 and Eugene Medaglia, License #8782 be reinstated with the payment of the proper fees. Messrs. Patrick and Medaglia will be advised that the Board will accept the 34 hours of continuing education courses that they have already attended towards the renewal of their license for the 2006 to 2009 renewal. Therefore, they must attend another 34 hours of continuing education courses for their 2009 to 2012 triennial license renewal.

Signed cease and desist agreements were received from Michael Parisi, Wall, New Jersey; John and Mary Budge, Matawan, New Jersey; Edward King, Marmora, New Jersey; Herber and Gladys Villaizan, Fair Lawn, New Jersey; Ron Barca, t/a Master Handyman, Toms River, New Jersey, agreeing to include the language in their advertisement that all electrical work is "performed by licensed electrical contractors". Signed cease and desist agreement received from Peter J. Gioello, License #9669.

The Board accepted the signed cease and desist agreements.

The Board discussed the penalty amounts to be issued to licensees who do not have the correct amount of Continuing Education hours required to renew his/her license for the 2006 to 2009 triennial renewal period. The Board also discussed instructors who have not followed continuing education guidelines. The Board reviewed the draft prepared by Mr. Malec.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Mitchell R. Malec, and unanimously passed, that a civil penalty in the amount of \$62.50 be assessed against a licensee for each continuing education credit not taken.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that a civil penalty in the amount of \$2,500.00 be assessed against a licensee who has falsified their renewal.

Motion made by Mr. James H. Flaherty and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that a civil penalty in the amount of \$100.00 be assessed against a licensee who has not provided

the necessary documentation in response to the audit.

DAG Provost stated that Settlement Letters will be drafted. Failure to pay the penalty will result in the automatic suspension of the license until the penalty is satisfied. Additionally, the license will not be renewed until the licensee satisfies the terms of the order. The licensee will have six months to attend the courses not taken.

DAG Provost also stated that licensees who fail to comply with the Order must return the seal and notify the business to which the business permit is endorsed.

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Twenty-eight (28) applications were approved.

At its Special Meeting held July 16, 2008, the Board reviewed applications for the written examination to be administered by Thomson Prometric. Twenty-one (21) applications were approved.

At its Special Meeting held September 17, 2008, the Board reviewed applications for the written examination to be administered by Thomson Prometric. Thirteen (13) applications were approved.

Motion made by Mr. James H. Flaherty and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that the Board go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
