

**802 BUSINESS MEETING OF THE BOARD OF EXAMINERS OF ELECTRICAL CONTRACTORS  
(PUBLIC SESSION) - - - OCTOBER 4, 2006**

The Board Minutes of October 4, 2006, have not been formally approved and are subject to change or modification by the Public Body at its next meeting of November 1, 2006. All requirements of the "Open Public Meetings Act" have been complied with according to N.J.S.A. 10:4-6.

The notice of the meeting has been mailed to the Newark Star Ledger, Camden Courier Post, and the Trenton Times, and also notice has been posted on the Bulletin Board at the office of the Secretary of State, Trenton, New Jersey.

Meeting of October 4, 2006, was called to order at 9:00 A.M.

Marian Fiore, Sr. Management Assistant, was present from 9:00 A.M. until the close of the meeting.

Kathleen Moran, Administrative Assistant, III, was present from 9:00 A.M. until the close of the meeting.

Ginger R. Provost, Deputy Attorney General, Division of Law, was present from 9:00 A.M. until the close of the meeting.

Also in attendance was James Bibbo, Central Jersey Electrical League.

The Board saluted the Flag.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve the Minutes of the 800 Meeting held August 2, 2006.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve the Minutes of the 801 Meeting held September 6, 2006, with the following correction:

Page 6, paragraph 4:

The word Blackberries should have been capitalized.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve (15) Initial Licenses effective October 4, 2006, 2006 to March 31, 2009.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to approve (17) Initial Business Permits effective October 4, 2006 to March 31, 2009.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed,

to approve (5) Initial Business Permits Previously Expired effective October 4, 2006 to March 31, 2009.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to approve (3) Changes in Business Permits effective October 4, 2006 to March 31, 2009.

Check in the amount of \$100.00 received from Michael Delli Santi, Unlicensed, as the tenth installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started November 29, 2005 and the balance due is \$1,400.00.

The Board accepted the payment.

Check in the amount of \$25.00 received from Nick Ortense, Unlicensed, as the twelfth installment of a civil penalty in the amount of \$1,000.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started October 18, 2005 and the balance due is \$675.00.

The Board accepted the payment.

Check in the amount of \$500.00 received from Casey Morton, Unlicensed, as the seventh installment of a civil penalty in the amount of \$6,000.00 for violation of N.J.S.A. 45:5A-9. Payments started January 26, 2006 and the balance due is \$1,500.00.

The Board accepted the payment.

Check in the amount of \$50.00 received from Vernon Walderon, Unlicensed, as the fourth installment of a civil penalty in the amount of \$500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started July 17, 2006 and the balance due is \$300.00.

The Board accepted the payment.

Check in the amount of \$1,000.00 received from James M. Celestino, License #8456, t/a MMSI, as the first and final installment of a civil penalty in the amount of \$1,000.00.

The Board accepted the payment.

Check in the amount of \$2,500.00 received from Philip DeAngelo, Unlicensed, t/a Utility Refunds of NJ Inc., as the first and final installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq.

The Board accepted the payment.

Letter dated September 15, 2006, received from Michael Cohen requesting a second six-month continuance of business under permit #206 according to N.J.S.A. 45:5A-14. The licensee, Eli Cohen, died March 20, 2006. The first extension expires on October 13, 2006.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that a letter be sent to Mr. Cohen advising him that the Board has granted the firm of Shack Electric, Inc. a second six-month continuance of Business Permit #206 according to N.J.S.A. 45:5A-14.

The Board reviewed an application for reinstatement received from Alfred T. Brouillard, Sr., as he failed to renew his License #4945 for the 1997 to 2000; 2000 to 2003; 2003 to 2006 and 2006 to 2009 triennial renewal periods.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, that a letter be sent to Mr. Brouillard advising him that he must take and pass the written examination in order to regain his license pursuant to the Uniform Enforcement Act which requires that five years after a license has expired a licensee is not permitted to renew his/her license without first taking the qualifying examination.

Additionally, a letter is to be sent to Robert Frangipane, Continuing Education Course Instructor, advising him that it is his responsibility to ensure that the individuals who are attending his class have a current license. Additionally, Mr. Frangipane is to be advised that any changes made by him on a certificate issued to an attendee should be initialed. Mr. Frangipane is to be further advised that if there is more than one instructor teaching the course, then all instructors should sign the certificate.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from A. Alan Chech.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that (5) new courses, and instructors, are approved as submitted. The previously approved courses are also approved.

The sub-committee reviewed a letter received September 20, 2006, from James J. McGlynn requesting approval to add two new instructors to teach previously approved Continuing Education Course/Seminars.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that Mr. McGlynn's request to add two new instructors to previously approved courses is approved.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Joseph J. Bevacqua.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Mitchell R. Malec, and unanimously passed, that (12) new courses, and instructors, are approved as submitted. The previously approved courses are also approved with the requested changes.

Maryann Sheehan, Regulatory Analyst, discussed a draft of the Board's Rules which will Sunset on May 2, 2007 and a draft of the Qualified Journeyman Electrician.

Mrs. Sheehan stated the regulations will impose a registration for the Qualified Journeyman Electrician who will be required to pay a triennial renewal fee and attend continuing education courses. Mrs. Sheehan also stated that originally the registration was only for those individuals who were exempt from the Board's licensing laws under N.J.S.A. 45:5A-18 (k). We have since amended that language to include those people who are to supervise electrical work being performed pursuant to N.J.A.C. 13:31-3.4.

DAG Provost requested that the word "valid" be added to 13:31-5.1(a1) as such:

Holds a current valid active license to practice electrical contracting issued by the Board.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that the Board approves the draft of N.J.A.C. 13:31-1.2 "Qualified Journeyman Electrician" with a couple of minor corrections.

The Board also discussed a draft of the Board's Rules which will Sunset on May 2, 2007.

Mrs. Sheehan stated that there are no major changes in the rules. Mrs. Sheehan also stated that the cost of the initial and replacement pressure seal has been changed to \$25.00.

Mr. McCullough requested that language be added to N.J.A.C. 13:31-1.7 to reflect that the sponsor pay the \$100.00 fee each submission or modification to a course offering, including but not limited to hours, instructors, or any such change.

Mr. Schooley requested that the words for a business be added to N.J.A.C. 13:31-1.8 ( c & d) and to N.J.A.C. 13:31-2.4 ( c ) after the wording "qualifying license".

DAG Provost requested that the following language be added to N.J.A.C. 13:31-2.2 (a)

or any such company approved by the Board.

Mrs. Sheehan asked what is required of a licensee who is seeking reinstatement of his license more than five years after suspension/expiration.

Mr. Schooley stated that the Board abides by the Uniform Enforcement Act which requires that five years after a license has expired a licensee is not permitted to renew his/her license without first taking the qualifying examination.

Mrs. Sheehan stated that she will add a section that indicates same.

Mr. McCullough requested that the language Electrical Subcode be deleted from N.J.A.C. 13:31-3.4 (a) but keep the language Uniform Construction Code.

Mr. McCullough requested that the language Electrical Subcode be deleted from N.J.A.C. 13:31-3.4(b 1); (d 1) and (d 2).

DAG Provost requested that in N.J.A.C. 13:31-3.6 (b) the following language be deleted or may result in the taking of other disciplinary action against and the language be changed to read or may result in any other such disciplinary action

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, that the Board approves the draft of its Sunset Rules with the changes as reflected.

Signed cease and desist agreement received from Philip DeAngelo, Fairfield, New Jersey; Mark Molina, Union City, New Jersey and Mark Rodio, Hammonton, New Jersey.

The Board accepted the signed cease and desist agreements.

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Twelve (12) applications were approved.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that the Board go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
