October 6, 2010

Motion made by Mr. James H. Flaherty and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, to approve (57) Initial Licenses effective October 6, 2010 to March 31, 2012.

The sub-committee reviewed an application for Continuing Education Course/Seminar Approval received from Mervin Munoz, IEC Chesapeake.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. James H. Flaherty, and unanimously passed, to approve three (3) new courses and instructors.

The sub-committee reviewed an application for Continuing Education Course/Seminar Approval received from Brian Mitchell, Construction Training Service.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. James H. Flaherty, and unanimously passed, to approve one (1) new course and instructors, and previously approved courses.

Letter dated September 23, 2010, received from Dennis R. Fields, License #9249, requesting that the State of New Jersey join the Multi State Reciprocal Licensing Group. Mr. Fields stated that the New Jersey requirements exceed the requirements necessary to belong to the licensing group.

Motion made by Mr. James H. Flaherty and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that a letter be sent to Mr. Fields advising him that the Board does not have the statutory authority to enter into a reciprocal agreement with any other state.

Signed cease and desist agreements received from Richard Gapin, Mount Laurel, New Jersey and Troy T. McMahon, Toms River, New Jersey.

The Board accepted the signed cease and desist agreements.

Mr. Dubyna stated that the Electrical Contractors of New Jersey is a new organization and representatives will attend the Open Session portion of the Board meetings.

Charles Manning, Regulatory Analyst, Division of Consumer Affairs, appeared before the Board to discuss language regarding the scope of practice of master HVACR Contractors.

After reviewing the drafted language, the Board felt that it should further discuss the safety concerns regarding work performed in commercial buildings.

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Fourteen (14) applications were approved.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that the Board go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
