

The sponsor shall resubmit to the Board the documentation and continuing education sponsor fee set for in N.J.A.C. 13:31-1.7 (h 2 & 5). If there are no changes in course content, hours of instruction, or course lecturer for a previously approved course or program, the sponsor shall not be required to reapply to the Board for approval prior to offering the course or program in a subsequent renewal period.
