Mrs. Beggs stated that the first available test date for her son to take the electrical contractor's examination is January 4, 2010.

Office files reflect that Beggs Electrical Contractors has been granted two six-month extensions and one three-month extension.

Cantalupo, and unanimously passed, that a letter be sent to Mrs. Beggs advising her that pursuant to N.J.S.A. 45:5A-14 the firm of Beggs Electrical Company has been granted an additional six-month continuance of business under permit #1789.

Letter dated December 1, 2009, received from Pamela R. Kowitski, PKR Electrical Contractors, Inc., requesting a second six-month continuance of business under Permit #7731 according to N.J.S.A. 45:5A-14. The licensee, Robert G. Kowitski, died on May 16, 2009.

Mrs. Kowitski stated that her son, Anthony, has submitted his application for approval to take the electrical contractor's examination in April 2010.

December 2, 2009

Motion made by Mr. James H. Flaherty and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that a letter be sent to Mrs. Kowitzki advising her that pursuant to N.J.S.A. 45:5A-14 the firm of PKR Electrical Contractors, Inc. has been granted a second six-month continuance of business under Permit #7731.

The Board reviewed a memorandum dated November 23, 2009, received from Darlene Kane, Budget Officer, Division of Consumer Affairs, stating that for the first quarter of Fiscal Year 2010, the Electrical Board/Committee was directly billed for 126.5 hours of Deputy Attorney General/Paralegal services totaling \$18,721.68.

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Sixteen (16) applications were approved.

David Melton, applicant, appeared before the Board to advise that he submitted his application to take the electrical contractor's examination more than one year ago and has not been notified as to whether or not he is approved to take the examination.

Mr. Schooley advised Mr. Melton that the Board will review his application and he will be informed of its decision as soon as possible.

Mr. Melton thanked the Board for their assistance.

At the October 21, 2009, meeting the Committee unanimously recommended that DAG Donofrio finalize the Provisional Order of Discipline and issue a Final Order of Discipline ordering that Michael Stallone pay a civil penalty in the amount of \$1,500.00 for violation of N.J.S.A. 45:5A-13.1 and N.J.A.C. 13:31-1.7(b & c) for failing to complete the ten hour course of study and a public reprimand is imposed for violation of N.J.S.A. 1-21 (h), N.J.S.A. 45:5A-13.1 and N.J.A.C. 13:31-1.7(a, b & c et seq).

Motion made by Mr. Constantinos Papademas and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that a Final Order of Discipline be drafted rescinding the Provisional Order of Discipline as Mr. Stallone submitted the correct Continuing Education certificates. Mr. Stallone will be sent a Letter of Caution for his failure to provide documentation to substantiate that he attended the required 34 hours of Continuing Education Courses.

December 2, 2009

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, that the Board go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
