

**827TH BUSINESS MEETING OF THE BOARD OF EXAMINERS OF ELECTRICAL
CONTRACTORS
(PUBLIC SESSION) - - - DECEMBER 3, 2008**

Meeting of December 3, 2008, was called to order at 9:00 A.M. The following members were present:

Ginger R. Provost, Deputy Attorney General, Division of Law, was present from 9:00 A.M. until the close of the meeting.

Miguel Dominguez, Intern, Division of Law, was present.

Also in attendance were James Bibbo and Robert Jules, Central Jersey Electrical League.

The Board saluted the Flag.

The Board was notified by the Division that Barbara A. Cook, Executive Director, passed away on December 2, 2008.

Mr. Richard T. Aicher, Jr. abstained from the following motion as he was not in attendance for the 824th Meeting.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and passed, to approve the Minutes of the 824th Business Meeting held September 3, 2008, with the following corrections:

Page 3, paragraph 8

Mr. McCullough's name was misspelled.

Page 4, paragraph 10

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that four (4) new courses, and instructor, are approved as submitted.

Mr. Robert A. McCullough abstained from the following motion as he was not in attendance for the 825th

Meeting.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. James H. Flaherty, and passed, to approve the Minutes of the 825th Meeting held October 1, 2008, with the following corrections:

Page 2, paragraph 10

DAG Provost advised the Board that she has been informed that there is a state wide program for debt collection. Therefore, before Provisional Orders of Discipline are drafted, for individuals who have outstanding fines imposed by the Board, she must first ascertain whether or not the outstanding penalties of electrical contractors have been sent for collection.

Page 5, paragraph 6

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that a civil penalty in the amount of \$2,500.00 be assessed against a licensee who has falsified their renewal by stating that they did complete all continuing education requirements when they had not done so.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. James H. Flaherty, and unanimously passed, to approve the 826th Business Meeting held November 5, 2008, with the following correction:

Page 5, paragraph 2

Mr. Belko stated that Mr. Kaminskis is still supervising the work being performed.

Mr. James H. Flaherty, Mr. Mitchell R. Malec and Mr. Robert A. McCullough abstained from the motion as they were not in attendance at the Special Meeting held October 15, 2008.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Richard T. Aicher, Jr., and passed, to approve the Minutes of the Special Meeting held October 15, 2008, with the following corrections:

Page 2, paragraph 4

DAG Provost recommended to the Board that the lower penalty amount be imposed by a Consent Order to those licensees who do not have the correct amount of Continuing Education hours required to renew his/her license for the 2006 to 2009 triennial renewal period.

Page 2, paragraph 5

Motion made by Mr. Richard T. Aicher and seconded by Mr. Constantinos Papademas, and unanimously passed, that in regards to the continuing education audit, penalties issued in the amount of \$1,500.00 or less be handled first by a Consent Order. If no agreement is reached, a Provisional Order of Discipline will be issued.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. James H. Flaherty, and unanimously passed, to approve (27) Initial Licenses effective December 3, 2008 to March 31 2009.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. James H. Flaherty, and unanimously passed, to approve (22) Initial Business Permits effective December 3, 2008 to March 31, 2009.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve (2) Initial Business Permits Previously Expired effective December 3, 2008 to March 31, 2009.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to approve (13) Changes in Business Permits effective December 3, 2008 to March 31, 2009.

Check in the amount of \$25.00 received from Frank D'Arpa, License #8778, as the fortieth installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started September 25, 2002 and the balance due is \$1,500.00.

The Board accepted the payment.

Postal Money Order in the amount of \$100.00 received from James Gandy, Unlicensed, as the nineteenth installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.A.C. 13:31-3.3. Payments started May 25, 2007 and the balance due is \$600.00.

The Board accepted the payment.

Check in the amount of \$1,000.00 received from Tom Iaione, License #9256, t/a Iaione Electric, Inc., as the first and final payment of a civil penalty in the amount of \$1,000.00 for violation of N.J.A.C. 13:31-3.2 and N.J.A.C. 13:45C-1.2 and 1.3. Restitution check also received Mr. Iaione in the amount of \$200.00 made payable to David Ritter.

The Board accepted the payment.

Check in the amount of \$100.00 received from William Rivera, Unlicensed, as the first and final payment of a civil penalty in the amount of \$100.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq.

The Board accepted the payment.

Letter dated November 24, 2008, received from Claude Pavia, President, Knight Electric, Inc., requesting a six-month continuance of business under Permit #6768 according to N.J.S.A. 45:5A-14. The licensee, Chester R. White, Jr., died on September 23, 2008.

Motion made by Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and unanimously passed, that a letter be sent to Mr. Pavia advising him that pursuant to N.J.S.A. 45:5A-14 the firm of Knight Electrical, Inc. has been granted a six-month continuance of business under permit #6768. Mr. Pavia will be advised that the extension will commence September 24, 2008.

Signed cease and desist agreement received from William Rivera, Pennsauken, New Jersey. Signed cease and desist agreements received from Alex Kye, Pennington, New Jersey; Waldo Alvarado, t/a Washington Construction, Orange, New Jersey; Peter LaLima, t/a Best Horticulture Services, Marlboro, New Jersey and Sharon Tai, t/a TJKB Kitchen & Bath, Ocean, New Jersey, agreeing to include the language in their advertisement that all electrical work is "performed by licensed electrical contractors".

The Board accepted the signed cease and desist agreements.

Maryann Sheehan, Regulatory Analyst, Director's Office, appeared before the Board to discuss amending the journeyman regulations to require that journeyman training is consistent with National Electrical Code standards.

Mrs. Sheehan stated that all of the changes requested by the Board were accepted. Mrs. Sheehan also stated that the only change not accepted was the language reflecting that the work performed by Journeyman Electricians had to be done in compliance with the National Electrical Code.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, that a proposal be drafted to amend N.J.A.C. 13:31-1.2 to require that a Qualified Journeyman Electrician acquire the 8,000 hours of practical experience working with tools in the installation, alteration, or repair of wiring for electric light, heat or power, which work shall have been done in compliance with the National Electrical Code.

A letter dated November 15, 2008, was received from Wally Spergel, License #4775, requesting a waiver of the Continuing Education Courses pursuant to N.J.A.C. 13:31-1.7(g).

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. Mitchell R. Malec, and unanimously passed, that Mr. Spergel's request be denied. The Board suggests that Mr. Spergel renew his license as Inactive.

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Seven (7) applications were approved.

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that the Board go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
