

**792 BUSINESS MEETING OF THE BOARD OF EXAMINERS OF ELECTRICAL CONTRACTORS  
(PUBLIC SESSION) - - - DECEMBER 7, 2005**

The Board Minutes of December 7, 2005, have not been formally approved and are subject to change or modification by the Public Body at its next meeting of January 4, 2006. All requirements of the "Open Public Meetings Act" have been complied with according to N.J.S.A. 10:4-6.

Meeting of December 7, 2005, was called to order at 9:00 A.M. The following members were present:

Barbara A. Cook, Executive Director, was present from 9:00 A.M. until the close of the meeting.

Alok Jain, Personal Assistant for the Executive Director, was present from 9:00 A.M. until the close of the meeting.

Marian Fiore, Sr. Management Assistant, was present from 9:00 A.M. until the close of the meeting.

Kathleen Moran, Secretarial Assistant, III, was present from 9:00 A.M. until the close of the meeting.

Susan Carboni, Deputy Attorney General, Division of Law, was present from 9:00 A.M. until the close of the meeting.

The Board saluted the Flag.

Motion made by Mrs. Gail Best and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to approve the Minutes of the 791 Meeting held November 2, 2005, with one correction in Open Session and one correction in Closed Session.

Page 5 paragraph 7 (last sentence)

The proposal would allow supplying service to a new installation, but the BPU proposal prohibits the electric company from servicing that equipment.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve (37) Initial Licenses effective December 7, 2005 to March 31, 2006.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve (25) Initial Business Permits effective December 7, 2005 to March 31, 2006.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve (3) Initial Business Permits Previously Expired effective December 7, 2005 to March 31, 2006.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve (7 of 8) Changes in Business Permits effective December 7, 2005 to March 31, 2006. (#1 is being held in abeyance pending further review)

Check in the amount of \$300.00 received from John J. Helmstetter, License #7192, as the seventeenth installment of a civil penalty in the amount of \$7, 500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started June 7, 2004 and the balance due is \$2,400.00.

The Board accepted the payment.

Check in the amount of \$25.00 received from Frank D'Arpa, License #8778, as the thirty-third installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started September 25, 2002 and the balance due is \$1,675.00.

The Board accepted the payment.

Check in the amount of \$25.00 received from Nick Ortense, Unlicensed, as the second installment of a civil penalty in the amount of \$1,000.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started October 18, 2005 and the balance due is \$950.00.

The Board accepted the payment.

Postal Money Order in the amount of \$500.00 received from Frank Chaba, Unlicensed, as the first and final installment of a civil penalty in the amount of \$500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq.

The Board accepted the payment.

Check in the amount of \$250.00 received from Joseph Melius, License #15245, as the first and final installment of a civil penalty in the amount of \$250.00 for violation of N.J.S.A. 45:5A-9.

The Board accepted the payment.

Personal Money Order received from Albert P. Jackson, License #9852, as the first and final installment of a civil penalty in the amount of \$500.00 for violation of N.J.S.A. 13:45A-16.2(12) and N.J.A.C. 13:31-1.5(b).

The Board accepted the payment.

Check in the amount of \$200.00 received from Michael Delli Santi, Unlicensed, as the first installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1. The balance due is \$2,300.00.

The Board accepted the payment.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Kevin Martin requesting approval of new courses.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Mitchell R. Malec, and unanimously passed, that Mr. Martin's request be held in abeyance pending confirmation as to who will be teaching the Power Point presentations and receipt of outlines for the courses entitled "NFPA 72 Fire Alarm Code" and "Review of the Uniform Fire Code".

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from

Eric J. Sivertsen, Sponsor #24, requesting approval of new courses.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Mitchell R. Malec, and unanimously passed, that the following courses, and instructors, are approved as submitted.

"Pre-Construction Planning Process"

"Earned Value Analysis"

"Ideal Jobsite Inventory Levels"

"Impact Assessment of Liability Insurance Problems for Contractor Businesses"

"Workers Compensation Experience Modification Rating - Review and Issues"

Additionally, Mr. Sivertsen's request to change instructors for previously approved courses is approved along with his request to amend a course name.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Merle Margolese requesting approval of new courses.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Mitchell R. Malec, and unanimously passed, that the following courses, and instructors, are approved as submitted.

"A-Count-Ability"

"Unlocking the Secrets to Growing Your Business"

"Lets Get Organized"

"Telephone Technique"

The sub-committee reviewed Lawrence S. Cross', III, request to include an additional instructor to teach the nine hours of code changes and the one hour of laws, rules, and regulations, under his sponsorship.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Mitchell R. Malec, and unanimously passed, to approve Dennis Campbell to teach the Nine Hours of Code Changes and the One Hour of Laws, Rules, and Regulations.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Brian DeGuevara requesting approval of new courses.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Mitchell R. Malec, and unanimously passed, that the following courses, and instructors, are approved as submitted.

"OSHA 10 Hour Safety and Health Course" 10 hrs (not 15) DeGuevara Safety "OSHA 30 Hour Safety and Health Course " 30 hrs (not 36) Safety

The sub-committee reviewed Anthony T. Urbanik's, Sponsor #011, request to expand the approved five hour course entitled "NEC Article 250 Grounding" to a ten hour course.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Mitchell R. Malec, and unanimously passed, that a letter be sent to Mr. Urbanik advising him that his request is being held in abeyance pending a more detailed course outline.

Motion made by Mr. Richard T. Aicher, Jr. And seconded by Mr. Robert A. McCullough, and unanimously passed, that all requests for continuing education courses must be submitted on the Application for Continuing Education Course/Seminar Approval.

Letter dated October 28, 2005, received from Thomas E. Pernal, Sponsor #052, requesting to be granted 15 credits towards his 2006 to 2009 triennial renewal pursuant to N.J.A.C. 13:31-1.7.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that a letter be sent to Mr. Pernal advising him that his request is being held in abeyance pending clarification as to whether or not these courses are new pursuant to N.J.A.C. 13:31-1.7(d 2). Additionally, Mr. Pernal will be requested to submit his request when he has taught all of the courses he is requesting credit for as it does not appear that Mr. Pernal has taught 18 classroom hours as stipulated.

Letter dated October 25, 2005, received from Frank R. Dudis, Esq., License #7417, requesting to be granted 15 credits towards his 2006 to 2009 triennial renewal pursuant to N.J.A.C. 13:31-1.7.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Mitchell R. Malec, and unanimously passed, that a letter be sent to Mr. Dudis advising him that his request is being held in abeyance pending receipt of the sign-in sign-out sheets. Additionally, Mr. Dudis will be requested to clarify whether or not these courses are new pursuant to N.J.A.C. 13:31-1.7(d 2) and were the courses taught exclusively for ITA.

Memorandum dated November 14, 2005, received from Darlene Kane, Budget Officer, Division of Consumer Affairs, stating that for the first quarter of Fiscal Year 2006 the board/committee was directly billed for 208.7 hours of Deputy Attorney General/Paralegal services totaling \$25,342.01.

Mrs. Cook stated that DAG Carboni has focused a considerable amount of time on specific Board matters; therefore, the Division's charges have increased.

DAG Carboni stated that the Division is spending more time on unlicensed practice cases. DAG Carboni also stated that she and Deputy Attorney General Susan Berger are working together.

Mrs. Cook stated that there are approximately 17 unlicensed practice cases. Mrs. Cook also stated that in the past, some of the cases were too old to be prosecuted and the Association, along with the individual licensed electrical contractors, are questioning what the Board is doing about unlicensed practice.

DAG Carboni stated that when the Board has received two complaints against an unlicensed contractor, the Division considers them a bit more significant. DAG Carboni also stated that the names of the unlicensed contractors are also referred to the Home Improvement Contractors Division requesting that they can flag their file should the contractor apply for a Home Improvement Contractor's Registration.

The Board reviewed the proposed amendment N.J.A.C. 5:23-3.16 of the Department of Community Affairs to adopt the 2005 National Electrical Code.

The Board also reviewed the Department of Community Affairs' adopted amendment N.J.A.C. 5:23-3.4 which lists the enforcement responsibilities of the adopted subcodes.

Mr. McCullough stated that the 2005 National Electrical Code will be adopted on January 6, 2006.

Letter dated November 28, 2005, received from Joseph Pavich requesting the Board's opinion as to whether or not he is required to obtain a Telecommunications Wiring Exemption for the installation of a satellite television system. Mr. Pavich states that he uses regular television antennas and small dishes (30") to receive television channels.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that a letter be sent to Mr. Pavich advising him that pursuant to N.J.S.A. 45:5A-18(j) any work with a potential of less than ten (10) volts does not require the securing of a business permit. Additionally, it is the opinion of the Board that Mr. Pavich would not be required to obtain a Telecommunication Wiring Exemption Card as the work his company performs does not come under the definition of Telecommunications Wiring. The Board requested that a copy of this letter be sent to the Township of Randolph.

Mrs. Cook advised the Board that she and Mr. Schooley, Mr. McCullough, Mr. Malec, and Mr. Jain, met with Susan McLaughlin, Supervisor, and Richard Osworth, Chief, Department of Community Affairs. The DCA

requested the meeting so that licensed inspectors, who were also licensed electrical contractors, could receive credit for attending inspector courses to renew their electrical contractor's license. The DCA agreed to pay the \$100.00 processing fee and agreed to submit their courses on the Board's application. The DCA will submit their continuing education courses for the Board's approval for the 2009 to 2012 triennial renewal cycle.

Mr. McCullough stated that as an instructor for both the inspectors and electrical contractors, he was always asked why the Board did not accept the DCA courses to renew their electrical contractor's license. Mr. McCullough also stated that he informed the inspectors that the DCA first needed to submit these courses to the Board for approval. Mr. McCullough also stated that the DCA was surprised as to how many instructors and providers the Board has approved.

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Twenty-one (21) applications were approved.

Motion made by Mrs. Gail Best and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that the Board go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
