

861st BUSINESS MEETING OF THE BOARD OF EXAMINERS
OF ELECTRICAL CONTRACTORS (PUBLIC SESSION) - - - DECEMBER 7, 2011

Kathleen Moran, Administrative Assistant 3, was present from 9:00 A.M. until the close of the meeting.

Joseph Donofrio, Deputy Attorney General, Division of Law, was present from 9:00 A.M. until the close of the meeting.

Also in attendance were Robert Spellman, Electrical Contractors Association of New Jersey; Joseph Coviello; and John Dubina.

The Board saluted the Flag.

Mr. Schooley requested a moment of silence in remembrance of Pearl Harbor.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to ratify the Committee's recommendations for the Minutes of the 860th Open Session Business Meeting held November 2, 2011.

December 7, 2011

Motion made by Mr. James H. Flaherty and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, to approve 29 (twenty-nine) Initial Licenses effective December 7, 2011 to March 31, 2012.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. James H. Flaherty, and unanimously passed, to approve 22 of the 23 Initial Business Permits effective December 7, 2011, to March 31, 2012. (#14 is being held in abeyance pending research done by DAG Donofrio to ensure that the word "security" can be used in the business name.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to approve 5 of the 6 Initial Business Permits Previously Expired effective December 7, 2011 to March 31, 2012. (#1 is being held in abeyance pending further review)

Motion made by Mr. James H. Flaherty and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to approve 12 of the 13 Changes in Business Permits effective December 7, 2011 to March 31, 2012. (#11 is being held in abeyance pending research done by DAG Donofrio to ensure that the word "security" can be used in the business name.

The Board reviewed additional information received from John M. DeBouter, Local Union #163, IBEW, regarding his request to teach Continuing Education Courses. At its September 7, 2011 meeting, the Board requested that Mr. DeBouter provide a more detailed description/outline of the courses to be taught.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve one (1) new course and instructor. Mr. DeBouter will be advised that the Board is only approving twenty-one (21) hours of the forty (40) hour course. Licensed electrical contractors must attend all 21 hours in order to receive a certificate for the renewal of their license. It is the Board's recommendation that the IBEW include this language in their advertisements.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Dessie Kirilova, Krannich Solar, Inc. Included with the application is a letter dated October 6, 2011, received from the Solar Education Center granting approval to Krannich Solar, Inc. to utilize courses previously approved under the sponsorship of the Solar Education Center.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve four (4) new courses and instructors. Ms. Kirilova will be advised that the course entitled "1 Day Solar PV Electrical Design" is being approved as a (7) hour course and not an eight (8) hour course as lunches and breaks can not be included in the instructional hours.

December 7, 2011

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Jan Whitley, Janco Electric, LLC.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve seven (7) new courses and instructors.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Terri Wettle, E-Hazard.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve three (3) new courses and instructors.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Darlene Pirtle, Lewellyn Technology.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve two (2) new courses and instructors and previously approved courses.

Mr. Constantinos Papademas abstained from the following discussion and the motion as he is listed as the instructor for Warshauer Electric Supply Co.

Application for Continuing Education Course/Seminar Approval received from Kennie M. Fried, Warshauer Electric Supply Co.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. James H. Flaherty, and passed, to approve one (1) new course and instructor.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Gary P. Fulton, Sr.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve six (6) new courses and instructor. Additionally, previously approved courses under the sponsorship of Lawrence H. Kosden are approved for transfer to the sponsorship of Gary P. Fulton Sr.

December 7, 2011

The Board reviewed an Application for Continuing Education Course/Seminar Approval received from Thomas McNulty, Penn-Del-Jersey Chapter NECA.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve five (5) new courses and instructors.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Kennie M. Fried, Warshauer Electric Supply.

At its October 5, 2011 meeting, the Board held in abeyance the course entitled "Photovoltaic Technical Sales Classes". The Board requested that Ms. Fried clarify whether or not the course is one thirty-two (32) hour course or eight (8) four hour courses.

E-Mail received from Ms. Fried advising that the course is one 32 hour course and Warshauer will make it mandatory for the licensed electrical contractor to attend all 32 hours in order to receive a certificate for the renewal of their license.

Ms. Fried also advised that she will provide the Board with a more detailed breakdown of the instructional hours and hands-on hours for the course entitled "Design and Build of a Solar System".

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve one (1) new course and instructor. Ms. Fried will be advised that licensed electrical contractors must attend all 32 hours in order to receive a certificate for the renewal of their license. It is the Board's recommendation that this language be included in all advertising.

Letter received on October 3, 2011, from Ralph Lombardi, Instructor #94, requesting 15 hours of credit towards the renewal of his License #9685 pursuant to N.J.A.C. 13:31-1.7. Mr. Lombardi has provided copies of attendance certification sheets reflecting that he has taught 38 hours of continuing education courses which includes the nine hours of code changes and the one hour of laws, rules and regulations.

Motion made by Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and unanimously passed, that Mr. Lombardi be granted 15 credits toward his 2012 to 2015 triennial license renewal.

Letter dated November 1, 2011, received from Charles Aikey, License #6642, requesting an extension to complete his Continuing Education Courses for the 2012 to 2015 renewal period. Mr. Aikey stated that he has been under the care of an orthopedic surgeon.

December 7, 2011

Motion made by Mr. Constantinos Papademas and seconded by Mr. James H. Flaherty, and unanimously passed, that a letter be sent to Mr. Aikey requesting that he provide documentation from his physician. The Board would also like to know how many continuing education hours Mr. Aikey has attended thus far and how long he needs to complete same.

The Board reviewed the Fiscal Year 2011 Final Budget Report for the Board of Examiners of Electrical Contractors.

Mr. Spellman stated that there is a bill pending which revises the law regarding reciprocity. Mr. Spellman also stated that the Electrical Contractors Association of New Jersey is opposed to this bill because New Jersey has higher standards than other states. Mr. Spellman further stated that the Association would not oppose reciprocity if that other state had the same or higher standards than New Jersey.

Darryl Gayton, License #11140, has failed to respond to the Administrative Action Provisional Order of Discipline filed June 1, 2011, ordering that Mr. Gayton's License and Business Permit #11140 are provisionally suspended until such time as he responds to the complaint and is assessed a civil penalty in the amount of \$1,000.00 for violation of N.J.A.C. 13:45C-1.2.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. James H. Flaherty, and unanimously passed, to go into Executive Closed Session to discuss this matter.

After discussion in Closed Session, the Board returned to Open Session for the following motion regarding Darryl Gayton, License #11140.

Motion made by Mr. James H. Flaherty and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, that a letter be sent to Mr. Gayton advising him to respond to the POD in writing within ten days. Should Mr. Gayton not respond within ten days, the Board directed that Deputy Attorney General Joseph Donofrio finalize the Provisional Order of Discipline and issue a Final Order of Discipline ordering that Mr. Gayton's License and Business Permit #11140 are provisionally suspended until such time as he responds to the complaint and assessed a civil penalty in the amount of \$1,000.00 for violation of N.J.A.C. 13:45C-1.2.

December 7, 2011

Rachel Franklin, Telecommunications Wiring Exemption #1645, has failed to respond to the Administrative Action Provisional Order of Discipline filed September 7, 2011, ordering that Mrs. Franklin's Telecommunications Wiring Exemption #1645 is provisionally suspended until such time as she complies with all provisions outlined in the September 16, 2009 Consent Order and is assessed a civil penalty in the amount of \$1,000.00 for violation of N.J.S.A. 45:1-21(e) and \$1,000.00 for violation of N.J.S.A. 45:1-22.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, that Deputy Attorney General Joseph Donofrio finalize the Provisional Order of Discipline and issue a Final Order of Discipline ordering Rachel Franklin's Telecommunications Wiring Exemption #1645 is suspended until such time as she complies with all provisions outlined in the September 16, 2009 Consent Order and is assessed a civil penalty in the amount of \$1,000.00 for violation of N.J.S.A. 45:1-21(e) and \$1,000.00 for violation of N.J.S.A. 45:1-22.

Provisional Order of Discipline filed May 18, 2011, ordered Aziz Abed, License #11311, to pay a civil penalty in the amount of \$2,000.00 for violation of N.J.A.C. 13:45C-1.2.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Mitchell R. Malec, and unanimously passed, to go into Executive Closed Session to discuss this matter.

After discussion in Closed Session, the Board returned to Open Session for the following motion regarding Aziz Abed, License #11311.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, that Deputy Attorney General Joseph Donofrio finalize the Provisional Order of Discipline and issue a Final Order of Discipline rescinding the civil penalty assessed against Mr. Abed in the amount of \$2,000.00 for violation of N.J.A.C. 13:45C-1.2 based on Mr. Abed's letter dated June 12, 2011. Mr. Abed will be requested to provide copies of continuing education course certificates totaling 34 hours for the 2012 triennial renewal period.

Administrative Action Provisional Order of Discipline filed September 7, 2011, ordered Anthony J. Catalano, License #7623, to pay a civil penalty in the amount of \$500.00 for violation of N.J.S.A. 45:5A-9; Mr. Catalano's License and Business Permit #7623 are provisionally suspended as a disciplinary action; and Mr. Catalano is provisionally reprimanded for having violated N.J.S.A. 45:1-21(h) and N.J.S.A. 45:1-21(n).

In November 2011 Mr. Catalano paid his first penalty installment in the amount of \$100.00.

December 7, 2011

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. Arthur W. Jacobs, Sr., and unanimously passed, that Deputy Attorney General Joseph Donofrio finalize the Provisional Order of Discipline and issue a Final Order of Discipline ordering that Anthony J. Catalano, License #7623, pay a civil penalty in the amount of \$500.00 for violation of N.J.S.A. 45:5A-9; Mr. Catalano's License and Business Permit #7623 are suspended as a disciplinary action; and Mr. Catalano is reprimanded for having violated N.J.S.A. 45:1-21(h) and N.J.S.A. 45:1-21(n). Mr. Catalano has paid \$100.00 towards the civil penalty assessed against him.

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Fifteen (15) applications were approved.

Mr. Papademas stated that he attended the code related Webinar course and felt that the course and instructor were very informative. Mr. Papademas also stated that he felt that the length of the course was too long.

The Board requested that Maryann Sheehan appear before it Board at its January 4, 2012 meeting to discuss drafting language which will allow licensees the opportunity to attend Webinar Continuing Education courses at a minimum of one hour and a maximum of two hours in length.

Mr. Flaherty stated that licensed electrical contractors should be allowed to attend fire alarm and burglar alarm courses approved by the Fire and Burglar Alarm Committee and receive credit for having done so.

The Board asked that Mr. Cantalupo discuss this matter with the Burglar Alarm, Fire Alarm, and Locksmith Advisory Committee.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
