The above-mentioned game is approved for use in New Jersey as an amusement game, as defined in the Amusement Games Licensing Law, N.J.S.A. 5:8-100 et seq. ("Law"), and the regulations promulgated thereunder, N.J.A.C. 13:3-1.1 et seq. ("Regulations"). This approval is based upon information supplied by the applicant at the time of application for certification. The game must be operated in accordance with the specifications submitted and the terms of this certification. Any modification of the manufacturer's specifications or the specified method of play immediately voids this certification.

It is unlawful to license or operate any amusement game in the State of New Jersey without a valid Certification of Permissibility or in a manner not in accordance with Certification of Permissibility issued for the game. This Certification of Permissibility contains three pages. This is page 1 of 3.

GAME DESCRIPTION

The Avengers game is a 1 to 2 player noncompetitive electronic arcade coin pusher themed after super heroes such as Captain America, Thor, The Hulk, Iron Man and other super hero characters. Each player position features a coin/token slot, a coin/token release button, stop and a stop button. Each player position utilizes a separate play field which consists of an upright coin ramp, a spiral ramp, Super Hero Slots, a Super Bonus Wheel and a double level mechanical coin pushing arm mechanisms.

The player inserts a coin/token into the game slot, the player then utilizes a button located at the player position to time the direction the coin/token will be released down unto the games play field. The coin/token travels down the spiral ramp into 1 of nine (9) Super Hero Slots which has various ticket amount positions that the coin/token passes through awarding the player additional redemption tickets. If the coin passes through the lit Super Hero Slot the game releases game balls in addition to the coin into the play field. The coin/token then enters the play field with existing game coins/tokens which then moves the entering coin/token forward and backwards forcing them to fall over the play field edge. The coins, tokens, game balls or cards which fall off the play field edge are deemed for prize redemption.

The Avenger coin pusher game also offers a bonus feature. The bonus feature consists of a large spinning wheel when the player illuminates all six (6) power gems located on the gauntlet "glove". The large spinning wheel displays various Avenger hero characters on them. If the player achieves the bonus feature additional redemption tickets based upon the posted ticket payout schedule of displayed characters once the large spinning wheel comes to a complete stop.

All prizes are dispensed to the player for prize redemption immediately upon completion of the game.

CONDITIONS

- 1.) The maximum price to play shall not exceed values set forth in N.J.A.C. 13:3-3.4.
- 2.) Payout must occur immediately in the form of tickets redeemable for prizes.
- 3.) Game shall be clean and free of debris.
- 4.) Game shall be installed and maintained according to manufacturer specifications.
