The above-mentioned game is approved for use in New Jersey as an amusement game, as defined in the Amusement Game Licensing Law, N.J.S.A. 5:8-100 et seq. ("Law"), and the regulations promulgated thereunder, N.J.A.C. 13:3-1.1 et seq. ("Regulations"). This approval is based upon information supplied by the applicant at the time of application for certification. The game must be operated in accordance with the specifications submitted and the terms of this certification. Any modification of the manufacturer's specifications or the specified method of play immediately voids this certification.

It is unlawful to license or operate any amusement game in the State of New Jersey without a valid Certification of Permissibility or in a manner not in accordance with Certification of Permissibility issued for the game. This Certification of Permissibility contains three pages. This is page 1 of 3.

GAME DESCRIPTION

The Beat the Goalie game is a single player or two player arcade non-competitive redemption game. This game is a soccer theme game which consists of a game ball launcher located at the player position and a one (1) player or two (2) player selection buttons also located at the player position, twelve (12) round lit game targets and a soccer goalie character.

If the two (2) player selection button is activated the game will be set for two (2) players, each player completes their respected game, once the game clock expires and the second players turn will begin. Each player has a separate LED score display to reflect the amount of points achieved during game play.

The object of the game is for the player(s) to shoot as many game balls into the round lit game targets for score within the allotted amount of time displayed on the LED game clock. Each game target has a separate point value which is displayed above each said target. The player(s) is awarded points for each successful shot into the lit game targets. However, during game play there is a soccer goalie character positioned in front of the game targets which moves left to right and right to left attempting to block the game balls from hitting the game targets.

If the player(s) shoot out all twelve (12) lit game targets before the game clock expires then the player is awarded the "Kickers Jackpot". The "Kicker Jackpot" is a LED display located at the top marquee of the game. Upon completion of the game all tickets are dispensed to the player(s) for prize redemption.

CONDITIONS

- 1.) The maximum price to play shall not exceed values set forth in N.J.A.C. 13:3-3.4.
- 2.) Payout must occur immediately upon a win.
- 3.) The game play field shall be clean and free of debris.
- 4.) Game shall be installed and maintained according to manufacturer specifications
- 5.) The device is being operated by the following software version:
