The above-mentioned game is approved for use in New Jersey as an amusement game, as defined in the Amusement Game Licensing Law, N.J.S.A. 5:8-100 et seq. ("Law"), and the regulations promulgated thereunder, N.J.A.C. 13:3-1.1 et seq. ("Regulations"). This approval is based upon information supplied by the applicant at the time of application for certification. The game must be operated in accordance with the specifications submitted and the terms of this certification. Any modification of the manufacturer's specifications or the specified method of play immediately voids this certification.

It is unlawful to license or operate any amusement game in the State of New Jersey without a valid Certification of Permissibility or in a manner not in accordance with Certification of Permissibility issued for the game. This Certification of Permissibility contains three pages. This is page 1 of 3.

## **GAME DESCRIPTION**

The Golden Empire is a single player noncompetitive redemption game. The Golden Empire redemption device consists of a mechanical arm, a joystick controller and a game clock. The joystick controller is located at the player position. The play field of the game consists of a mechanical arm and a square flat area which "Golden" tokens rest and in the middle of the play field is a vertical pillar bar with an emperor figure head.

The object of the game is for the player to utilize the joystick controller to maneuver the mechanical arm across the play field knocking off as many "Golden" tokens as possible before the game clock expires. However, the player must be careful not to knock over the vertical pillar bar otherwise the game is deemed over. The player is awarded tickets based upon the games payout schedule. If the player knocks off all the tokens then the player is awarded the "Super Bonus". The "Super Bonus" is a LED display located at the top portion of the game cabinet. Upon completion of the game all awards are dispensed as tickets to the player for prize redemption.

## **CONDITIONS**

- 1.) The maximum price to play shall not exceed values set forth in N.J.A.C. 13:3-3.4.
- 2.) Payout must occur immediately in the form of tickets for redeemable prizes.
- 3.) The game play field shall be clean and free of debris.
- 4.) Game shall be installed and maintained according to manufacturer specifications
- 5.) The device is being operated by the following software version:


