This approval is based upon information supplied by the applicant at the time of application for certification. The game must be operated in accordance with the specifications submitted and the terms of this certification. GAME DESCRIPTION

The HYPERpitch game is a one or two player noncompetitive baseball pitching theme arcade redemption game. Each player position consists of a solo or versus button, a baseball catcher background target, LED score display and LED speed pitch display.

The player(s) throws three (3) baseballs one at a time into the catcher background target in an attempt to hit the catcher target utilizing speed and accuracy within the allotted amount of time displayed on the LED game clock. The player's score is calculated on the speed of the pitch and the area in which hits the catcher target. The scores for each throw is added together for a final score. The player(s) is awarded tickets based upon a score and the posted game rules of play.

Upon completion of the game all tickets are dispensed to the player for prize redemption.

CONDITIONS

- 1.) The maximum price to play shall not exceed values set forth in N.J.A.C. 13:3-3.4.
- 2.) Payout must occur immediately in the form of tickets redeemable for prizes.
- 3.) Game shall be clean and free of debris.
- 4.) Game shall be installed and maintained according to manufacturer specifications.


Software Identification
