The above-mentioned game is approved for use in New Jersey as an amusement game, as defined in the Amusement Game Licensing Law, N.J.S.A. 5:8-100 et seq. ("Law"), and the regulations promulgated thereunder, N.J.A.C. 13:3-1.1 et seq. ("Regulations"). This approval is based upon information supplied by the applicant at the time of application for certification. The game must be operated in accordance with the specifications submitted and the terms of this certification. Any modification of the manufacturer's specifications or the specified method of play immediately voids this certification.

It is unlawful to license or operate any amusement game in the State of New Jersey without a valid Certification of Permissibility or in a manner not in accordance with Certification of Permissibility issued for the game. ## **GAME DESCRIPTION**

NBA Hoops is single player basketball toss redemption game. The player inserts the appropriate amount of coins/tokens into the acceptor. The player presses the <code>IStartI</code> button to initiate game play, releasing the basketballs. The player shoots the basketballs at the basketball hoop located within the game enclosure. Tickets are awarded to the player based on the number of basketballs successfully passing through the hoop in the allotted amount of time. All awards are dispensed as tickets to player for prize redemption.

Upon completion of the game all awards are dispensed as tickets to the player for prize redemption.

## **CONDITIONS**

- 1.) The maximum price to play shall not exceed values set forth in N.J.A.C. 13:3-3.4.
- 2.) Payout must occur immediately in the form of a redemption tickets redeemable for prizes.
- 3.) Game shall be clean and free of debris.
- 4.) Game shall be installed and maintained according to manufacturer specifications.
