DESCRIPTION

The Rescue "1" redemption game is a single player noncompetitive arcade game. The said game consists of twelve (12) square targets, a water gun and game clock. The twelve (12) square targets are located at the back plain of the play field which represent windows. The player utilizes a water gun which is located a the player position to shoot a stream of water at the window targets when they randomly illuminate. Every time the player successfully shoots the illuminated window the player is awarded ten (10) points. Play continues until the game clock reaches zero. The player is awarded tickets based upon the displayed pay out schedule located on the game. If the player's score exceeds the "BONUS" score which is displayed on a LCD screen located at the top marque, the player is awarded that displayed value. All awards are dispensed as tickets to the player for prize redemption.

CONDITIONS

- 1.) The maximum price to play shall not exceed values set forth in <u>N.J.A.C.</u> 13:3-3.4.
- 2.) Payout must occur immediately in the form of tickets redeemable for prizes.
- 3.) Game shall be clean and free of debris.
