The above-mentioned game is approved for use in New Jersey as an amusement game, as defined in the Amusement Game Licensing Law, N.J.S.A. 5:8-100 et seq. ("Law"), and the regulations promulgated thereunder, N.J.A.C. 13:3-1.1 et seq. ("Regulations"). This approval is based upon information supplied by the applicant at the time of application for certification. The game must be operated in accordance with the specifications submitted and the terms of this certification. Any modification of the manufacturer's specifications or the specified method of play immediately voids this certification.

It is unlawful to license or operate any amusement game in the State of New Jersey without a valid Certification of Permissibility or in a manner not in accordance with Certification of Permissibility issued for the game. This Certification of Permissibility contains three pages. This is page 1 of 3.

#### **GAME DESCRIPTION**

The Wild West Shoot Out is a one or two (2) player cowboy themed shooting electronic arcade redemption game. Each of the player positions is equipped with game button, a plastic six-shooter styled gun and a large video monitor displaying the devices play field, which includes the player(s) score. The Wild West Shoot Out video play field consists of video animated bad guys, good guys, hostages and other animated targets. Each of these game targets shine a specific color to show the player which character / target to correctly shoot at.

The player initiates game play by inserting the required credits displayed on the device. The player then presses the game button which initiates game play.

The object of the game is for the player to aim the guns sight and press the trigger which shoots a light beam unto the video player field in an attempt to shoot the bad guys. The player is awarded points for each bad guy hit. However, during game play the player must avoid shooting the good guys and hostages that appear on the play field. Game play continues until the health meter expires, this is done when the player incorrectly shoots the wrong character or target a number of times.

Upon completion of the game all tickets are dispensed immediately to the player for prize redemption.

#### **CONDITIONS**

- 1.) The maximum price to play shall not exceed values set forth in N.J.A.C. 13:3-3.4.
- 2.) Payout must occur immediately in the form of redemption tickets.
- 3.) Game shall be clean and free of debris.
- 4.) Game shall be installed and maintained according to manufacturer specifications.

The approved operating software version is listed below:

### **Software Identification**

Coastal Amusements, Inc. has agreed to the terms by completing the certification section #1 of the Application for Amusement Game Certification that reflects the **software version v2.0.1910US** for the Wild West Shoot Out electronic arcade redemption game.
