B DEP Rule Proposal (Attachment)

On September 17, 2020, Mehnaz Rahim, Regulatory Analyst, Division of Consumer Affairs was present for discussion on this matter. The Board reviewed language in a rule proposal from the Department of Environmental Protection which appeared to permit the preparation of surveys by unlicensed individuals. Upon further review, it was determined that this language was existing within the rules, not proposed, and therefore not subject to public comment.

After some further discussion, BM Smith motioned to issue a comment objecting to the existing language due to conflicts with the Board's rules. There was no second and the motion was not carried.

After further discussion, BM Kelly motioned to have Regulatory Analyst find any available historical background on the existing rule language but provide no comment on the rule proposal because the proposed amendments did not conflict with the Board's rules. The Board will determine what further action should be taken once it has all the requested information. BM Vernick seconded the motion. BM Smith voted nay. Motion carried.
