# **COMMITTEE REPORTS**

- A Standing Committees:
  - I Legislation Committee S1589 – Requires certain standards for professional and occupational boards considering applicants with criminal history records.

**ACTION:** Liza Ackerman, Regulatory Analyst, was present to discuss the above Bill. After some discussion, the Board supports the rehabilitation criteria and the "Megan's Law" language in the Bill, however, the Board opposes the limitations of offenses which the Board can take action; lacks clarity regarding "relating to practice"; and the Board has concerns as to liability to board members when action is taken.

Liza Ackerman, Regulatory Analyst, also informed the Board the following:

- Bill A-4273 has been re-introduced, which includes the indemnity language for Board members in the assembly and senate.

- Bill pertaining expediting licensure in light of natural disasters has been reintroduced in the assembly and senate.
- II Regulations / Sunset Committee Liza Ackerman, Regulatory Analyst, Home Inspection regulations

**ACTION:** Liza Ackerman, Regulatory Analyst was present and informed the Board of the changes made to the Home Inspection regulations regarding additional services. On a motion by BM Smith, seconded by BM Kelly, the Board voted to approve the Home Inspector Advisory Committee's rules for publication.

BM Smith motioned to re-open discussion on the tax map assessment language. The motion died due to a lack of a second.

50 N.J.R. 299(a) – Rule Adoption by Department of Community Affairs regarding Carnival-Amusement Rides

**ACTION:** Liza Ackerman, Regulatory Analyst, informed the Board that the above regulation was adopted on November 17, 2017 without change and published in the *New Jersey Register* on January 16, 2018. The Board is concerned that DCA failed to address the Board's comments adequately and that the above rule will permit unlicensed persons to practice engineering in this State.
