CALL TO ORDER

Notice of the scheduled the May 16, 2024 meeting of the New Jersey State Board of Professional Engineers and Land Surveyors was not held at 124 Halsey Street, Newark, New Jersey, but remotely. Pursuant to the Open Public Meetings Act, N.J.S.A. 10:4-9.3, adequate notice was made by mailing and posting in accordance with N.J.S.A 10:4-18. The meeting was called to order by President Michael Venuto at 9:01 am and conducted virtually.

Re: Engineering Registration Requirements for 501c3 Organization in New Jersey

ACTION: Based on information provided, the Board determined that you can continue to work as indicated and there appears to be no need of a Certificate of Authorization license.

OLD BUSINESS

DAG Roman informed the members of the public that at the last meeting, the Board held elections for the President and Vice President of the Board. Michael Venuto was elected as the new President and Lisa Peterson was elected as Vice President of the Board for the next year. After the elections, President Valenti announced his resignation from the Board.

COMMITTEE REPORTS

A Standing Committees:

1 Application Improvement Committee – MVenuto (chair) & LPeterson

ACTION: BP Venuto expressed that past president Valenti, during his last term, worked to make vital improvements to move the application and review process along. The Board requested that ED Miller provide a report on the status of applications to the Committee can continue to look for further opportunities to make improvements.

PLS Education Committee – GPaparozzi (Chair) & LPeterson
 A Draft amendments to PELS rules on continuing education for discussion.

ACTION: Chuck Manning, Regulatory Analyst, and Nytaino Rusomano, Regulatory Analyst from the Division of Consumer Affairs were present to discuss this rule proposal with the Board. Approval from the Governor's office was received.

The Board, on a motion by BM Paparozzi, seconded by BM Purcell, unanimously voted to approve the proposed regulation changes to NJAC 13:40-11.3 and NJAC 13:40-13.1 and begin the process for publication in the NJ Register.

3 Legislation Committee – MHagag (Chair) & JPurcell Copy of an email from Chuck Manning, Regulatory Analyst, regarding A2805

ACTION: Chuck Manning, Regulatory Analyst, and Nytaino Rusomano, Regulatory Analyst from the Division of Consumer Affairs were present for discussion. Bill A-2805, which requires issuance of report on certain information and data on processing of applications for professional and occupational licenses and mandates review of training and call intake in Division of Consumer Affairs. In the last session, the Governor pocket vetoed the bill. It has been re-introduced for this session in January 2024 and referred to Assembly Regulated Professions Committee. Mr. Manning informed the Board that the Division is aware of this bill and has concerns that it takes resources away from processing the applications to compile data for a report on the process the applications. Bill A-2225, which requires certain standards for professional and occupational boards considering applicants with criminal history records. It has been introduced for this session in January 2024 and referred to Assembly Regulated Professions Committee. Mr. Manning informed the Board that there has been no movement on this bill.

4 NCEES Committee – JPurcell (Chair) & M Alsharaa

ACTION: BM Purcell informed the board that he attended the NCEES Northeast Zone Interim meeting. There were approximately two dozen first-time attendees. The purpose of the Interim meeting is to discuss committee reports and it's informational in preparation for the Annual Meeting in August. NCEES Model Law does not recognize engineering technology degrees as sufficient for licensure. There are 32 jurisdictions that do allow engineering technology degrees. A motion was passed to create a committee in the Northeast Zone to develop a motion to be heard at the Annual meeting to change model law to accept engineering technology degrees. BM Peterson will be the funded delegate of the board to attend the NCEES meeting. BM Purcell and Hagag will also be attending the meeting. BM Alsharaa informed the Board that she is on the the committee discussing engineering technology degrees and the first meeting was held Tuesday. There is a second meeting scheduled for Friday and proposed language will be provided for voting at the annual meeting.

ACTION: May meeting was canceled. The next scheduled meeting is September 3, 2024
