**ACTION:** BP Venuto read comments submitted by BM Purcell as follows: Anyone interested should review the summary of actions and voting results on the My NCEES page. All motions presented passed. Of particular import was the Northeast Zone motion to amend Model Law to include ABET-ETAC accredited engineering technology programs as acceptable for engineering education. The language will be incorporated into the Model Law by the Committee on Uniform Procedures and Legislative Guidelines (UPLG), which I chair, and presented to the NCEES Council at next year’s annual meeting. New Jersey has become a signatory to the Mutual Recognition between the United States (NCEES) and the United Kingdom (Engineering Council). Our next steps are to consider amending our Statute to allow us to recognize Chartered Engineers from the UK, vetted by the Engineering Council, without meeting our requirements for licensure. We need to discuss how that is accomplished.
