- II Statute / Regulation Proposal Committee
 Liza Ackerman, Regulatory Analyst, Division of Consumer Affairs was present to
 update the Board on the following:
 - A-2810 concerning NC supervision
 This Bill has been reported out of the Assembly Committee with amendments which address complaints made by the public against a board alleging that a regulation/action/decision is anticompetitive. The added language states that once a complaint is received by a board, the regulatory officer to that board is to review the complaint and decide if a regulation/action/decision was evaluated under the protocol established in the bill. An evaluation of the regulation/action/decision is to then proceed if the officer finds that 1) an evaluation had not been previously performed before the regulation/action/decision took effect or 2) the complaint provides additional information that could alter the outcome of a prior review of the board's regulation/action/decision.
 - Acting Director Paul Rodríguez has asked the regulatory analysts to work with their assigned boards to determine, in both their statutes and their regulations, 1) what provisions are outdated and/or no longer necessary and 2) what is the "wish list" of items Board members would like to see in the law and/or regulations. The "wish list" is to focus items that will help the public. There is no set deadline for this issue.
 - A-1531 regarding out-of-state applicants has been signed by Governor Murphy. No regulations have been drafted at this point. Not sure when the law goes into effect.

ACTION: The Board determined to establish a sub-committee (BM Valenti, BM Smith and BP Kelly) along with DAG Albertson to review the statutes of the Board. The regulation sub-committee (BM Valenti, BM Paparozzi and BM Cleary) along with DAG Roman Guzik will review the regulations of the Board.
