Discussion: BM Vernick informed the Board that no bills on the chart have moved. There is one bill A-5951, which provides for licensure of landscape professionals and registration of professional landscaping businesses. However, this bill has not moved either. DAG Albertson informed the Board that the Architect board received this bill and due to some concerning language she felt this board should review the bill.

ACTION: After reviewing the bill and some discussion, the Board, on a motion by BM Vernick, seconded by BM Kelly, unanimously voted to oppose the bill.

II Application & Examination Committee

ACTION: Ileana Botelho, former Acting Executive Director, informed the Board of this in her general report.

III NCEES Committee

ACTION: BM Purcell informed the Board that the civil exam will be a computer based test going forward. There is no more paper and pencil exam in New Jersey. Tim Miller, NCEES Chief Officer of Examinations is retiring and Jason Gamble will be the new Chief Officer of Examinations. BM Purcell had visited the new building of NCEES. BM Purcell is on the Advisory Committee for Council Activities and he will be writing a revision to the bylaws to include a public member and a member board administrator to become a members of the NCEES Board of Directors, which would increase the number of eight members to ten members for full voting.

BP Valenti and BMs Smith and Kelly expressed interest in attending.
