Mr. Giella appeared before the Board to request reinstatement of his professional engineers license in adherence to the terms of the Consent Order. After a discussion, the Board on a motion by VP Schwartz, second by BM Vernick, voted to approve the reinstatement of Mr. Giella's license.

# Paul J. Kenny, PE - Adherence to Consent Order

Mr. Kenny appeared before the Board to request reinstatement of his professional engineers license in adherence to the terms of the Consent Order. After discussing this matter, the Board on a motion by BM Smith, second by VP Schwartz, voted that Mr. Kenny must complete four continuing professional competency courses, pre-approved by the Board. Before the Board will consider reinstatement of Mr. Kenny's license, he needs to comply with the terms of the consent order.

#### Elizabeth Greenblatt, Regulatory Analyst

Ms. Greenblatt appeared before the Board to discuss a land surveyors correction to the Board's proposed continuing professional competency regulation regarding the conversion ratio of credits. After discussing this matter, the Board on a motion by BM Jones, second by BM Vernick, voted to issue a rule proposal to correct any issues in its current proposal.

Acting Executive Director, Joseph Grabowy, informed the Board that two public comments were received regarding the Board's proposed regulation regarding its continuing professional competency requirements.
