CALL TO ORDER

COMMITTEE REPORTS

Application Review Committee

President Valenti presented the Board with a draft outline for the future review of applications. The discussion on this matter will continue at future Board meetings.

Joint Committee

President Valenti indicated that there was a Joint Committee meeting on February 14, 2006. He also stated that Joint Committee meetings have been scheduled on a monthly basis for the calendar year 2006. It will cancel meetings as needed.

REPORT OF THE EXECUTIVE DIRECTOR

General Report

Executive Director Russo informed the Board that license renewal notices were mailed to all licensees on or about February 15, 2006 which indicate that renewal is available online. He also indicated that President

Valenti successfully renewed his license online.

He also reported that NCEES has requested to appear before the Board to discuss issues concerning the acceptance of electronic records. President Valenti indicated that there is no need to appear at this time. He has requested that Executive Director Russo discuss these matters with the Director's Office. Also, President Valenti requested that the Executive Director communicate with NCEES and advise them that until this issue is resolved, the Board will require a hard copy of all records.

Executive Director Russo informed the Board that there will only be two examination sites (N.J.I.T. and the West Trenton Fire Department) this year. Rowan University has opted not to participate.

President Valenti indicated that he will work towards obtaining a speaker for the Board's upcoming Certificate Award Ceremony in April 2006.

The Board reviewed a draft of the State Specific Examination for land surveyors and, on a motion by BM Angeline, second by BM Marshall, unanimously approved it with modifications.

REVIEW OF PROPOSED HOME INSPECTION COURSE OF STUDY

Michael Fitzpatrick, Home Inspection Advisory Committee Member, appeared before the Board regarding the development of the home inspection course of study. After discussing this matter, the Board requested input from the public.

Charles Blumeling, PE, PLS stated that he believed that the 7 hours allocated to the professional practice section of the course of study was too short. The Board advised him that the allocation of the number of hours was determined by the Role Delineation Study conducted by the Examination Board of Professional Home Inspectors (EBPHI) from which the course of study is constructed.

The Board, on a motion by BM Angeline, second by BM Frantz, unanimously approved the course of study and requested that Executive Director Russo forward it to the New Jersey Department of Education for implementation.

RE: Licensed Professional Engineers as Licensed Private Investigators (January 30, 2006)

Ms. Svoboda requests a determination whether a licensed professional engineer may be able, by virtue of their engineering license, to perform investigative/forensic work in matters such as structural failures, building collapses, retaining wall failures, foundation failures, water seepage and water intrusion into foundations and structures, vibration and blasting related damages, etc., or if a license as a private investigator is required.

The Board will advise Ms. Svoboda that any person practicing engineering within the State of New Jersey must have a PE license.
