REPORT OF THE EXECUTIVE DIRECTOR

General Report

Acting Executive Director Joseph Grabowy thanked the Board members for all their efforts in the timely review of application files for the April 2011 professional examinations.

Acting E.D. Joseph Grabowy stated that effective February 22, 2011, Elizabeth Greenblatt will become the Board's new regulatory analyst. Ms. Greenblatt will also serve the Board of Professional Planners and the Home Inspection Advisory Committee in the same capacity.

As part of Lieutenant Governor, Kim Guadagno, red tape commission, Acting Executive Director, Joseph Grabowy, stated that a meeting with the Code Officials Association of Municipalities will be tentatively scheduled in March 2011. Representatives from the Board of Architects will also be invited to participate.

Acting Executive Director, Joseph Grabowy, stated that the northeast zone interim meeting will be held on May 19 - 21, 2011 in Annapolis Maryland. BMs Purcell and Smith agreed to attend.

The Board on a motion by BM Cleary, second by BM Marshall, voted to submit the completed application for the NCEES "ENNY" award on behalf of BM Purcell.

INCOMING CORRESPONDENCE

Chris Del Borrello, Legislative Aid for Assemblyman Domenick C. DiCicco, Jr. February 11, 2011

Re: Constituent Questions Regarding Engineering/Surveyor Continuing Education

On behalf of a constituent, Mr. Del Borrello submitted a correspondence to the Board office requesting clarification to the continuing education requirements for licensees holding dual licenses as both a professional engineer and land surveyor.

The Board discussed this correspondence and will advise Mr. Del Borrello that pursuant to N.J.S.A. 45:8-35.8, persons licensed as both a professional engineer and a land surveyor, shall complete not less than 36 credits of continuing professional competency relating to the practice of professional engineering and land surveying, with not less than 12 credits to be completed in professional engineering and not less than 12 credits to be completed in land surveying. Additionally, of the minimum 36 credits required for a dual licensee, 2 credits must be in Ethics.

In addition, Mr. Del Borrello will be advised that the Board has implemented a review process and is currently approving courses for continuing professional competency, as required by statute, namely N.J.S.A. 45:8-35.12. Mr. Del Borrello will also be advised that fifteen hours of continuing professional competency are required to be completed by April 30, 2012 including 2 hours in ethics.

Finally, Mr. Del Borrello will be advised that regulations have not yet been adopted

requiring a fee for course approval.

Re: Professional Engineering Experience Requirements.

The Board discussed this correspondence and will inform Ms. Goldfarb of its statutory requirement of four (4) years of acceptable experience, of which two (2) years shall be original engineering design experience, all gained and verified by reference, under the regular and effective supervision of a licensed professional engineer. Furthermore, she will be advised that two years of experience (not design experience) could be satisfied through the receipt of a Masters Degree and a PhD in engineering. She will also be provided with the Board's statutes and regulations in order to review the Board's licensing requirements.

Stephen Carter, Dir., Rutgers Advanced Tech Ext. February 15, 2011

Re: Provider acceptance as a continuing education instructors.

The Board reviewed the submission from Mr. Carter and will advise that it anticipates that all instructors will earn some definitive number of credits while teaching review courses for the fundamentals of engineering and the principles and practices portions of the engineering examinations. He will be advised that the Board is preparing its regulations which address this and other matters. Regulations for Professional Engineering Continuing Education not yet adopted by the Board.
