COMMITTEE REPORTS

Legislation

A2442/S142 - Requires the public bidding or competitive contracting for award of professional service contracts and requires certain vendors to fully itemize bills to school districts and local units and prescribes sanctions. This bill was heard by the Senate Committee on February 28, 2005.

S297/A2809 - Requires value engineering clause in specifications for certain construction contracts under the Local Public Contracts Law. An amended bill passed the Senate and assembled on March 14, 2005 and was signed by the Governor on April 7, 2005.

A3897 - Establishes the State Board of Examiners of Heating, Ventilation and Air Conditioning Contractors. On March 1, 2005, this bill was introduced and referred to the Assembly Regulated Professions and Independent Authorities Committee.

Professional Qualification Program for Smart Growth Area Permitting: Comments have been submitted by the professional societies.

Proposed Election Law Enforcement Commission Regulations: Comments were given at a public hearing. The NJSPE is preparing written comments for consideration by the ELEC.

A3938 - Proposed Amendments to the Professional Licensing Act. At this time the Board will defer its comment on this bill.

RE: Engineers sealing framing plans

(February 21, 2005)

Mr. Gatti requests the Board's determination regarding a professional engineer signing and sealing framing plans for a residential addition.

After reviewing this matter, the Board shall provide Mr. Gatti with the Building Design Services Act, which addresses this issue.

Patrick S. Vitarelli, PLS, PP RE: Drug Free Zone Maps (March 1, 2005)

Mr. Vitarelli asks for clarification as to who is authorized to prepare and sign drug free zone maps.

The Board will inform Mr. Vitarelli that the preparation of a drug free zone map involves boundary information along with the measuring and locating of distances. Therefore, said map must be prepared by a licensed land surveyor. In addition, if there exists other statutory requirements for involvement by the municipal or county engineer, those laws should also be followed.

Lewis H. Conley, Jr., PLS, PP/ Van Note-Harvey RE: Preparation of Drug Free Zone Maps (March 1, 2005)

Mr. Conley requests an Attorney General opinion on the above matter.

After discussing this matter, Mr. Conley will be advised that the preparation of a drug free zone map involves boundary information along with the measuring and locating of distances, and as such, said map must be prepared by a licensed land surveyor. If there exists other statutory requirements for involvement by the municipal or county engineer, those laws should also be followed.

Brian J. Strizki, PE, Director, Division of Design Services/ NJDOT RE: Interpretation of N.J.S.A. 45:8-41 (March 7, 2005)

Mr. Strizki requests the Board's interpretation of the above statute in order to assist in the evaluation of DOT's positions.

After discussing this correspondence the Board shall advise him that pursuant to the statute a person in responsible charge of professional engineering work must be a New Jersey licensed professional engineer.

Mr. Strizki will appear before the Board on May 19, 2005 to further discuss this issue.

Robert N. Roop, PE/ Criterium Lockatong Engineers RE: Home Inspection (March 14, 2005)

Mr. Roop provides his concerns over the inconsistencies in the requirements for professional engineers and those for professional engineers that obtain home inspector licenses.

Louis A. Raimondi, PE, PLS, PP RE: Septic System Inspections (March 24, 2005)

Mr. Raimondi provided the Board with an analysis of the certification program by the NJ Department of Environmental Protection regarding septic system inspections.
