# Legislation

A953 - Rescinds recent NJ DEP rules on subsurface sewage disposals for development of 6 lots or more, or 2,000 02.

gallons per day or more - Formerly known as A3293, this bill was referred to the Assembly Environmental Committee. Recent court rulings, which voided the regulations, were upheld by the Appellate Division in March 20
<b>A1926/S1004 - Concerns Project Labor Agreements</b> - A1926 was reported favorably out of the Assembly Labor Committee on March 11, 2002 with committee amendments. It has since been referred to the Assembly Appropriation Committee. S1004 was referred to the Senate Labor Committee on February 21, 2002.
<b>A1814 - Concerns content of municipal tax maps following revaluation</b> - This Assembly Bill was introduced and referred to the Assembly Housing and Local Government Committee on February 11, 2002. The Board opposed this bill and expressed its concerns to the Acting Director, Reni Erdos, in a May 23, 2002 correspondence.

#### REPORT OF THE EXECUTIVE DIRECTOR

#### **Incoming Correspondence**

Donna Lentz RE: Corner Marker Waiver (April 19, 2002)

Mrs. Lentz advises the Board of a situation involving corner markers which were not set at the time a survey of her home was completed in 1994. She states that a waiver was never signed and that the surveyor in question does not have a copy of the waiver.

After reviewing her correspondence, the Board concluded to inform Mrs. Lentz that she would need to file a formal complaint in order for the Board to have a better understanding of her situation and requested she also submit copies of her 1994 & 1996 surveys.

John A. Napolitano/ Lewis & McKenna RE: Licensure as a Professional Engineer (April 29, 2002)

Mr. Napolitano's correspondence is in response to the Board's inquiry of April 24, 2002 in which Mr. Napolitano was referred to as being "a licensed professional engineer" in a March 29, 2002 Bergen Record article.

In his response Mr. Napolitano informs the Board that he never represented himself as a licensed professional engineer in New Jersey. Additionally, he states that he is currently licensed in the State of New York.

#### **DISCUSSION ITEMS**

#### How to improve attendance at the Certificate Award Ceremony

As a result of discussing this topic, President Patel created the Licensure Promotion Committee to encourage licensure by students. President Patel elected BM Raj as chair along with VP Vernick as assistant-chair. BMS Raj and Vernick will meet with departmental deans, faculty and students to advocate the importance of pursuing licensure.

## **Signing of Computer Generated Plans**

The Board continued its discussion on this topic and concluded that it is not in favor of the electronic signing and sealing of plans. It remains in agreement that the manual signing and sealing of documents with an impression type seal is essential to protecting the consumer and will safeguard licensees from potential tampering of their work.

## **Discussion of Home Inspector Regulations for Professional Engineers**

The Board discussed the issue of professional engineers being licensed as home inspectors.

On behalf of the NJ Professional Engineers Society, Joseph Simonetta expressed his concern over insurance coverage for professional engineers performing home inspections prior to the adoption of the Home Inspection Regulations. He indicated that some insurance companies have threatened to cancel existing insurance policies for those engineers performing home inspections without a license, after the adoption of the home inspection regulations.

Retesting of all licensees on the NJ PE/LS Statutes and Regulations in every other biennial renewal period

After a discussion on this topic, the Board concluded that it will not retest its licensees on the underlying statutes and regulations affecting the professions.

On a motion by BM Frantz, seconded by BM Raj, the Board unanimously voted to adjourn at 2:00 p.m.
