#### APPROVAL OF MINUTES

February 19, 2004

The Board, on a motion by BM Frantz, second by BM Marshall, unanimously voted to approve the minutes of February 19, 2004 as amended.

# **COMMITTEE REPORTS**

Legislation

President Vernick presented the Board with the following legislative information:

S297/A2809 - Requires a value engineering clause in specifications for certain construction contracts under the

Local Public Contracts Law. This bill was reported out of the Assembly Housing and Local Government Committee on May 27, 2004. The Board, on a motion by President Kelly, second by BM Vernick, unanimously voted to take no position on this bill.

A2772 - Revises filing requirements for minor subdivisions. This bill was introduced on May 10, 2004 and was referred to the Assembly Regulated Professions and Independent Authorities Committee. After a discussion of the bill, the Board, on a motion by BM Faraldi, second by BM Vernick, unanimously voted to support it since it will benefit the public.

A2897 - Clarifies the functions of a land surveyor as distinguished from the functions of licensed professional engineers. This bill was introduced on May 24, 2004 and referred to the Assembly Regulated Professions and

Independent Authorities Committee. After a careful review of the bill, the Board, on a motion by BM Faraldi, second by BM Vernick, unanimously voted to oppose this bill since it undermines the Board's regulations and fails to protect the consumer.
A2611 - Requires the DEP to establish a certification program for environmental consultants. This bill was introduced on May 3, 2004 and referred to the Assembly Environment and Solid Waste Committee. The Board, on a motion by BM Raimondi, second by BM Vernick, unanimously voted to support the bill and suggested that the function be assigned to this Board.
A2052 - Regulates contractors engaging in home improvements. This bill which was introduced on February 5, 2004 was passed in both the Assembly and Senate and approved and signed into law by the Governor on May 13, 2004.
