### **REVIEW OF MINUTES**

The Board, on a motion by BM Vernick, second by BM Marshall, voted to approve the minutes. VP Purcell and BM Koo abstained.

### **COMMITTEE REPORTS**

Legislation

BM Vernick advised the Board on the updates of the following bills:

A2146/S1849 - Revises regulation of landscape architects which has passed assembly and being reviewed by the senate.

A2735 - Prohibits employment and licensing background checks going back no further than seven years, under certain circumstances. On a motion by BM Vernick, second by BM Angeline, the Board unanimously voted to take no position since this bill is not applicable.

S846 - Requires consumer complaints of licensing boards of regulated professions to be resolved within 120 days. On a motion by BM Vernick, second by BM Angeline, the Board unanimously voted to oppose the bill since it does not protect the best interests of consumers.

#### REPORT OF THE EXECUTIVE DIRECTOR

ED Russo informed the Board that the Professional Credential Services (PCS) has provided the Professional Land Surveyors test questions for review. BM Jones will review the questions and report to the Board at a later date.
