# STATE BOARD OF PROFESSIONAL ENGINEERS AND LAND SURVEYORS

Minutes of July 17, 2008 Public Session

#### CALL TO ORDER

The meeting of the State Board of Professional Engineers and Land Surveyors was called to order by President Valenti at 9:00 a.m. at 124 Halsey Street, 3rd Floor Union Conference Room, Newark, New Jersey. All parties were duly notified of the time, date and place, with all pertinent material being provided.

#### SUNSHINE LAW ANNOUNCEMENT

# APPEARANCE BY JERRY CARTER, NCEES & EVA-ANGELA ADAN, CPEES EVALUATION SERVICES

Jerry Carter and Eva-Angela Adan appeared before the Board to discuss the education evaluation services of the Center for Professional Engineering Education Services (CPEES).

On a motion by BM Vernick, seconded by BM Schwartz, the Board voted to include CPEES as one of its approved education evaluation service providers.

## REPORT OF THE EXECUTIVE DIRECTOR

Executive Director Arthur Russo discussed a request from the Department of Agriculture, State Soil Conservation regarding state departments and the requirements for professional engineers. On a motion by VP Purcell, second by BM Schwartz the Board voted to advise the State Soil Conservation that it will need a professional engineer to perform the work described since it appears to be engineering work.

ED Russo stated that all Certificate of Authorization biennial renewal applications have been mailed out.

ED Russo informed the Board of the NCEES' invoice for the April 2008 Exam Book/Score and of the April 2008 Candidate Score Status Report by School Code of PCS. The Board noted these matters for the record.

ED Russo stated that the score results were released for the April 2008 examinations.

## APPEARANCE BY PATRICIA SCHIRIPO, REGULATORY ANALYST

Ms. Schripio appeared before the Board to discuss the Architects Registration Examination (ARE) transition chart and study guides. She stated she will speak with Pro-Metric, the examination developers for architects, to determine if professional engineers will be allowed to continue testing in version 3.0 beyond July 1, 2009. At this time NCARB cannot do anything regarding the transition from version 3.0 to version 4.1 of the ARE.

#### **COMMITTEE REPORTS**

Joint Committee

The Board noted that there was opposition to the draft response letter to Jason Lusardi which memorialized the final determination of the Joint Committee. The Board expressed its concern that the draft letter, which appears to be entirely consistent with the Joint Committee's decision, had not been sent out as a result of the opposition. Accordingly, the Board voted to send a memorandum from ED Russo to ED Hsu of the Joint Committee to request the scheduling of a special meeting in August to discuss this matter.
