Re: Conducting Hydrographic Surveys

Mr. Goll requests a determination whether professional engineers can conduct hydrographic surveys.

Mr. Goll will be advised that professional engineers shall not perform hydrographic surveys pursuant to the definition of land surveying which includes any service or work the adequate performance of which involves the application of special knowledge of the principles of mathematics, the related physical and applied sciences and the relevant requirements of law to the act of measuring and locating distances, directions, elevations, topography including natural and man-made topographical features in the air, on the surface of the earth, within underground workings, and on beds of bodies of water for the purpose of determining areas and volumes, and for the establishing of horizontal and vertical control as it relates to construction stake-out, for the monumentation of property boundaries and for platting and layout of lands and subdivisions thereof and for the preparation and perpetuation of maps, record plats, field notes, records and property descriptions in manual and computer coded form that represents these surveys. Further, the practice of land surveying includes the establishment and maintenance of the base mapping and related control for land information systems that are developed from the practice of land surveying.

Re: Revisions on a plan sheet by a new engineer.

Mr. Lescavage is requesting guidance on plan taken over by a new engineer.

The Board discussed this matter and concluded that a newly hired licensed professional may decide it is best to prepare a new plan for which that professional takes full responsibility. In that instance, the existing plan may be used as a guide, but the newly hired professional will be required to take full responsibility for the work and be expected to complete a new version of the design. However, there may be other laws outside the jurisdiction of this Board, such as copyright laws, which may be implicated and, therefore, the licensee should consult with an attorney for advice. Otherwise, a licensed professional may utilize an existing plan and either make revisions on that plan with a second title block, or prepare a separate document to be attached to the original plan showing those revisions with the preparer's title block. However, an existing title block

should not be removed by a licensee as it represents the original work product which was not altered by subsequent professionals.
