STATE BOARD OF PROFESSIONAL ENGINEERS AND LAND SURVEYORS

Minutes of September 8, 2005 Public Session

CALL TO ORDER

The meeting of the State Board of Professional Engineers and Land Surveyors was called to order by President James Valenti at 9:00 a.m. at 124 Halsey Street, 6th Floor Hudson Conference Room, Newark New Jersey. All parties were duly notified of the time, date and place, with all pertinent material being provided.

SUNSHINE LAW ANNOUNCEMENT

President Valenti read the statement required by Chapter 231, Laws of 1975 known as the Open Public Meetings Act, and announced that notice of this meeting was prepared in the office of the Board and mailed to the Secretary of State, the Star Ledger, the Camden Press, and the Courier Post.

REVIEW OF MINUTES

July 21, 2005

The Board, on a motion by VP Vernick, second by BM Raimondi, unanimously voted to approve the minutes of July 21, 2005 as amended.

COMMITTEE REPORTS

Legislation

BM Vernick informed the Board that A3983 was signed into law on August 18, 2005 by Acting Governor Codey and expressed concerns about the substantive changes to the home inspector licensing requirements.

Regulations

BM Kelly advised the Board that the corner marker waiver regulation was soon to be published.

NCEES Representative

BM Raimondi informed the Board that there were many items of discussion at the NCEES annual meeting in August. One discussion topic was requiring that applicants obtain an additional 30 credits of education in order to be eligible to sit for the principles and practices portion of the examinations or to receive a license through comity. In addition, a vote was also held by NCEES to continue to allow Board administrators to vote on behalf of their respective Boards.

Another area of discussion was the possibility of standardizing the continuing education requirements for all states. A task force was appointed to look into this matter. Also discussed was the waiving of the fundamentals of engineering examination for applicants with a Ph.D., providing the applicant has passed the principles and practices examination.

BM Raimondi was sworn in as President-Elect at this meeting. BP Valenti, former BM Patel, and Executive Director Russo were also in attendance.

The next NCEES annual meeting will be held in Anchorage, Alaska on September 13-16, 2006.

Education

BM Frantz reiterated his position in opposition to the "watering" down of school curriculum standards nation wide.

Finance

No report.

Examinations

Robert Welsh informed the Board that Rowan University has indicated that their Multipurpose Room may be utilized for the April 2006 examinations. A letter of intent was received from Rowan to utilize the University Ballroom for the October 2005 examinations.

Licensure Promotion Committee

BM Vernick and Robert Welsh informed the Board that the annual engineering Deans' meeting, a meeting for all Engineering Deans nationwide, will be held in Washington D.C.

The Board directed Mr. Welsh to provide them with a list of all the New Jersey engineering schools they have already visited. In addition, the Board requested the staff to schedule regular biennial meetings with the New Jersey engineering schools to promote licensure.

Website

BM Vernick informed the Board that all agendas and previously approved minutes have been posted to the Board's web site. In addition, both the Engineering in Training and Principles and Practice examinations have been converted to a writeable PDF format to expedite the application process. BM Raimondi suggested that Mr. Welsh contact NCEES to determine how other states handle their online application process.

Newsletter

Board President Valenti expressed concern that the Boards' newsletter took longer than expected. President Valenti reiterated his commitment to publishing two newsletters per year.

Joint Committee

Board President Valenti and BM Kelly will serve on the Joint Committee. VP Vernick will act as an

alternate.

Continuing Education Committee

BMs Angeline and Cleary are reviewing various continuing education course sponsor applications. These applications will be discussed at a future meeting.

REPORT OF THE EXECUTIVE DIRECTOR

General Report

The Board has requested that the staff verify that all board members have received their agenda packages prior to the meeting.

The Board reviewed a brochure indicating that TOEFL/TSE will be changing from a manual/computer examination to an Internet based format. The Board favored this change and indicated that it should be more efficient.

Joseph Grabowy advised that the Board's examination administrators, PCS, will require an extra \$10.00 per candidate to extend its scheduling deadline for those applicants taking either the engineering in training or the fundamentals of land surveying examinations. On a motion by BM Purcell, second by VP Vernick, the Board unanimously agreed to extend the application and document deadlines and to authorize PCS to increase their examination fees by \$10.00 for these examinations.

On a motion by BM Raimondi, second by BM Angeline, the Board voted to approve payment of the \$250.00 annual invoice from Colonial States Boards of Surveyor Registration representing membership in the organization for the calender year 2005.

Joseph Grabowy stated that a meeting with Larry Powers, Esquire regarding topographic surveys shall be scheduled in the near future.

On a motion by BM Kelly, second by BM Angeline, the Board canceled its September 15, 2005 meeting.

Incoming Correspondence

Sam Niemann/ The Wetlands Co., LLC RE: PE Certification for SPCC Plans (July 11, 2005)

Mr. Niemann wrote to the Board to determine if a professional engineer from another state can prepare and sign Spill Prevention Control Countermeasure (SPCC) reports.

The Board stated that this practice is prohibited and that he must be licensed as a professional engineer in New Jersey to prepare these types of reports.

Sonja Jennings RE: FE Examination (July 18, 2005)

Ms. Jennings wrote to the Board on behalf of the University of Maryland. She requested the Board's input or interest in allowing individuals to take the Fundamentals of Engineering examination through the United Arab Emirates under the supervision of a state board.

The Board expressed no interest in pursuing this invitation.

DJ McCutcheon, Jr., PLS

RE: Testing of measuring devices (August 9, 2005)

Mr. McCutcheon wrote to the Board requesting if a list is maintained by the Board of those individuals who have submitted the appropriate documentation for review by the State superintendent.

The Board directed the staff to refer Mr. McCutcheon, PLS, to the Office of Weights and Measures.

Mark F. Fruits/ Woolwich Township Zoning Office RE: Property lines (August 8, 2005)

Mr. Fruits wrote to the Board to determine where the starting point is to begin measurements of a survey.

After discussing this matter, the Board will advise Mr. Fruits to check his local ordinances as it does not establish these standards.

John A. Aiello, Esq./ Giordano, Halleran & Ciesla RE: Proposed Conversion of Professional Corporation into a Business Corporation (July 6, 2005)

Mr. Aiello requested the Board's suggestions on a proposed plan to convert a professional corporation into a general business corporation.

The Board shall inform Mr. Aiello that there are no statutes or regulations administered by the Board with regard to conversion of businesses. However, any general business corporation offering engineering or land surveying services in New Jersey must obtain a certificate of authorization pursuant to the Board's statutes and regulations.

Robert Waxman RE: Application #992959 (August 9, 2005)

Mr. Waxman wrote to the Board explaining his health condition and requested that it waive the three points that he lacked in passing the recent PE examination.

The Board denied Mr. Waxman's request and noted that he can take the PE examination again in October 2005 or April 2006.
