Minutes of September 20, 2007 Public Session

CALL TO ORDER

The meeting of the State Board of Professional Engineers and Land Surveyors was called to order by President Michael T. Angeline at 9:00 a.m. at 124 Halsey Street, 3rd Floor Union Conference Room, Newark, New Jersey. All parties were duly notified of the time, date and place, with all pertinent material being provided.

SUNSHINE LAW ANNOUNCEMENT

President Angeline read the statement required by Chapter 231, Laws of 1975 known as the Open Public Meetings Act, and announced that notice of this meeting was prepared in the office of the Board and mailed to the Secretary of State, the Newark Star Ledger, Trenton Times, the Camden Courier Post, Bergen Record, and the Atlantic City Press.

REPORT OF THE EXECUTIVE DIRECTOR

General Report

Executive Director Russo stated that staff member Ernest Gonzalez will be leaving the Board staff to pursue a career in law enforcement.

He also stated that Lawrence DeMarzo will be serving as the new Acting Director of the Division of Consumer Affairs.

ED Russo stated that the upcoming engineering and land surveying examinations are scheduled for October 26 and 27, 2007 at NJIT and the West Trenton Firehouse.

Previously, Board President Angeline reviewed the draft questions for the New Jersey state specific land surveying examination. On a motion by BM Jones, second by BM Cleary, the Board voted unanimously to approve the state specific land surveying examination. Patsy Steele and Linda Kellner, both with Professional Credentials Services, will be so advised.

Board President Angeline requested that the Examinations Committee be merged into the Collusion committee. He also requested that the Legislation and the Regulations Committees be merged.

BM Purcell spoke about a notice from the Department of Community Affairs regarding certification to perform specific inspections on Class 1 buildings which would now require professional engineers to take additional examinations. Since the regulation has been adopted, he requested that Lawrence DeMarzo be made aware that the Board did not have an opportunity to make any comments during the comment period.

In its review of engineering-in-training applications, the Board expressed concern about the deficient evaluations being submitted by CPEES. Specifically, CPEES is not utilizing the breakdown of the required number of credits for math and basic sciences (32), engineering sciences (32), and engineering design courses (16). On a motion by VP Valenti, second by BM Purcell, the Board requested that a letter be sent to Executive Director Adan of CPEES requesting that the above breakdown be utilized in its evaluation format. The names of candidates with deficient evaluations will also be included in said correspondence and CPEES shall be requested to prepare revised evaluations.

On a motion by VP Valenti, second by BM Purcell, the Board requested that the staff reach out to the other State Boards to determine who they utilize to prepare their foreign degree evaluations.
