# APPEARANCE BY LINDA KELLNER, PCS

The Board discussed the draft version fo the 15 minute New Jersey law examination which PCS had revised. After discussion, the Board advised Ms. Kellner of modifications that should be made to the examination. She will revise the examination accordingly and resubmit it to the Board for final review.

## REPORT OF THE EXECUTIVE DIRECTOR

ED Russo informed the Board that the Certificate Award Ceremony would be conducted tonight at the Holiday

Inn, Jamesburg, New Jersey.

The Board's statute and regulations booklet are in the process of being printed. BM Raimondi will assist with revising the sample title block page to be included as an appendix.

The latest Certificate of Authorization Report has been posted to the website. BM Faraldi suggested that the names of the responsible charge individuals be included as well, which the Board staff will investigate. In addition, it was suggested that the report state that the Board office can be contacted to obtain the names of the individuals in responsible charge.

Several Board members suggested that the continuing education form for land surveyors be added to the website and to the Board's statutes and regulations booklet.

Mr. Lucas, on behalf of the GSLSA, submitted a revised version of suggested amendments to N.J.A.C. 13:40-5.1(h).

The Board noted this correspondence for the record, which shall be further addressed when the regulations sunset.

William C. Longo, PE/ Lortech, Inc. RE: Question relating to a client's use of engineering plans (September 12, 2003)

Mr. Longo asked whether there are existing statutes dealing with a client's use of engineering plans when payment has not been made.

The Board shall refer Mr. Longo to N.J.A.C. 13:40-8.1 concerning the release of project records.

G.M. Toneatto, Ph.D., PE RE: Questions related to possible conflicts of interest (September 29, 2003)

Mr. Toneatto asked whether it was a conflict of interest to receive payment for expert testimony by a plaintiff which is contingent upon the favorable outcome of the case. In addition, he asked whether it would be a conflict to serve as the engineer of record to a planning and zoning board at a time when these entities are considering an application for development of a piece of land in which the engineer has an interest.

The Board refers Mr. Toneatto to N.J.A.C. 13:40-3.1 and also suggests that he consult with legal counsel for other applicable laws.

## APPLICATIONS FOR FULL BOARD REVIEW

Suli Wang - #951339

Ms. Wang requested a waiver of the requirement for a foreign degree evaluation. She stated that her country, China, will not provide original transcripts to other entities. The Board noted that she has received a masters degree from the University of Cincinnati.

The Board, on a motion by VP Kelly, second by BM Faraldi, unanimously voted to approve a waiver since the University of Cincinnati had accepted her undergraduate degree when she enrolled in the masters program.

Elliot Nir - #953609

Mr. Nir is a comity applicant. The Board stated that Mr. Nir's design experience is not acceptable since it was not performed under the supervision of a professional engineer. However, he may have sufficient engineering experience in fire protection. The Board requests that he provide updated experience forms.

Felix Wang - #950388

The Board stated that Mr. Wang received a BS from the University of Indiana in public affairs and a MS from Virginia Tech in environmental engineering. The Board previously requested, and received, a course work evaluation. After reviewing his undergraduate course work evaluation, the Board concluded that he lacks 4 design credits. However, Mr. Wang requests that the Board accept his masters thesis in satisfaction of the 4 design credits.

The Board, on a motion by BM Patel, second by VP Kelly, unanimously voted to accept Mr. Wang's masters thesis to fulfill the design credits.

#### CONTINUING EDUCATION

The Board discussed three course submissions from the New Jersey Society of Land Surveyors. The submissions included videos which were of excellent quality. The Board unanimously voted to approve these courses for a total of 8 hours.

### **COMMITTEE REPORTS**

#### **Examinations**

BM Raimondi informed the Board that, after verifying the information with NCEES, an individual who wishes to take multiple principle and practices examinations (in different examination disciplines) may do so, but cannot be issued multiple PE licenses if successful in passing the exams.

## **Special Committee Reports**

#### **Licensure Promotion Committee**

ED Russo, along with BM Raj and Robert Welsh, met with recently appointed Dean Thomas Blake of NJIT to discuss the subject of licensure promotion. BM Raj presented various viewpoints on issues related to this topic including raising the academic standards from a BS degree to a MS degree in engineering to qualify for licensure, and requiring the successful passing of the fundamentals of engineering examination as a prerequisite towards graduation.

A second meeting will be scheduled with Dean Blake to provide him with sufficient time to acclimate himself with his new position. For this meeting the Committee will request that other chairmen of the various engineering departments also be present.

The Board unanimously appointed BM Valenti to join the Licensure Promotion Committee.

## **Civil Service Committee**

BM Marshall stated that the N.J. Department of Transportation has compiled a listing of states which utilize civil service titles with designations utilizing the term "engineer."

This matter will continue to be monitored.
