**CALL TO ORDER**

The meeting of the State Board of Professional Engineers and Land Surveyors was called to order by President James Kelly at 9:00 a.m. at 124 Halsey Street, 3rd Floor Union Conference Room, Newark New Jersey. All parties were duly notified of the time, date and place, with all pertinent material being provided.

**REPORT OF THE EXECUTIVE DIRECTOR**

General Report

The Board reviewed and noted the licensure renewal statistics which indicated a 94.70% renewal rate.

ED Russo presented the Board with a statistical report reflecting a 80.09% renewal rate for certificate of authorization (C/A) renewals that were processed. The Board instructed the staff to forward a second notice to those C/A holders that were not renewed.

ED Russo stated that the Board's statute and regulations book has been returned to the Print Production Unit where it is currently being reviewed.

ED Russo informed the Board that the topographic survey notice will be published in the New Jersey Register on November 1, 2004.

A letter of invitation was mailed to ECEI requesting their appearance at a future Board meeting.

ED Russo reminded the Board that the examinations are scheduled for October 22 and 23, 2004 at the usual sites: Rowan University, the West Trenton Firehouse and NJIT.

ED Russo informed the Board that bill number S1930, which revises the procedures for suspension or revocation of licenses for overdue child support, has been referred by the Director's Office to the Board for its position. The Board determined after a review of the bill that it has no position on this matter.

ED Russo informed the Board that the NCEES Board President's Assembly is scheduled for February 10-12, 2005 in Kansas City, MO. BP Kelly and ED Russo plan to be in attendance.

ED Russo stated that all preparations are in place for the Certificate Award Ceremony at the Holiday Inn, Jamesburg, NJ scheduled for tonight.
