V. CORRESPONDENCE

A. Dr. Neil Wilson, Ph.D.

In his letter addressed to the Committee, Dr. Neil Wilson, Ph.D., Co-founder and Director of the New Jersey Institute for Training in Psychoanalysis (the Institute) in Teaneck New Jersey, provides a summary of the Institute. He also reports that as a charter member of NAAP the Institute respects the differences and similarities represented by the NAAP membership. While recognizing the different requirements of each school of thought, he points to the areas of commonality including course work, supervision and the long period of personal psychoanalysis. Dr. Wilson suggests that the Modern schools have been an integral part of analytic training and should be recognized and accepted for their internal standards and contribution to the field of psychoanalysis.

B. Marcia H. Rosen, Psy.D

Dr. Rosen wrote to thank the Committee for consideration of her letter dated June 16, 2005 and requests correction to the public minutes in which it was stated that her proposed two tier structure would "allow for a

distinction between those who hold professional (mental health) licenses..." and those who do not. She states her belief that the institutes are best able to decide whom to accept as a candidate. She further informs that several institutes in the tri-state area accept master's (or doctoral) level candidates without a degree in psychiatry, psychology or social work and points to a number of well-known analysts who did not hold degrees in a mental health profession.
