V. LEGISLATION/REGULATION

The Committee reviewed the comments submitted concerning the proposed regulations for telemedicine <u>N.J.A.C.</u> 13:42A-8 with the assistance of Charles Manning, Regulatory Analyst. The official comment period for the regulations ended August 16, 2019.

1. Telemedicine Adoption

- 2. Discussion of comments:
 - i. A commenter asks if <u>N.J.A.C.</u> 13:42A-8.5 permits psychoanalysts to provide services through telemedicine without a video component when clinically appropriate. *This inquiry is addressed under <u>N.J.A.C.</u> 13:42A-8.5 (e).*
 - ii. A commenter recommends amendment of the proposed regulations so that a certified psychoanalyst from another jurisdiction is not required to be certified in New Jersey if he or she is traveling through New Jersey. *Licensure/certification is required by statute, which cannot be waived.*
 - iii. A commenter recommends amendment of the proposed regulation in <u>N.J.A.C.</u> 13:42-8.5 and 8.8 so that written request or acknowledgement could be hand-delivered, mailed, or transmitted electronically because of the difficulty of obtaining acknowledgment when providing services through telemedicine. *This proposed amendment would further limit the certified psychoanalysts' options as allowed under the regulations.*

The Committee determined to table voting on the adoption of the regulations to its October 16, 2019 meeting.
